20	Section 33. A. All bills for raising revenue shall originate
21	in the House of Representatives. The Senate may propose amendments

- D. Any revenue bill originating in the House of Representatives may become law without being submitted to a vote of the people of the state if such bill receives the approval of three-fourths (3/4) sixty percent (60%) of the membership of the House of Representatives and three-fourths (3/4) sixty percent (60%) of the membership of the Senate and is submitted to the Governor for appropriate action. Any such revenue bill shall not be subject to the emergency measure provision authorized in Section 58 of this Article and shall not become effective and be in force until ninety days after it has been approved by the Legislature, and acted on by the Governor.

THE GIST OF THE PROPOSITION IS AS FOLLOWS:

1 This measure amends Section 33 of Article 5 of the Oklahoma 2 Constitution. The section sets out certain requirements for 3 bills for raising revenue for the support of state government. 4 Under current law, a revenue bill must be approved by three-5 fourths (3/4) of the membership of the House and the Senate. 6 This would change the approval vote to sixty percent (60%) of 7 the membership. 8 SHALL THE PROPOSAL BE APPROVED? 9 FOR THE PROPOSAL - YES 10 AGAINST THE PROPOSAL - NO 11 SECTION 3.
