The fundamental right of a each individual 19 citizen to keep and to bear arms in defense of his home, person, or 20 property, or, including handguns, rifles, shotguns, knives, 21 nonlethal defensive weapons and other arms in common use, as well as 22 ammunition and the components of arms and ammunition, for security, 23 self-defense, lawful hunting and recreation, in aid of the civil
