L7	SECTION 1. The Secretary of State shall refer to the people for
L8	their approval or rejection, as and in the manner provided by law,
L 9	the following proposed amendment to the Oklahoma Constitution by

21	Section 44. A. There is hereby created in the State Treasury
22	an endowment fund to be designated the "Revenue Replacement
23	Endowment Fund" to support the operation of state government. The
24	endowment fund principal shall consist of annual deposits of at

least five percent (5%) of the total collections of the gross production tax for each fiscal year levied on the production of oil and gas prior to any other apportionment of the gross production tax, income and investment return on endowment fund principal, and any other deposits and apportionments from other sources as may be provided by law. The Legislature may direct that any amount above five percent (5%) be deposited for a fiscal year. Funds deposited in the endowment fund shall be invested in the types of instruments in which the State Treasurer is authorized by law to invest.

B. There is hereby created in the State Treasury a revolving fund to be designated the "Revenue Replacement Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of deposits from the Revenue Replacement Endowment Fund and any other deposits as the Legislature may direct. Subject to the provisions of this subsection, all funds accruing to the credit of the revolving fund are hereby appropriated and may be budgeted and expended for fiscal years beginning July 1, 2017, in the same manner as the General Revenue Fund is expended; provided, no monies in the revolving fund may be used for debt service payments due on bonds or other financing instruments issued by the State of Oklahoma, counties, municipalities, authorities, commissions, political subdivisions or any other governmental entities.

14	percent (5%) of the gross production tax will fund the
15	endowment fund every year. The funds will be invested. Every
16	year no more than four percent (4%) of the funds in the
17	endowment fund will be taken out. This amount will go to a
18	fund that can be spent on state government like general
19	revenue. However, it cannot be spent on debt service on bonds.
