6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 26 of
10 Article V of the Constitution of the State of
11 Oklahoma; restricting ability of Legislature to
12 consider certain types of measures during even-
13 numbered years; authorizing consideration of certain
14 types of measures during even-numbered years based
15 upon certain vote; providing an effective date;
16 providing ballot title; and directing filing.

19 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
20 1st Session of the 56th OKLAHOMA LEGISLATURE:

21 SECTION 1. The Secretary of State shall refer to the people for
22 their approval or rejection, as and in the manner provided by law,
23 the following proposed amendment to Section 26 of Article V of the
24 Constitution of the State of Oklahoma to read as follows:

Section 26. A. The Legislature shall meet in regular session
at the seat of government at twelve o'clock noon on the first Monday
in February of each year and the regular session shall be finally
adjourned sine die not later than five o'clock p.m. on the last
Friday in May of each year.

1 B. The Legislature shall also meet in regular session at the
2 seat of government on the first Tuesday after the first Monday in
3 January of each ~~odd-numbered~~ odd-numbered year, beginning at twelve
4 o'clock noon for the purposes only of performing the duties as
5 required by Section 5 of Article VI of the Constitution and
6 organizing pursuant to the provisions of this Article and shall
7 recess not later than five o'clock p.m. of that same day until the
8 following first Monday in February of the same year, beginning at
9 twelve o'clock noon.

10 C. In an even-numbered year, the Legislature may not consider
11 any measure for the enactment of new law, the amendment or repeal of
12 existing law or referenda for modifications to the Oklahoma
13 Constitution or Statutes, except as necessary for the appropriation
14 or raising of revenue as authorized by the Oklahoma Constitution or
15 as provided in subsection D of this section.

16 D. Upon an affirmative vote of three-fourths (3/4) of the
17 members of each chamber of the Legislature, the types of measures
18 enumerated in subsection C of this section may be introduced and
19 considered during an even-numbered year.

20 E. The changes made to this section pursuant to this amendment
21 shall become effective January 1, 2019.

22 SECTION 2. The Ballot Title for the proposed Constitutional
23 amendment as set forth in SECTION 1 of this resolution shall be in
24 the following form:

THE GIST OF THE PROPOSITION IS AS FOLLOWS:

This measure amends the Oklahoma Constitution. It amends Section 26 of Article 5. It would prohibit the Legislature from considering legislation other than as necessary for the appropriation or raising of revenue in even-numbered years. The Legislature, by 3/4 vote of each chamber, could consider nonappropriation measures in even-numbered years. This amendment would become effective on January 1, 2019.
