- 5. Department of Public Safety, OAC 595:25-1-2, disapproving adding definition of ""Payment" means compensation for services rendered by a wrecker or towing company in the form of cash, credit card, debit card, Automated Clearinghouse Transfer (ACH), business checks, cashier's check, or money order." and OAC 595:25-5-7(b) and (c), disapproving proposed changes, except for the P.O.
