SENATE JOINT  
RESOLUTION 22

AS INTRODUCED

A Joint Resolution approving certain proposed permanent rules of Oklahoma state agencies; disapproving certain proposed permanent rules; and directing distribution.

WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma Statutes, the Legislature shall have a joint resolution prepared for consideration each session.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 1ST SESSION OF THE 59TH OKLAHOMA LEGISLATURE:

SECTION 1. All proposed permanent rules of Oklahoma state agencies filed on or before April 1, 2023, are hereby approved except for:

1. State Board of Medical Licensure and Supervision, OAC 435:15-1-1.1, 435:15-3-1, 435:15-3-13, 435:15-3-17, 435:15-3-19, 435:15-5-10, 435:15-5-11, 435:15-11-1, and 435:15-11-2;

2. Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing Commission, OAC 765:10-3-5;

3. Oklahoma Health Care Authority, OAC 317:30-3-35;

1 4. Oklahoma State Board of Examiners for Long-Term Care  
2 Administrators, OAC 490-10-1-2.1, disapproving new language in  
3 subparagraph (d);

4 5. Department of Public Safety, OAC 595:25-1-2, disapproving  
5 adding definition of ""Payment" means compensation for services  
6 rendered by a wrecker or towing company in the form of cash, credit  
7 card, debit card, Automated Clearinghouse Transfer (ACH), business  
8 checks, cashier's check, or money order." and OAC 595:25-5-7(b) and  
9 (c), disapproving proposed changes, except for the P.O. Box number;

10 6. State Board of Cosmetology and Barbering, OAC 175:10-1-3,  
11 disapproving the language "misdemeanors and", as included in  
12 subparagraph (b), OAC 175:10-1-3, disapproving the language ", or  
13 who has a criminal charge currently pending," as included in  
14 subparagraph (c), OAC 175:10-3-47, and OAC 175:10-9-55, disapproving  
15 the language "Only a licensed Cosmetology Instructor of licensed  
16 Facial/Esthetics Instructor may teach Eyelash Extension Specialist  
17 courses or classes.", as included in subparagraph (b); and

18 7. State Department of Health, OAC 310:643-5-1, 310:643-5-2,  
19 and 310:643-7-1.

20 SECTION 2. The Secretary of State is hereby directed to  
21 distribute copies of this resolution to the Governor and the editor  
22 of "The Oklahoma Register".
