7 A Joint Resolution disapproving permanent rules of  
8 the State Board of Education; sending rules back with  
9 certain instructions; and directing distribution.

13 subject matter standards adopted by the State Board of Education;

16 codified as OAC 210:15-3-90, 210:15-3-90.1, 210:15-3-90.2, 210:15-3-  
17 90.3, 210:15-3-91, 210:15-3-91.1, 210:15-3-92, 210:15-3-92.2,  
18 210:15-3-93, 210:15-3-93.3, 210:15-3-94, 210:15-3-94.4, 210:15-3-95,  
19 210:15-3-95.5, 210:15-3-96, 210:15-3-96.6, 210:15-3-97, 210:15-3-  
20 97.7, 210:15-3-98, 210:15-3-98.8, 210:15-3-99, 210:15-3-99.9,  
21 210:15-3-100, 210:15-3-100.1, 210:15-3-100.2, 210:15-3-100.3,

24 reflect the intent of the Oklahoma Legislature.

1 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF  
2 REPRESENTATIVES OF THE 1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

3 SECTION 1. The Legislature hereby disapproves the promulgated  
4 rules of the State Board of Education codified as OAC 210:15-3-90,  
5 210:15-3-90.1, 210:15-3-90.2, 210:15-3-90.3, 210:15-3-91, 210:15-3-  
6 91.1, 210:15-3-92, 210:15-3-92.2, 210:15-3-93, 210:15-3-93.3,  
7 210:15-3-94, 210:15-3-94.4, 210:15-3-95, 210:15-3-95.5, 210:15-3-96,  
8 210:15-3-96.6, 210:15-3-97, 210:15-3-97.7, 210:15-3-98, 210:15-3-  
9 98.8, 210:15-3-99, 210:15-3-99.9, 210:15-3-100, 210:15-3-100.1,  
10 210:15-3-100.2, 210:15-3-100.3, 210:15-3-101, 210:15-3-101.1,  
11 210:15-3-102, 210:15-3-102.2, 210:15-3-103, 210:15-3-103.3, 210:15-  
12 3-104, and 210:15-3-104.4, and sends them back to the State Board of  
13 Education with instructions to comply with Section 11-103.6a of  
14 Title 70 of the Oklahoma Statutes.

15 SECTION 2. The Secretary of State is directed to distribute  
16 copies of this resolution to the Governor and the State Board of  
17 Education.
