8 AS INTRODUCED

9 A Joint Resolution directing the Secretary of State  
10 to refer to the people for their approval or  
11 rejection a proposed amendment to Article X of the  
12 Oklahoma Constitution; exempting retirement benefits  
13 received by an individual from any component of the  
14 Armed Forces of the United States from taxable  
15 income; providing ballot title; directing filing; and  
16 ordering a special election.

17 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE  
18 2ND SESSION OF THE 58TH OKLAHOMA LEGISLATURE:

19 SECTION 1. The Secretary of State shall refer to the people for  
20 their approval or rejection, as and in the manner provided by law,  
21 the following proposed amendment to the Oklahoma Constitution by  
22 adding a new Section 12b to Article X thereof, to read as follows:

23 Section 12b. For tax year 2022 and subsequent tax years,  
24 retirement benefits received by an individual from any component of

1 the Armed Forces of the United States shall be exempt from state  
2 taxable income.

3 SECTION 2. The Ballot Title for the proposed Constitutional  
4 amendment as set forth in SECTION 1 of this resolution shall be in  
5 the following form:

8 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

9 This measure amends Article 10 of the Oklahoma Constitution by  
10 adding a new Section 12b. It exempts from the state income tax  
11 the retirement benefits of an individual from any component of  
12 the Armed Forces of the United States.

13 SHALL THE PROPOSAL BE APPROVED?

14 FOR THE PROPOSAL - YES \_\_\_\_\_

15 AGAINST THE PROPOSAL - NO \_\_\_\_\_

16 SECTION 3. The President Pro Tempore of the Senate shall,  
17 immediately after the passage of this resolution, prepare and file  
18 one copy thereof, including the Ballot Title set forth in SECTION 2  
19 hereof, with the Secretary of State and one copy with the Attorney  
20 General.

21 SECTION 4. A special election is hereby ordered to be held  
22 throughout the State of Oklahoma on June 28, 2022, at which time the  
23 proposed amendment to the Constitution of the State of Oklahoma, as  
24 set forth in Section 1 of this resolution shall be submitted to the

1 people of Oklahoma for their approval or rejection as and in the  
2 manner provided by law.
