WHEREAS, it is the solemn duty of the states to protect the liberty of our people, particularly for the generations to come, by proposing amendments to the Constitution of the United States through a convention of the states under Article V of the United States Constitution to place clear restraints on these and related abuses of power.

7 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 55TH OKLAHOMA LEGISLATURE: 8 9 THAT the Legislature of the State of Oklahoma hereby applies to 10 Congress, under the provisions of Article V of the Constitution of the United States, for the calling of a convention of the states 11 12 limited to proposing amendments to the United States Constitution 13 that impose fiscal restraints on the federal government, limit the 14 power and jurisdiction of the federal government, and limit the terms of office for its officials and for members of Congress; and 15

THAT this application shall be deemed an application for a 16 17 convention to address each or all of the subjects herein stated. 18 For the purposes of determining whether two-thirds of the states 19 have applied for a convention addressing any of the subjects stated 20 herein, this application is to be aggregated with the applications 21 of any other state legislatures for the single subjects of balancing 22 the federal budget, limiting the power and jurisdiction of the 23 federal government or limiting the terms of federal officials; and
