The fundamental right of $\frac{1}{2}$ each individual citizen 19 to keep and bear arms in defense of his home, or her person, or 20 property, or including handguns, rifles, shotguns, knives, nonlethal 21 defensive weapons, and other arms in common use, as well as 22 ammunition and the components of arms and ammunition, for self-23 defense, lawful hunting, and recreation, in aid of the civil power,
