6	<u>AS INTRODUCED</u>
7	A Joint Resolution directing the Secretary of State to refer to the people for their approval or
8	rejection a proposed amendment to the Oklahoma Constitution by adding a new Section 9 to Article
9	XIII; creating the School Modernization and Renew Teaching Commission until certain date; providing for
10	appointments; requiring submission of certain proposal to the Legislature by certain date; establishing requirements for certain proposal;
12	providing a process for consideration of the proposal by the Legislature; providing for consideration of
13	the proposal by the Governor; providing for expiration; providing ballot title; and directing
14	filing.
15	
16	BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
17	2ND SESSION OF THE 55TH OKLAHOMA LEGISLATURE:
18	SECTION 1. The Secretary of State shall refer to the people for
19	their approval or rejection, as and in the manner provided by law,
20	the following proposed amendment to the Oklahoma Constitution by
21	adding a new Section 9 to Article XIII to read as follows:
22	Section 9. A. There is hereby created until January 31, 2021,
23	the School Modernization and Renew Teaching Commission.
24	

- B. The Commission shall be comprised of fifteen (15) members to be appointed as follows:
 - 1. Five members, appointed by the Governor;

- 2. Five members, appointed by the President Pro Tempore of the Senate; and
- 3. Five members, appointed by the Speaker of the House of Representatives.
- C. By December 31, 2020, the Commission shall present to the Governor and both branches of the Legislature proposed legislation that would implement a school district map of Oklahoma that consists of no more than two hundred (200) school districts. To be valid, the proposed legislation shall meet the following standard: The percentage decline in the number of school districts in the state's largest county, either wholly or partially; the percentage decline in the number of school districts in the state's second largest county, either wholly or partially; and the cumulative percentage decline in the number of school districts in the state's remaining seventy-five (75) counties, either wholly or partially, must be within ten (10) percentage points of each other. The Commission shall be prohibited from recommending the closure of any school sites.
- D. The proposed legislation shall not be subject to amendment by either branch of the Legislature.

E. The Lieutenant Governor shall conduct a drawing to determine which branch of the Legislature considers the proposed legislation first.

- F. Regardless of any other statutory or constitutional provisions, the proposed legislation shall receive an up-or-down vote by the first branch during the first session of the 58th Oklahoma Legislature. A majority vote shall be required for passage of the proposed legislation.
- 1. If the proposed legislation passes the first branch, the proposed legislation shall receive an up-or-down vote in the opposite branch during the first session of the 58th Oklahoma Legislature.
- 2. If the proposed legislation does not pass the first branch, the proposed legislation shall not be considered in the opposite branch during the first session of the 58th Oklahoma Legislature.
- G. If the proposed legislation is approved by both branches of the Legislature during the first session of the 58th Oklahoma

 Legislature, it shall be presented to the Governor, who may sign it or veto it during the first session of the 58th Oklahoma

 Legislature, or within ten (10) days following passage of the proposed legislation. Failure of the Governor to take any action shall constitute approval.
- H. The provisions of this section shall expire on December 31, 24 2021.

6	THE GIST OF THE PROPOSITION IS AS FOLLOWS:
7	This measure adds a new section of law to the State
8	Constitution. It adds Section 9 to Article 13. It creates a
9	commission to propose a new school district map that would
10	contain only 200 school districts. It provides for appointments
11	to the commission. It requires the commission to submit its
12	proposal to the Legislature by a certain date. It establishes
13	requirements that the proposal must meet. It provides a process
14	for how the proposal is to be considered by both branches of the
15	Legislature. It provides for consideration of the proposal by
16	the Governor. It states that this section of the Constitution
17	shall expire on a certain date.
