15	SECTION 1. The Secretary of State shall refer to the people for
16	their approval or rejection, as and in the manner provided by law,
17	the following proposed amendment to Section 23 of Article V of the
18	Oklahoma Constitution to read as follows:
19	Section 23. No <u>A. Except as provided for in subsection B of</u>
20	this section, no member of the Legislature shall, during the term
21	for which he or she was elected, be appointed or elected to any
22	office or commission in the State, which shall have been created, or
23	the emoluments of which shall have been increased, during his <u>or her</u>
24 27	term of office, nor shall any member receive any appointment from

1 the Governor, the Governor and Senate, or from the Legislature, 2 during the term for which he or she shall have been elected, nor 3 shall any member, during the term for which he or she shall have 4 been elected, or within two years thereafter, be interested, 5 directly or indirectly, in any contract with the State, or any 6 county or other subdivision thereof, authorized by law passed during 7 the term for which he or she shall have been elected. 8 B. The provisions of this section shall not operate to prohibit 9 a member of the Legislature from being employed by a public school 10 in this state after completing the term to which he or she was 11 elected. 12 SECTION 2. The Ballot Title for the proposed Constitutional 13 amendment as set forth in SECTION 1 of this resolution shall be in 14 the following form: 15 BALLOT TITLE 16 Legislative Referendum No. State Question No. 17 THE GIST OF THE PROPOSITION IS AS FOLLOWS: 18 This measure amends Section 23 of Article 5 of the Oklahoma 19 Constitution.
