6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 23 of
10 Article V of the Oklahoma Constitution; allowing a
11 member of the Legislature to be employed as a
12 certified teacher with a public school district in
13 this state after completion of certain term;
14 providing ballot title; and directing filing.

15 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
16 1ST SESSION OF THE 57TH OKLAHOMA LEGISLATURE:

17 SECTION 1. The Secretary of State shall refer to the people for
18 their approval or rejection, as and in the manner provided by law,
19 the following proposed amendment to Section 23 of Article V of the
20 Oklahoma Constitution to read as follows:

21 Section 23. ~~No~~ A. Except as provided for in subsection B of
22 this section, no member of the Legislature shall, during the term
23 for which he or she was elected, be appointed or elected to any
24 office or commission in the State, which shall have been created, or
the emoluments of which shall have been increased, during his or her
term of office, nor shall any member receive any appointment from

1 the Governor, the Governor and Senate, or from the Legislature,
2 during the term for which he or she shall have been elected, nor
3 shall any member, during the term for which he or she shall have
4 been elected, or within two years thereafter, be interested,
5 directly or indirectly, in any contract with the State, or any
6 county or other subdivision thereof, authorized by law passed during
7 the term for which he or she shall have been elected.

8 B. The provisions of this section shall not operate to prohibit
9 a member of the Legislature from being employed as a certified
10 teacher by a public school district in this state after completing
11 the term to which he or she was elected.

12 SECTION 2. The Ballot Title for the proposed Constitutional
13 amendment as set forth in SECTION 1 of this resolution shall be in
14 the following form:

16 Legislative Referendum No. _____ State Question No. _____

17 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

18 This measure amends Section 23 of Article 5 of the Oklahoma
19 Constitution. It allows a member of the Legislature to be
20 employed as a certified teacher with a public school district in
21 this state after he or she completes his or her term in office.
