The Secretary of State shall refer to the people for 16 their approval or rejection, as and in the manner provided by law, 17 the following proposed amendment to Section 23 of Article V of the 18 Oklahoma Constitution to read as follows: 19

Section 23. No A. Except as provided for in subsection B of this section, no member of the Legislature shall, during the term for which he or she was elected, be appointed or elected to any office or commission in the State, which shall have been created, or the emoluments of which shall have been increased, during his or her term of office, nor shall any member receive any appointment from

1	the Governor, the Governor and Senate, or from the Legislature,
2	during the term for which he <u>or she</u> shall have been elected, nor
3	shall any member, during the term for which he or she shall have
4	been elected, or within two years thereafter, be interested,

6	county or other subdivision thereof, authorized by law passed during
7	the term for which he <u>or she</u> shall have been elected.
8	B. The provisions of this section shall not operate to prohibit
9	a member of the Legislature from being employed as a certified
10	teacher by a public school district in this state after completing
11	the term to which he or she was elected.
