SUMMARY

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 442.385 is amended to read:

- 7 (1) "Health care" means items, services and supplies intended to improve or maintain human

8 function or treat or ameliorate pain, disease, condition or injury, including but not limited to the

[(6)] (5) "Net cost of private health insurance" means the difference between health insurance 1 2 premiums received by a payer and the claims for the cost of health care paid by the payer under a policy or certificate of health insurance. 3 [(7)] (6) "Payer" means: 4 (a) An insurer offering a policy or certificate of health insurance or a health benefit plan as 5 defined in ORS 743B.005; 6 (b) A publicly funded health care program, including but not limited to Medicaid, Medicare and 7 the State Children's Health Insurance Program; 8 9 (c) A third party administrator; and 10 (d) Any other public or private entity, other than an individual, that pays or reimburses the cost for the provision of health care. 11 12[(8)] (7) "Provider" means an individual, organization or business entity that provides health 13 care. ORS 442.386 is amended to read: 442.386. (1) The Legislative Assembly intends to establish a health care cost growth 2627[benchmark,] target, for all providers and payers, to: (a) Support accountability for the total cost of health care across all providers and payers, both 28public and private; 2930 (b) Build on the state's existing efforts around health care payment reform and containment of 31 health care costs; and (c) Ensure the long-term affordability and financial sustainability of the health care system in 32this state. 33 34 (2) The Health Care Cost Growth [Benchmark] Target program is established. The program shall be administered by the Oregon Health Authority in collaboration with the Department of Consumer 35 and Business Services, subject to the oversight of the Oregon Health Policy Board. The program 36 37 shall establish a health care cost growth [benchmark] target for increases in total health expen-38 ditures and shall review and modify the [benchmark] target on a periodic basis. (f) Recommend approaches for measuring the quality of care that account for patient health 6 7 status.

(g) Seek to align the approaches for measuring the quality of care under paragraph (f) of this 8 9 subsection with the outcome and quality measures adopted by the Health Plan Quality Metrics 10 Committee.

(h) Identify opportunities for lowering costs, improving the quality of care and improving the 11 12 efficiency of the health care system by using innovative payment models for all payers, including 13 payment models that do not use a per-claim basis for payments.

(i) Recommend a system for identifying: 14

15 (A) Unjustified variations in prices or in health care cost growth; and

(B) The factors that contribute to the unjustified variations. 16

17 (j) Identify providers and payers that are required to report.

18 (k) Recommend accountability and enforcement processes, which may be phased in over time, including: 19

(A) Measures to ensure compliance with reporting requirements;

(B) Procedures for imposing a performance improvement action plan or other escalating 2122enforcement actions when a provider or payer fails to remain at or below the [benchmark] target; 23and

(C) Measures to enforce compliance with the health care cost growth [benchmark] target in 24programs administered by the Oregon Health Authority and the Department of Consumer and Busi-25ness Services, including but not limited to: 26

27(i) The medical assistance program;

(ii) Medical, dental, vision and other health care benefit plans offered by the Public Employees' 28Benefit Board; 29

30 (iii) Medical, dental, vision and other health care benefit plans offered by the Oregon Educators 31 Benefit Board;

(iv) Insurance offered through the health insurance exchange; and 32

(v) The review of health insurance premium rates by the department. 33

34 (L) Make recommendations regarding the reporting of data collected by the Health Care Cost Growth [Benchmark] Target program, including recommendations for: 35

(A) Publication of an annual health care cost trends report and analyses on the statewide health 36 37 care cost growth [benchmark] target, total health expenditures and spending by each type of health

38 care entity;

(B) Elements to be included in the annual health care cost trends report, such as: 39

(i) Services provided, sorted by provider organization; 40

(ii) Services paid for, sorted by the type of payer; 41

(iii) Variations in cost trends, sorted by category of service; and 42

(iv) Affordability of health care, based on prices, insurance premiums and types of payment; 43

(C) Frequency and format of public hearings conducted in accordance with [section 2 (6)(a) of 44 this 2019 Act] ORS 442.386 (6)(a); 45

(D) Publication of recommendations for policies and strategies for achieving the health care cost 1 2 growth [benchmark] target; 3 (E) Publication of performance improvement action plans and other enforcement actions; and (F) Reporting to the Legislative Assembly. 4 (m) Establish an implementation timeline and the phases of implementation that may include the 5 establishment of the initial health care cost growth [benchmark] target under paragraph (c) of this 6 subsection in 2021, with reporting, enforcement and penalties beginning in 2022. 7 SECTION 5.
