House Bill 2179

Sponsored by Representative WILDE (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Modifies zero-emission and electric vehicle rebate programs to allow rebate for purchase or lease of electric farm tractor or repowering of farm tractor.

Applies to electric farm tractors purchased or leased and farm tractor repower costs incurred on or after January 1, 2022. Takes effect on 91st day following adjournment sine die.
