SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows professional licensing board to issue temporary authorization to spouse of member of Armed Forces of United States stationed in Oregon and who holds out-of-state authorization to provide occupational or professional service.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to professional authorizations; and prescribing an effective date.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) As used in this section:**

5 (a) **“Occupational or professional service” means a service:**

6 (A) **For which an individual must possess a license, certificate or other form of authori-**
7 **zation to provide under the laws of this state; and**

8 (B) **Over which a professional licensing board has regulatory oversight.**

9 (b) **“Professional licensing board” means a state agency or board that licenses, certifies**
10 **or otherwise authorizes individuals to provide an occupational or professional service.**

11 (2) **A professional licensing board may issue a temporary authorization to provide the**
12 **occupational or professional service regulated by the professional licensing board to a person**
13 **who:**

14 (a) **Is the spouse of a member of the Armed Forces of the United States who is stationed**
15 **in this state;**

16 (b) **Holds a current authorization to provide the occupational or professional service is-**
17 **sued by another state; and**

18 (c) **Provides to the professional licensing board, in a manner determined by the profes-**
19 **sional licensing board, sufficient proof that the person is in good standing with the issuing**
20 **out-of-state professional licensing board.**

21 (3) **A temporary authorization issued under this section is valid for two years from the**
22 **date of issuance and is not renewable. A person may not continue to provide the occupational**
23 **or professional service unless the person is issued a full authorization under the laws of this**
24 **state to provide the occupational or professional service.**

25 (4) **A professional licensing board shall revoke an authorization issued under this section**
26 **when:**

27 (a) **The spouse of the person to whom the authorization was issued completes the**
28 **spouse's term of service in this state; or**

1 **(b) The person’s authorization issued by another state expires.**

2 **(5) A professional licensing board may adopt rules to carry out the provisions of this**
3 **section.**

4 **SECTION 2.** **(1) Section 1 of this 2019 Act becomes operative on January 1, 2020.**

5 **(2) A professional licensing board may take any action before the operative date specified**
6 **in subsection (1) of this section that is necessary to enable the board to exercise, on and**
7 **after the operative date specified in subsection (1) of this section, all of the duties, functions**
8 **and powers conferred on the board by section 1 of this 2019 Act.**

9 **SECTION 3.** **This 2019 Act takes effect on the 91st day after the date on which the 2019**
10 **regular session of the Eightieth Legislative Assembly adjourns sine die.**
