# House Bill 3074

Sponsored by Representative MARSH

# SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Includes insurance in definition of real estate, goods and services that are subject to penalties for unlawful trade practices.

Permits person to obtain, and court to award, appropriate equitable relief in addition to monetary damages under Unlawful Trade Practices Act.

Requires Director of Department of Consumer and Business Services to request action before prosecuting attorney may take action under Unlawful Trade Practices Act against act or practice related to insurance.

Declares emergency, effective on passage.

6 **SECTION 1.** ORS 646.605 is amended to read:

7 646.605. As used in ORS 336.184 and 646.605 to 646.652:

8 (1) "Appropriate court" means the circuit court of a county:

9 (a) [Where one or more of the defendants reside] In which a defendant resides;

10 (b) [Where one or more of the defendants maintain] In which a defendant maintains a principal 11 place of business;

12 (c) [Where one or more of the defendants are] In which a defendant is alleged to have committed 13 an act prohibited by ORS 336.184 and 646.605 to 646.652; or

14 (d) With [*the*] **a** defendant's consent, [*where*] **in which** the prosecuting attorney maintains an 15 office.

a trust, a partnership, an incorporated or unincorporated [associations] association and any other
legal entity except [bodies or officers] a body or officer that is acting under the statutory authority
of this state or the United States.

(5) "Prosecuting attorney" means the Attorney General or the district attorney of any county
in which a violation of ORS 336.184 and 646.605 to 646.652 is alleged to have occurred.

(6)(a) "Real estate, goods or services" means [those] real estate, goods or services, including 1 2 insurance, that are or may be obtained primarily for personal, family or household purposes[,] that, with respect to insurance, are or may be obtained for purposes other than personal, family 3 or household purposes, or that are or may be obtained for any purposes as a result of a telephone 4 solicitation, and includes loans and extensions of credit[,] and franchises, distributorships and other 5 similar business opportunities[, but does not include insurance]. 6

(b) Notwithstanding paragraph (a) of this subsection[:],

[(A) "Real estate" does not cover conduct covered by ORS chapter 90.]

9 [(B)] "loans and extensions of credit" does not include transactions [involving] that involve a pawnbroker, as defined in ORS 726.010, that [is required to] must be licensed under ORS chapter 10 726. 11

12(7) "Telephone solicitation" means a solicitation [where] in which a person, in the course of the 13 person's business, vocation or occupation, uses a telephone or an automatic dialing-announcing device to initiate telephonic contact with a potential customer and the person is not one of the fol-14 15 lowing:

16(a) [A person who is] A broker-dealer or salesperson licensed under ORS 59.175, or a mortgage banker or mortgage broker licensed under ORS 86A.106, [when] if the solicitation is for a security 17 18 qualified for sale [pursuant to] under ORS 59.055.

19 (b) A real estate licensee or a person who is otherwise authorized to engage in professional real estate activity [pursuant to] under ORS chapter 696, [when] if the solicitation involves professional 20real estate activity. 21

22(c) A person licensed or exempt from licensure as a builder [pursuant to] under ORS chapter 23701, [when] if the solicitation involves [the construction, alteration, repair, improvement or demolition of] constructing, altering, repairing, improving or demolishing a structure. 24

25[(d) A person licensed or otherwise authorized to sell insurance as an insurance producer pursuantto ORS chapter 744, when the solicitation involves insurance.] 26

27[(e)] (d) A person [soliciting] that solicits the sale of a newspaper of general circulation, a magazine or membership in a book or record club who complies with ORS 646.611, [when] if the 2829solicitation involves newspapers, magazines or membership in a book or record club.

30 [(f)] (e) A person [soliciting] that solicits, without the intent to complete, and who does not 31 complete [the] **a** sales presentation during the telephone solicitation and [who] **that** only completes 32the sales presentation at a later face-to-face meeting between the [solicitor] person and the pro-33 spective purchaser.

[(k)] (j) A person who sells farm products, as defined [by] in ORS 576.006, if the [solicitation
neither intends to nor actually results] person does not intend to complete a sale and the solicitation does not actually result in a sale that costs the purchaser in excess of \$100.

(8) "Trade" and "commerce" mean advertising, offering or distributing, whether by sale, rental

or indirectly [affecting] affects the people of this state.

(9) "Unconscionable tactics" means actions that include, but are not limited to, actions [by]
 in which a person:

(a) Knowingly takes advantage of a customer's physical infirmity, ignorance, illiteracy or ina bility to understand the language of the agreement;

(b) Knowingly permits a customer to enter into a transaction from which the customer will
 derive no material benefit;

(c) Permits a customer to enter into a transaction [with knowledge that there is no reasonable
probability of payment of the attendant financial obligation in full by the customer when due] knowing
that the customer does not have a reasonable probability of paying the attendant financial

25 obligations in full when due; or

(d) Knowingly takes advantage of a customer who is a disabled veteran, a disabled
 servicemember or a servicemember in active service, or the spouse of a disabled veteran, disabled
 servicemember or servicemember in active service. For purposes of this paragraph:

(A) "Disabled veteran" has the meaning given that term in ORS 408.225.

by false or misleading representations of fact.

(i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
services as advertised, or with intent not to supply reasonably expectable public demand, unless the
advertisement discloses a limitation of quantity.

(j) Makes false or misleading representations of fact concerning the reasons for, existence of,
 or amounts of price reductions.

(k) Makes false or misleading representations concerning credit availability or the nature of the
 transaction or obligation incurred.

The court or the jury may award punitive damages and the court may provide any equitable relief the court considers necessary or proper.

20	with the seller, unless the relationship is remote and is not a factor in the transaction;
21	(b) The lender gives a commission, rebate or credit in any form to a seller who refers the
22	borrower to the lender, other than paying the proceeds of the loan jointly to the seller and
23	the borrower;
24	(c) The lender is related to the seller by blood or marriage;
25	(d) The seller directly and materially assists the borrower in obtaining the loan;
26	(e) The seller prepares documents that are given to the lender and used in connection
27	with the loan; or
28	(f) The lender supplies documents to the seller that the borrower uses in obtaining the
29	loan.
30	SECTION 7. Section 8 of this 2021 Act is added to and made a part of ORS 646.605 to
31	646.652.
32	SECTION 8. A prosecuting attorney may not take action under ORS 646.618 or 646.632
33	with respect to an act or practice declared to be unlawful under ORS 646.607 or 646.608 if the
34	act or practice is related to insurance and otherwise subject to the Insurance Code unless
35	the Director of the Department of Consumer and Business Services first requests the pros-
36	ecuting attorney to take action. The director may elect to be named as a party in any action
37	or proceeding that the prosecuting attorney commences at the director's request.
38	SECTION 9. Section 8 of this 2021 Act and the amendments to ORS 646.605, 646.608,
39	646.612, 646.636, 646.638 and 646.648 by sections 1 to 6 of this 2021 Act apply to proceedings
40	that begin on or after the effective date of this 2021 Act.
41	SECTION 10. This 2021 Act being necessary for the immediate preservation of the public
42	peace, health and safety, an emergency is declared to exist, and this 2021 Act takes effect
43	on its passage.
