

House Bill 3100

Sponsored by Representative HERNANDEZ

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Task Force on Audit Equity Analysis. Directs task force to study and recommend legislation to require Secretary of State to include certain information related to equity issues in performance and program audits.

Sunsets December 31, 2020.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to audits; and prescribing an effective date.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on Audit Equity Analysis is established.**

5 **(2) The task force consists of nine members appointed as follows:**

6 **(a) The President of the Senate shall appoint one member from among members of the**
7 **Senate.**

8 **(b) The Speaker of the House of Representatives shall appoint one member from among**
9 **members of the House of Representatives.**

10 **(c) The Governor shall appoint members with expertise or experience in equity issues as**
11 **follows:**

12 **(A) One member representing the Governor's office;**

13 **(B) Two members representing state agencies; and**

14 **(C) One member representing Metro, as defined in ORS 197.015.**

15 **(d) The Secretary of State shall appoint three members representing the Secretary of**
16 **State's office.**

17 **(3) The task force shall study and prepare recommendations regarding policies that would**
18 **require the Division of Audits of the Secretary of State to include in its performance audits**
19 **and program audits:**

20 **(a) A contextualized description of equity issues that affect the mission of the audited**
21 **entity, including past or present structural inequities;**

22 **(b) Proposals to redress the effects of past inequities and end present current inequities;**
23 **and**

24 **(c) Analysis of the audited entity's policies relating to equity issues and a comparison of**
25 **those policies to current best practices.**

26 **(4) The task force may, in carrying out its duties, consult with any experts, advisors or**
27 **other persons as the task force deems necessary or advisable.**

28 **(5) A majority of the members of the task force constitutes a quorum for the transaction**
29 **of business.**

30 **(6) Official action by the task force requires the approval of a majority of the members**

2 (7) The task force shall elect one of its members to serve as chairperson.

3 (8) If there is a vacancy for any cause, the appointing authority shall make an appoint-
4 ment to become immediately effective.

5 (9) The task force shall meet at times and places specified by the call of the chairperson
6 or of a majority of the members of the task force.

7 (10) The task force may adopt rules necessary for the operation of the task force.

8 (11) The task force shall submit a report in the manner provided by ORS 192.245, and
9 may include recommendations for legislation, to the joint legislative committee established
10 under ORS 171.580 no later than September 15, 2020.

11 (12) The Secretary of State shall provide staff support to the task force.

12 (13) Members of the task force who are not members of the Legislative Assembly are not
13 entitled to compensation or reimbursement for expenses and serve as volunteers on the task
14 force.

15 (14) All agencies of state government, as defined in ORS 174.111, are directed to assist
16 the task force in the performance of the task force's duties and, to the extent permitted by
17 laws relating to confidentiality, to furnish information and advice the members of the task
18 force consider necessary to perform their duties.

19 (15) As used in this section:

20 (a) "Equity issues" means issues pertaining to justice and fairness in social policy toward
21 historically disadvantaged groups.

22 (b) "Performance audit" has the meaning given that term in ORS 297.070.

23 (c) "Program audit" has the meaning given that term in ORS 297.070.

24 **SECTION 2.** Section 1 of this 2019 Act is repealed on December 31, 2020.

25 **SECTION 3.** This 2019 Act takes effect on the 91st day after the date on which the 2019
26 regular session of the Eightieth Legislative Assembly adjourns sine die.
