# House Bill 3161

Sponsored by Representative EVANS

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires directors and senior executives of businesses that receive \$10 million or more in public moneys over five year period to file statement of economic interest.

## A BILL FOR AN ACT

2 Relating to disclosure of information from executives of businesses receiving public moneys; creating

3 new provisions; and amending ORS 244.020, 244.050, 244.060 and 244.090.

## 4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 244.020 is amended to read:

6 244.020. As used in this chapter, unless the context requires otherwise:

7 (1) "Actual conflict of interest" means any action or any decision or recommendation by a per-8 son acting in a capacity as a public official, the effect of which would be to the private pecuniary 9 benefit or detriment of the person or the person's relative or any business with which the person 10 or a relative of the person is associated unless the pecuniary benefit or detriment arises out of cir-11 cumstances described in subsection (13) of this section.

(2) "Business" means any corporation, partnership, proprietorship, firm, enterprise, franchise, association, organization, self-employed individual and any other legal entity operated for economic gain but excluding any income-producing not-for-profit corporation that is tax exempt under section 501(c) of the Internal Revenue Code with which a public official or a relative of the public official is associated only as a member or board director or in a nonremunerative capacity.

(3) "Business with which the person is associated" means:

(a) Any private business or closely held corporation of which the person or the person's relative
is a director, officer, owner or employee, or agent or any private business or closely held corporation in which the person or the person's relative owns or has owned stock, another form of equity
interest, stock options or debt instruments worth \$1,000 or more at any point in the preceding calendar year;

(b) Any publicly held corporation in which the person or the person's relative owns or has
owned \$100,000 or more in stock or another form of equity interest, stock options or debt instruments at any point in the preceding calendar year;

(c) Any publicly held corporation of which the person or the person's relative is a director orofficer; or

(d) For public officials required to file a statement of economic interest under ORS 244.050, any
business listed as a source of income as required under ORS 244.060 (3).

30 (4) "Candidate" means an individual for whom a declaration of candidacy, nominating petition 31 or certificate of nomination to public office has been filed or whose name is printed on a ballot or

1 is expected to be or has been presented, with the individual's consent, for nomination or election to 2 public office.

3 (5) "Development commission" means any entity that has the authority to purchase, develop, 4 improve or lease land or the authority to operate or direct the use of land. This authority must be 5 more than ministerial.

6 (6) "First Partner" means the spouse or domestic partner of the Governor, or an individual who 7 primarily has a personal relationship with the Governor as determined by the Oregon Government 8 Ethics Commission by rule. "First Partner" encompasses any alternative title that the Governor may 9 publicly substitute for "First Partner," including, but not limited to, "First Lady," "First Husband" 10 or "First Spouse."

(7)(a) "Gift" means something of economic value given to a public official, a candidate or a rel ative or member of the household of the public official or candidate:

(A) Without valuable consideration of equivalent value, including the full or partial forgiveness of indebtedness, which is not extended to others who are not public officials or candidates or the relatives or members of the household of public officials or candidates on the same terms and conditions; or

(B) For valuable consideration less than that required from others who are not public officialsor candidates.

19 (b) "Gift" does not mean:

20 (A) Contributions as defined in ORS 260.005.

21 (B) Gifts from relatives or members of the household of the public official or candidate.

(C) An unsolicited token or award of appreciation in the form of a plaque, trophy, desk item,
wall memento or similar item, with a resale value reasonably expected to be less than \$25.

(D) Informational or program material, publications or subscriptions related to the recipient's
 performance of official duties.

(E) Admission provided to or the cost of food or beverage consumed by a public official, a relative of the public official accompanying the public official, a member of the household of the public official accompanying the public official or a staff member of the public official accompanying the public official, at a reception, meal or meeting held by an organization when the public official represents state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117.

(F) Reasonable expenses paid by any unit of the federal government, a state or local government, 32a Native American tribe that is recognized by federal law or formally acknowledged by a state, a 33 34 membership organization to which a public body as defined in ORS 174.109 pays membership dues or a not-for-profit corporation that is tax exempt under section 501(c)(3) of the Internal Revenue 35Code, for attendance at a convention, fact-finding mission or trip, conference or other meeting if the 36 37 public official is scheduled to deliver a speech, make a presentation, participate on a panel or rep-38 resent state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117. 39

40 (G) Contributions made to a legal expense trust fund established under ORS 244.209 for the 41 benefit of the public official.

(H) Reasonable food, travel or lodging expenses provided to a public official, a relative of the
public official accompanying the public official, a member of the household of the public official accompanying the public official or a staff member of the public official accompanying the public offitial, when the public official is representing state government as defined in ORS 174.111, a local

1 government as defined in ORS 174.116 or a special government body as defined in ORS 174.117:

2 (i) On an officially sanctioned trade-promotion or fact-finding mission; or

3 (ii) In officially designated negotiations, or economic development activities, where receipt of the
4 expenses is approved in advance.

5 (I) Food or

(I) Food or beverage consumed by a public official acting in an official capacity:

(i) In association with the review, approval, execution of documents or closing of a borrowing,
investment or other financial transaction, including any business agreement between state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117 and a private entity or public body as defined in ORS 174.109;
(ii) While engaged in due diligence research or presentations by the office of the State Treasurer

11 related to an existing or proposed investment or borrowing; or

(iii) While engaged in a meeting of an advisory, governance or policy-making body of a corpo ration, partnership or other entity in which the office of the State Treasurer has invested moneys.

(J) Waiver or discount of registration expenses or materials provided to a public official or
 candidate at a continuing education event that the public official or candidate may attend to satisfy
 a professional licensing requirement.

(K) Expenses provided by one public official to another public official for travel inside this state
to or from an event that bears a relationship to the receiving public official's office and at which
the official participates in an official capacity.

20 (L) Food or beverage consumed by a public official or candidate at a reception where the food 21 or beverage is provided as an incidental part of the reception and no cost is placed on the food or 22 beverage.

(M) Entertainment provided to a public official or candidate or a relative or member of the
 household of the public official or candidate that is incidental to the main purpose of another event.

(N) Entertainment provided to a public official or a relative or member of the household of the public official where the public official is acting in an official capacity while representing state government as defined in ORS 174.111, a local government as defined in ORS 174.116 or a special government body as defined in ORS 174.117 for a ceremonial purpose.

(O) Anything of economic value offered to or solicited or received by a public official or candi date, or a relative or member of the household of the public official or candidate:

(i) As part of the usual and customary practice of the person's private business, or the person's
 employment or position as a volunteer with a private business, corporation, partnership,
 proprietorship, firm, enterprise, franchise, association, organization, not-for-profit corporation or
 other legal entity operated for economic value; and

(ii) That bears no relationship to the public official's or candidate's holding of, or candidacy for,
the official position or public office.

(P) Reasonable expenses paid to a public school employee for accompanying students on an ed-ucational trip.

(8) "Honorarium" means a payment or something of economic value given to a public official in
exchange for services upon which custom or propriety prevents the setting of a price. Services include, but are not limited to, speeches or other services rendered in connection with an event.

42 (9) "Income" means income of any nature derived from any source, including, but not limited to,
43 any salary, wage, advance, payment, dividend, interest, rent, honorarium, return of capital,
44 forgiveness of indebtedness, or anything of economic value.

45 (10) "Legislative or administrative interest" means an economic interest, distinct from that of

1 the general public, in:

2 (a) Any matter subject to the decision or vote of the public official acting in the public official's 3 capacity as a public official; or

4 (b) Any matter that would be subject to the decision or vote of the candidate who, if elected, 5 would be acting in the capacity of a public official.

6 (11) "Member of the household" means any person who resides with the public official or can-7 didate.

(12) "Planning commission" means a county planning commission created under ORS chapter 215 or a city planning commission created under ORS chapter 227.

(13) "Potential conflict of interest" means any action or any decision or recommendation by a person acting in a capacity as a public official, the effect of which could be to the private pecuniary benefit or detriment of the person or the person's relative, or a business with which the person or the person's relative is associated, unless the pecuniary benefit or detriment arises out of the following:

(a) An interest or membership in a particular business, industry, occupation or other class re quired by law as a prerequisite to the holding by the person of the office or position.

(b) Any action in the person's official capacity which would affect to the same degree a class consisting of all inhabitants of the state, or a smaller class consisting of an industry, occupation or other group including one of which or in which the person, or the person's relative or business with which the person or the person's relative is associated, is a member or is engaged.

(c) Membership in or membership on the board of directors of a nonprofit corporation that is
 tax-exempt under section 501(c) of the Internal Revenue Code.

(14) "Public office" has the meaning given that term in ORS 260.005.

(15) "Public official" means the First Partner and any person who, when an alleged violation of this chapter occurs, is serving the State of Oregon or any of its political subdivisions or any other public body as defined in ORS 174.109 as an elected official, appointed official, employee or agent, irrespective of whether the person is compensated for the services.

(16)(a) "Public partner" means any business or income-producing not-for-profit corpo ration that is tax exempt under section 501(c) of the Internal Revenue Code that has re ceived, over the previous five years, \$10 million or more in payment of public moneys.

31 (b) As used in this subsection, "payment of public moneys" includes:

32 (A) Payments for work performed on behalf of a public body;

33 (B) Grants awarded by a public body;

34 (C) Loans from a public body that were received at below market-rate; or

(D) Any other expenditure of public moneys that benefitted the business or not-for-profit
 corporation.

(a) The spouse, parent, stepparent, child, sibling, stepsibling, son-in-law or daughter-in-law of the
 public official or candidate;

8	SECTION 2. ORS 244.050 is amended to read:
9	244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
10	Government Ethics Commission a verified statement of economic interest as required under this
11	chapter:
12	(a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the

42	(4) Not later than the 40th day before the date of the statewide general election, each candidate
43	described in subsection (1) of this section who will appear on the statewide general election ballot
44	and who was not required to file a statement of economic interest under subsections (1) to (3) of this
45	section shall file with the commission a statement of economic interest as required under ORS

1 244.060, 244.070 and 244.090.

2 (5) Subsections (1) to (3) of this section apply only to persons who are incumbent, elected or 3 appointed public officials or who are directors or senior executives of a public partner as of 4 April 15 and to persons who are candidates on April 15.

5 (6) If a statement required to be filed under this section has not been received by the commis-6 sion within five days after the date the statement is due, the commission shall notify the public of-7 ficial, director or senior executive of a public partner or candidate and give the public official, 8 director or senior executive of a public partner or candidate not less than 15 days to comply 9 with the requirements of this section. If the public official, director or senior executive of a public 10 partner or candidate fails to comply by the date set by the commission, the commission may impose 11 a civil penalty as provided in ORS 244.350.

SECTION 3. ORS 244.060 is amended to read:

13 244.060. The statement of economic interest filed under ORS 244.050 shall be on a form pre-14 scribed by the Oregon Government Ethics Commission. The public official, director or senior 15 executive of a public partner or candidate filing the statement shall supply the information re-16 quired by this section and ORS 244.090, as follows:

(1) The names of all positions as officer of a business and business directorships held by the public official, **director or senior executive of a public partner** or candidate or a member of the household of the public official, **director or senior executive of a public partner** or candidate during the preceding calendar year, and the principal address and a brief description of each business.

(2) All names under which the public official, director or senior executive of a public partner
 or candidate and members of the household of the public official, director or senior executive of
 a public partner or candidate do business and the principal address and a brief description of each
 business.

(3) The names, principal addresses and brief descriptions of the sources of income received
during the preceding calendar year by the public official, director or senior executive of a public
partner or candidate or a member of the household of the public official, director or senior
executive of a public partner or candidate that produce 10 percent or more of the total annual
household income.

31 (4)(a) A list of all real property in which the public official, director or senior executive of a public partner or candidate or a member of the household of the public official, director or senior 32executive of a public partner or candidate has or has had any personal, beneficial ownership in-33 34 terest during the preceding calendar year, any options to purchase or sell real property, including 35a land sales contract, and any other rights of any kind in real property located within the geographic boundaries of the governmental agency of which the public official or director or senior 36 37 executive of a public partner holds, or the candidate if elected would hold, an official position or 38 over which the public official or director or senior executive of a public partner exercises, or the candidate if elected would exercise, any authority. 39

(b) This subsection does not require the listing of the principal residence of the public official,
 director or senior executive of a public partner or candidate.

(5) All expenses with an aggregate value exceeding \$50 received by the public official during the
preceding calendar year when participating in a convention, mission, trip or other meeting described
in ORS 244.020 (7)(b)(F), including the name and address of the organization, unit of government,
tribe or corporation paying the expenses, the nature of the event and the date and amount of the

1 expense.

2 (6) All expenses with an aggregate value exceeding \$50 received by the public official during the 3 preceding calendar year when participating in a mission, negotiations or economic development ac-4 tivities described in ORS 244.020 (7)(b)(H), including the name and address of the person paying the 5 expenses, the nature of the event and the date and amount of the expenditure.

6 (7) All honoraria and other items allowed under ORS 244.042 with a value exceeding \$15 that 7 are received by the public official, **director or senior executive of a public partner**, candidate or 8 member of the household of the public official, **director or senior executive of a public partner** 9 or candidate during the preceding calendar year, the provider of each honorarium or item and the 10 date and time of the event for which the honorarium or item was received.

(8) The name, principal address and brief description of each source of income exceeding an 11 12 aggregate amount of \$1,000, whether or not taxable, received by the public official or candidate, or 13 a member of the household of the public official or candidate, during the preceding calendar year, if the source of that income is derived from an individual or business that has a legislative or ad-14 15 ministrative interest or that has been doing business, does business or could reasonably be expected to do business with the governmental agency of which the public official holds, or the candidate if 16 elected would hold, an official position or over which the public official exercises, or the candidate 17 18 if elected would exercise, any authority.

19 **SECTION 4.** ORS 244.090 is amended to read:

20 244.090. (1) Each public official, director or senior executive of a public partner or candidate 21 required to file a statement of economic interest under this chapter shall include on the statement 22 the name of any compensated lobbyist who, during the preceding calendar year, was associated with 23 a business with which the public official, director or senior executive of a public partner or 24 candidate or a member of the household of the public official, director or senior executive of a 25 public partner or candidate was also associated.

(2) Subsection (1) of this section does not apply if the only relationship between the public official, director or senior executive of a public partner or candidate and the lobbyist is that the public official, director or senior executive of a public partner or candidate and lobbyist hold stock in the same publicly traded corporation.

30 (3) As used in this section, "lobbyist" has the meaning given that term in ORS 171.725.

31 <u>SECTION 5.</u> The amendments to ORS 244.020, 244.050, 244.060 and 244.090 by sections 1 32 to 4 of this 2019 Act first apply to statements of economic interest that are required to be 33 filed on or after the effective date of this 2019 Act.
