- On page 2, line 1, delete "(c)" and insert "(b)".

- In line 5, delete "(e)" and insert "(d)".
- In line 7, delete "(f)" and insert "(e)".
- 23 In line 9, delete "(g)" and insert "(f)".
- In line 11, delete "grant or loan" and insert "grant, loan or incentive".
- 25 After line 15, insert:
- 26 "(3) Natural resource agencies shall collaborate to develop and deliver a plan to the Governor
- 27 that describes how natural resource agencies shall participate in regional solutions teams.".
- In line 22, delete "carry out" and insert "coordinate".
- In line 31, delete "center" and insert "team" and after "a" delete the rest of the line.
- 30 In line 32, delete "of the".
- In line 40, after "committee" insert "to participate as necessary".
- 32 On page 3, delete lines 1 through 3 and insert:
- 33 "(d) The directors and staff of the state agencies listed in paragraph (a) of this subsection and
- 34 natural resource agencies shall work with regional solutions coordinators and regional solutions
- 35 teams to fulfill regional priorities, in coordination with the office of the Governor.".

After line 5, insert:

 "(f) In considering, reviewing or undertaking regional implementation project proposals or projects that involve significant environmental issues, regional solutions coordinators shall convene all affected stakeholders with the assistance of the Oregon Consensus Program established within the Mark O. Hatfield School of Government for the purpose of providing alternative dispute resolution services to seek to resolve disputed issues, if any.".

"(c) In considering, reviewing and recommending regional implementation project proposals under this subsection, regional solutions advisory committees shall consider whether the project proposal seeks to address the state's economically, socially and environmentally sustainable goals and objectives described in ORS 184.423.".

In line 22, delete "(c)" and insert "(d)".

In line 24, delete "(d)" and insert "(e)".

After line 26, insert:

"SECTION 4. Before the beginning of the 2015 regular legislative session, the Governor and the Director of the Oregon Department of Administrative Services shall develop a process to provide public notice and the opportunity for public comment, and for consideration of public comments, at regional solutions advisory committee meetings where the establishment of regional priorities for community and economic development and regional implementation project proposals are being considered."
