# A-Engrossed House Bill 4020

Ordered by the House February 16 Including House Amendments dated February 16

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Health Care)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Specifies criteria for licensing of extended stay centers and requires Oregon Health Authority to adopt rules. Requires extended stay centers to report discharge data to authority upon request by authority. Permits extended stay center to participate in Oregon Patient Safety Reporting Program.

Requires authority to apply for authorization from Centers for Medicare and Medicaid Services to receive federal matching funds for services of extended stay centers provided to medical assistance recipients and to permit extended stay centers and ambulatory surgical centers to operate under single license.

Adjusts inappropriate series references. Declares emergency, effective on passage.

7	EXTENDED STAY CENTER LICENSING
8	
9	SECTION 1. Section 2 of this 2018 Act is added to and made a part of ORS 441.015 to
10	441.087.
11	SECTION 2. (1) As used in this section:
12	(a) "Extended stay center" means a facility that provides extended stay services.
13	(b) "Extended stay services" means post-surgical and post-diagnostic medical and nursing
14	services provided to a patient who is recovering from a surgical procedure performed in an
15	ambulatory surgical center.
16	(c) "Local hospital" has the meaning given that term in rules adopted by the Oregon
17	Health Authority that are consistent with federal requirements.
18	(d) "Operating room" has the meaning given that term in rules adopted by the authority.
19	(2) The authority shall adopt rules and procedures for the licensing of extended stay
20	centers to ensure that each licensed extended stay center:
21	(a) Is affiliated with a facility:
22	(A) That is licensed by the authority as an ambulatory surgical center;
23	(B) Whose license is in good standing with the authority; and

1	(C) That meets the criteria in subsection (3) of this section;
<b>2</b>	(b) Has no more than two recovery beds for each operating room that is in its affiliated
3	ambulatory surgical center and a total of no more than 10 recovery beds;
4	(c) Discharges patients within 48 hours from the time of admission to the ambulatory
5	surgical center;
6	(d)(A) Has an agreement with at least one local hospital that has the capabilities to treat
7	patients requiring medical care that exceeds the capabilities of the extended stay center and
8	the agreement complies with the federal requirements applicable to patient transfer agree-
9	ments between ambulatory surgical centers and local hospitals; or
10	(B) Is affiliated with an ambulatory surgical center in which all of the physicians per-
11	forming surgeries have admitting privileges at a local hospital that has the capabilities to
12	treat patients requiring medical care that exceeds the capabilities of the extended stay cen-
13	ter;
14	(e) Conforms to all patient safety and facility requirements adopted by the authority by
15	rule;
16	(f) Uses admission criteria based only on the extended stay center's:
17	(A) Medical screening criteria;
18	(B) Evidence-based surgery guidelines; or
19	(C) Patient safety standards;
20	(g) Orally and in writing, clearly notifies patients with Medicare coverage of the services
21	provided by the extended stay center that are not covered by Medicare;
22	(h) Reports data and metrics to the authority as prescribed by the authority by rule, in-
23	cluding but not limited to the:
24	(A) Types of procedures performed at the affiliated ambulatory surgical center for which
25	patients are transferred to the extended stay center for recovery;
26	(B) Average duration of patient stays at the extended stay center;
27	(C) Medical acuity of the patients served by the extended stay center;
28	(D) Types of payers that reimburse services provided at the extended stay center and the
29	percentage of each payer type in the total number of payers; and
30	(E) Frequency and cause of patient transfers from the extended stay center to a hospital;

32	(i) Is located within an urban area as defined by the Office of Rural Health.
33	(3) The ambulatory surgical center that is affiliated with an extended stay center must:
34	(a) Not be affiliated with any other licensed extended stay center;
35	(b) Be physically contiguous with the extended stay center;
36	(c) Have demonstrated safe operating procedures in an outpatient surgery setting for no
37	less than 24 consecutive months;
38	(d) Be certified by the Centers for Medicare and Medicaid Services as participating in the
39	ambulatory surgical center quality reporting program administered by the Centers for Med-
40	icare and Medicaid Services; and
41	(e) Be accredited by a national accrediting organization approved by the authority.
42	(4) The authority shall mitigate barriers to and facilitate the reimbursement of extended
43	stay centers with medical assistance funds.
44	SECTION 3. (1) The Health Evidence Review Commission established under ORS 414.688
45	shall develop evidence-based guidelines regarding the patient characteristics and surgical

1 procedures that may be appropriate for ambulatory surgical centers and extended stay cen-

2 ters. The commission shall provide a report of the timeline and plan for implementing the

3 guidelines to the Legislative Assembly during the 2019 regular session.

4 (2) No later than December 31, 2022, the Oregon Health Authority shall report to the in-5 terim committees of the Legislative Assembly related to health on the implementation of 6 section 2 of this 2018 Act.

(6) "Party to a cooperative program agreement" or "party" means an entity that enters into the 44 principal agreement to establish a cooperative program and applies for approval under ORS 442.700 45

to 442.760 and 646.740 and any other entity that, with the approval of the director, becomes a 1 2 member of a cooperative program. (7) "Physician" means a physician licensed under ORS chapter 677. 3 SECTION 15. ORS 677.515 is amended to read: 4 677.515.
