House Resolution 8

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Honors Ivan Tadic on his 84th birthday.

| 2 | Whereas Ivan Tadic's father emigrated from Yugoslavia through Ellis Island in 1910 at 17 years |
| 3 | of age, settling in Portland and opening a barbershop; and |
| 4 | Whereas Ivan Tadic was born in 1931 and grew up in Portland, attending Central Catholic High |
| 5 | School and graduating in 1950; and |
| 6 | Whereas Ivan Tadic attended barber college and later enlisted in the Navy for four years; and |
| 7 | Whereas Ivan Tadic was assigned to the USS Daviess County (LST-692), a ship that had partic- |
| 8 | ipated in the attack on the beaches of Normandy in 1944, and was then deployed in the Korean War; |

| 10 | Whereas Ivan Tadic operated a 40-millimeter antiaircraft gun on the ship until the ship's captain |
| 11 | discovered that Ivan Tadic had attended barber college; and |
| 12 | Whereas Ivan Tadic thereafter cut the hair of hundreds of United States Naval Construction |
| 13 | Forces members, or "Seabees," between attacks by North Korean bomber planes; and |
| 14 | Whereas Ivan Tadic was honorably discharged in late 1954 and returned to Portland; and |
| 15 | Whereas Ivan Tadic began barbering in his father's Multnomah Village shop in southwest |
| 16 | Portland beginning in 1955; and |
| 17 | Whereas Ivan Tadic and his father worked side by side for 20 years until his father retired and |
| 18 | turned the shop over to Ivan Tadic; and |
| 19 | Whereas Ivan Tadic has now been barbering in the same shop in Multnomah Village for 60 |
| 20 | years; and |
| 21 | Whereas Ivan Tadic never wants to retire and has missed only four days of work due to illness, |
| 22 | including heart and throat surgery, and has taken only one vacation; and |
| 23 | Whereas Ivan Tadic still has returning customers who received their first haircuts from him in |
| 24 | 1955; and |
| 25 | Whereas Ivan Tadic's oldest customer recently passed away at 101 years of age; and |
| 26 | Whereas loyal customers fly and drive in from Washington and California to have Ivan Tadio |
| 27 | cut their hair; and |
| 28 | Whereas Ivan Tadic considers many of his customers his friends, always calls his customers by |
| 29 | their names and remembers them even after not having seen them for decades; and |
| 30 | Whereas Ivan Tadic's barbershop is a longtime fixture in his community and is a place where |
| 31 | many go to receive the best haircut in town; and |
