SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Eliminates probationary driver permits. Standardizes requirements for hardship permits.

Eliminates certain driving privilege suspensions.

Expands list of persons granted driving privileges in this state to include members of commissioned corps of National Oceanic and Atmospheric Administration and members' spouses under certain conditions.

11 **SECTION 1. ORS 807.250, 807.252, 807.260, 807.270, 809.650, 809.660, 813.500 and 813.510 are**
12 **repealed.**

13 **SECTION 1a. Notwithstanding section 7, chapter ___, Oregon Laws 2018 (Enrolled House**
14 **Bill 4055) (amending ORS 807.252), if House Bill 4055 becomes law, ORS 807.252 is repealed by**
15 **section 1 of this 2018 Act.**

16 **SECTION 2. ORS 807.240 is amended to read:**

17 807.240. The Department of Transportation shall provide for issuance of hardship driver permits
18 in a manner consistent with this section. A hardship driver permit grants the driving privileges
19 provided in this section or under the permit. Except as otherwise provided in this section, a hardship
20 driver permit is subject to the fees, provisions, conditions, prohibitions and penalties applicable to
21 a license. The following apply to a hardship driver permit:

22 (1) The department may only issue a permit to a person whose driving privileges under the ve-
23 hicle code have been suspended, **or revoked under ORS 809.600 as a habitual offender.**

28 [*(F)*] (E) That the person must operate a motor vehicle to get to or from a gambling addiction
29 treatment program.

30 (c) If the person is applying for a permit because the person or a member of the person's im-
31 mediate family requires medical treatment on a regular basis, the person must present, in addition
32 to any evidence required by the department under paragraph (b) of this subsection, a statement
33 signed by a licensed physician or certified nurse practitioner that indicates that the person or a
34 member of the person's immediate family requires medical treatment on a regular basis.

35 (d) The person must show that the person is not incompetent to drive nor a habitual incompe-
36 tent, reckless or criminally negligent driver as established by the person's driving record in this or
37 any other jurisdiction.

38 (e) The person must make a future responsibility filing.

39 (f) The person must submit any other information the department may require for purposes of

1 If the department issues the permit for a period shorter than the suspension **or revocation** period,
2 renewal of the permit shall be on such terms and conditions as the department may require. The

16 subsection is in addition to any fee charged for reinstatement of driving privileges under ORS
17 807.370.

18 (7) The department may issue a permit granting the same driving privileges as those suspended
19 **or revoked** or may issue a permit granting fewer driving privileges, as the department determines
20 necessary to assure safe operation of motor vehicles by the permit holder.

21 **(8) The department may not issue a hardship permit to a person:**

22 **(a) Whose driver license or driver permit is suspended pursuant to ORS 25.750 to 25.783;**

23 **(b) Whose driving privileges are suspended pursuant to ORS 809.280 (2);**

24 **(c) That authorizes the person to operate a commercial motor vehicle;**

25 **(d) Whose suspension of driving privileges is based on a second or subsequent conviction**
26 **of driving while under the influence of intoxicants in violation of ORS 813.010 or the statu-**
27 **tory counterpart to ORS 813.010 in another jurisdiction and the suspension period is deter-**
28 **mined by ORS 809.428 (2)(b) or (c);**

29 **(e) Whose driving privileges are suspended for a conviction of assault in the second, third**
30 **or fourth degree if the person, within 10 years preceding application for the permit, has been**
31 **convicted of:**

32 **(A) Any degree of murder, manslaughter, criminally negligent homicide or assault re-**
33 **sulting from the operation of a motor vehicle;**

34 **(B) Reckless driving, as defined in ORS 811.140;**

35 **(C) Driving while under the influence of intoxicants, as defined in ORS 813.010;**

36 **(D) Failure to perform the duties of a driver involved in an accident or collision, as de-**
37 **scribed in ORS 811.700 or 811.705;**

38 **(E) Criminal driving while suspended or revoked, as defined in ORS 811.182;**

39 **(F) Fleeing or attempting to elude a police officer, as defined in ORS 811.540;**

40 **(G) Aggravated vehicular homicide, as defined in ORS 163.149; or**

41 **(H) Aggravated driving while suspended or revoked, as defined in ORS 163.196; or**

42 **(f) Whose driving privileges are suspended for a conviction of assault in the second, third**
43 **or fourth degree:**

44 **(A) For a period of four years from the date the department suspends driving privileges**
45 **if the person's driving privileges are suspended for conviction of assault in the second degree**

1 **and the person was not incarcerated for that conviction.**

2 **(B) For a period of four years from the date the person is released from incarceration**
3 **for the conviction if the person's driving privileges are suspended for conviction of assault**
4 **in the second degree and the person was incarcerated for that conviction.**

5 **(C) For a period of two years from the date the department suspends driving privileges**
6 **if the person's driving privileges are suspended for conviction of assault in the third degree**

9 **the conviction if the person's driving privileges are suspended for conviction of assault in the**
10 **third degree and the person was incarcerated for that conviction.**

11 **(E) For a period of six months from the date the department suspends driving privileges**
12 **if the person's driving privileges are suspended for conviction of assault in the fourth degree**
13 **and the person is not incarcerated for that conviction.**

14 **(F) For a period of six months from the date the person is released from incarceration**
15 **for the conviction if the person's driving privileges are suspended for conviction of assault**
16 **in the fourth degree and the person was incarcerated for that conviction.**

17 **(9) A conviction arising out of the same episode as the current suspension is not con-**
18 **sidered a conviction for purposes of subsection (8)(e) of this section.**

37 tion if the person does not maintain a good driving record, as defined by the administrative rules
38 of the department, during the term of the permit.

40 163.196. (1) A person commits the crime of aggravated driving while suspended or revoked if the
41 person operates a motor vehicle that causes serious physical injury to, or the death of, another
42 person while knowingly violating ORS 811.175 or 811.182, if the suspension or revocation resulted
43 from, or if the hardship [*or probationary*] permit violated is based upon a suspension or revocation
44 that resulted from, a conviction for a criminal offense involving the use of a motor vehicle.

45 (2) Aggravated driving while suspended or revoked is a Class C felony.

1 (3) The Oregon Criminal Justice Commission shall classify aggravated driving while suspended
2 or revoked as crime category 7 of the sentencing guidelines grid of the commission.

4 430.165. The Oregon Health Authority may prescribe fee schedules for any of the programs that

8 five-year period, has been convicted of 20 or more of any one or more of the following offenses as
9 evidenced by the records maintained by the department or by a similar agency of another state:

19 (6) The department shall take action under subsection (1) of this section upon receipt of a record
20 of conviction of reckless endangerment of highway workers under ORS 811.231 (1).

21 [*(7) The department shall take action under subsection (1) of this section upon receipt of a record*
22 *of conviction of theft under ORS 164.043, 164.045 or 164.055 when the theft was of gasoline. A sus-*
23 *sension under this subsection shall continue for a period of six months from the date of suspension.*]

24 [(8)] **(7)** The department shall take action under subsection (1) of this section upon receipt of a
25 record of conviction of criminal trespass under ORS 164.245 that involves the operation of a motor
26 vehicle. A suspension under this subsection shall continue for a period of six months from the date
27 of suspension.

28 [(9)] **(8)** The department shall take action under subsection (1) of this section upon receipt of a
29 record of conviction of an offense described in ORS 809.310. A suspension under this subsection shall
30 continue for a period of one year from the date of the suspension.

31 [(10)(a)] **(9)(a)** The department shall take action under subsection (1) of this section upon receipt
32 of a record of conviction of assault in the second, third or fourth degree resulting from the operation
33 of a motor vehicle.

34 (b) A person who is convicted of assault in the second degree and whose driving privileges are
35 suspended under this subsection may apply for reinstatement of driving privileges eight years from
36 the date the person is released from incarceration for the conviction, if the sentence includes
37 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
38 ply for reinstatement of driving privileges eight years from the date the department suspended the
39 privileges under this subsection.

40 (c) A person who is convicted of assault in the third degree and whose driving privileges are
41 suspended under this subsection may apply for reinstatement of driving privileges five years from
42 the date the person is released from incarceration for the conviction, if the sentence includes
43 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
44 ply for reinstatement of driving privileges five years from the date the department suspended the
45 privileges under this subsection.

1 (d) A person who is convicted of assault in the fourth degree and whose driving privileges are
2 suspended under this subsection may apply for reinstatement of driving privileges one year from the
3 date the person is released from incarceration for the conviction, if the sentence includes
4 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
5 ply for reinstatement of driving privileges one year from the date the department suspended the
6 privileges under this subsection.

7 **SECTION 33.** ORS 809.415 is amended to read:

8 809.415. (1)(a) The Department of Transportation shall suspend the driving privileges of a person
9 who has a judgment of the type described under ORS 806.040 rendered against the person if the
10 person does not settle the judgment in the manner described under ORS 809.470 within 60 days after
11 its entry.

12 (b) A suspension under this subsection shall continue until the person does one of the following:

13 (A) Settles the judgment in the manner described in ORS 809.470.

14 (B) Has an insurer that has been found by the department to be obligated to pay the judgment,
15 provided that there has been no final adjudication by a court that the insurer has no such obli-

17 (C) Gives evidence to the department that a period of seven years has elapsed since the entry

27 policy to lapse or be canceled or otherwise fails to remain in compliance with financial responsi-

30 subsection only if proof of compliance with financial responsibility requirements as of the date of
31 the letter of verification from the department under ORS 806.150 is not submitted within 30 days

33 (c) A suspension under this subsection shall continue until the person complies with future re-
34 sponsibility filings.

35 (3)(a) The department shall suspend the driving privileges of a person who fails to comply with

38 (b) A suspension under this subsection shall continue until the person complies with future re-

40 (c) A person whose initial obligation to make future responsibility filings is not based upon a
41 conviction or other action by a court is entitled to a hearing under ORS 809.440 prior to a suspen-
42 sion under this subsection. A person whose obligation to make future responsibility filings is based
43 upon a conviction or other action by a court is entitled to administrative review under ORS 809.440
44 of a suspension under this subsection. A person whose suspension under this subsection is based on
45 lapses in filing after the initial filing has been made is entitled to administrative review under ORS

1 809.440.

2 (4)(a) The department shall suspend driving privileges when provided under ORS 809.416. The
3 suspension shall continue until the earlier of the following:

4 (A) The person establishes to the satisfaction of the department that the person has performed
5 all acts necessary under ORS 809.416 to make the person not subject to suspension.

6 (B) Ten years from the date the traffic offense or violation of ORS 471.430 occurred if the sus-
7 pension is imposed for a reason described in ORS 809.416 (1)[,] **or** 20 years from the date the traffic
8 offense occurred if the suspension is imposed for a reason described in ORS 809.416 (2) [*or five years*
9 *from the date the suspension is imposed for a reason described in ORS 809.416 (4)*].

10 (b) A person is entitled to administrative review under ORS 809.440 of a suspension under this

26 receives notice from a court to apply this section under ORS 809.220. A person who is subject under
27 this subsection remains subject until the person presents the department with notice issued by the
28 court showing that the person is no longer subject to this section or until 10 years have elapsed
29 from the date the traffic offense or violation of ORS 471.430 occurred, whichever is earlier. This
30 subsection shall not subject a person to ORS 809.415 (4) for any pedestrian offense, bicycling offense
31 or parking offense. Upon receipt of notice from a court, the department shall send a letter by first
32 class mail advising the person that the suspension will commence 60 days from the date of the letter
33 unless the person presents the department with the notice required by this subsection.

34 (2) A person is subject to suspension under ORS 809.415 (4) if the department receives a notice
35 of suspension from a court under ORS 809.210 indicating that the person has failed or refused to pay
36 a fine or obey an order of the court. A person who is subject under this subsection remains subject
37 until the earlier of the following:

38 (a) The person presents the department with a notice of reinstatement issued by the court
39 showing that the person:

40 (A) Is making payments, has paid the fine or has obeyed the order of the court; or

41 (B) Has enrolled in a preapprenticeship program, as defined in ORS 660.010, or is a registered
42 apprentice under ORS 660.020; or

43 (b) Twenty years have elapsed from the date the traffic offense occurred.

44 (3) Subsection (2) of this section does not subject a person to ORS 809.415 (4) for failure or re-
45 fusal to pay a fine relating to any pedestrian offense, bicycling offense or parking offense. Upon

1 receipt of a notice of suspension from a court, the department shall send a letter by first class mail
2 advising the person that the suspension will commence 60 days from the date of the letter unless
3 the person presents the department with the notice of reinstatement required by this subsection.

4 *[(4) A person is subject to suspension under ORS 809.415 (4) if the person pays the department any*
5 *fee or tax with a bank check and the check is returned to the department as uncollectible or the person*
6 *tenders payment with a credit or debit card and the issuer of the card does not pay the department.*
7 *A person who is subject under this subsection remains subject until the department receives the money*
8 *for the fee or tax and any fee charged by the department under ORS 802.170 or until five years have*
9 *elapsed, whichever is earlier.]*

14 **SECTION 35. The amendments to ORS 163.196, 164.775, 165.805, 802.170, 802.550, 807.240,**

16 **811.182 by sections 2, 3, 9, 13 and 18 to 34 of this 2018 Act and the repeal of ORS 339.254,**

27 **SECTION 36.** ORS 807.020 is amended to read:

28 807.020. A person who is granted a driving privilege by this section may exercise the driving
29 privilege described without violation of the requirements under ORS 807.010. A grant of driving
30 privileges to operate a motor vehicle under this section is subject to suspension and revocation the
31 same as other driving privileges granted under the vehicle code. This section is in addition to any
32 exemptions from the vehicle code under ORS 801.026. The following persons are granted the de-
33 scribed driving privileges:

34 (1) A person who is not a resident of this state or who has been a resident of this state for less
35 than 30 days may operate a motor vehicle without an Oregon license or driver permit if the person
36 holds a current out-of-state license issued to the person. For the purpose of this subsection, a person
37 is a resident of this state if the person meets the residency requirements described in ORS 807.062.
38 To qualify under this subsection, the person must have the out-of-state license or driver permit in
39 the person's possession. A person is not granted driving privileges under this subsection:

40 (a) If the person is under the minimum age required to be eligible for driving privileges under
41 ORS 807.060;

42 (b) During a period of suspension or revocation by this state or any other jurisdiction of driving
43 privileges or of the right to apply for a license or driver permit issued by this state or any other
44 jurisdiction; or

45 (c) That exceed the driving privileges granted to the person by the out-of-state license or driver

1 permit.

2 (2) A person *[in]* **who is a member of the Armed Forces of the United States or a member**
3 **of the commissioned corps of the National Oceanic and Atmospheric Administration** may op-
4 erate a motor vehicle without an Oregon license or driver permit if the person is operating a motor
5 vehicle in the course of the person's duties in the Armed Forces **or the National Oceanic and**
6 **Atmospheric Administration.**

7 (3) A person without a license or driver permit may operate a road roller or road machinery
8 that is not required to be registered under the laws of this state.

9 (4) A person without a license or driver permit may temporarily operate, draw, move or propel
10 a farm tractor or implement of husbandry.

11 (5) A person without a license or driver permit may operate a motor vehicle to demonstrate
12 driving ability during the course of an examination administered under ORS 807.070 for the purpose
13 of qualifying for a license or driver permit. This subsection only applies when an authorized exam-
14 iner is in a seat beside the driver of the motor vehicle.

15 (6) Driving privileges for snowmobiles are exclusively as provided in ORS 821.150.

16 (7) Driving privileges for Class I all-terrain vehicles are exclusively as provided in ORS 821.170,
17 unless a person is operating a Class I all-terrain vehicle on an all-terrain vehicle highway access
18 route that is designated by the Oregon Transportation Commission as open to all-terrain vehicles.

19 (8) Driving privileges for Class III all-terrain vehicles are exclusively as provided in ORS
20 821.172, unless a person is operating a Class III all-terrain vehicle on an all-terrain vehicle highway
21 access route that is designated by the commission as open to all-terrain vehicles.

22 (9) Driving privileges for Class IV all-terrain vehicles are exclusively as provided in ORS
23 821.176, unless a person is operating a Class IV all-terrain vehicle on an all-terrain vehicle highway
24 access route that is designated by the commission as open to all-terrain vehicles.

25 (10) A person without a license or driver permit may operate a golf cart in accordance with an
26 ordinance adopted under ORS 810.070.

27 (11) The spouse of a member of the Armed Forces of the United States on active duty **or the**
28 **spouse of a member of the commissioned corps of the National Oceanic and Atmospheric**
29 **Administration** who is accompanying the member on assignment in this state may operate a motor
30 vehicle if the spouse has a current out-of-state license or driver permit issued to the spouse by an-
31 other state in the spouse's possession.

32 (12) A person who is a member of the Armed Forces of the United States on active duty **or a**
33 **member of the commissioned corps of the National Oceanic and Atmospheric Administration**
34 may operate a motor vehicle if the person has a current out-of-state license or driver permit in the
35 person's possession that is issued to the person by the person's state of domicile or by the Armed
36 Forces of the United States in a foreign country. Driving privileges described under this subsection
37 that are granted by the Armed Forces apply only for a period of 45 days from the time the person
38 returns to the United States.

39 (13) A person who does not hold a motorcycle endorsement may operate a motorcycle if the
40 person is:

41 (a) Within an enclosed cab;

42 (b) Operating a vehicle designed to travel with three wheels in contact with the ground at
43 speeds of less than 15 miles per hour; or

44 (c) Operating an auticycle.

45 (14) A person may operate a bicycle that is not an electric assisted bicycle without any grant

1 of driving privileges.

2 (15) A person may operate an electric assisted bicycle without a driver license or driver permit
3 if the person is 16 years of age or older.

4 (16) A person may operate a motor assisted scooter without a driver license or driver permit if
5 the person is 16 years of age or older.

6 (17) A person who is not a resident of this state or who has been a resident of this state for less
7 than 30 days may operate a motor vehicle without an Oregon license or driver permit if the person
8 is at least 15 years of age and has in the person's possession a current out-of-state equivalent of a
9 Class C instruction driver permit issued to the person. For the purpose of this subsection, a person
10 is a resident of this state if the person meets the residency requirements described in ORS 807.062.
11 A person operating a motor vehicle under authority of this subsection has the same privileges and
12 is subject to the same restrictions as a person operating under the authority of a Class C instruction
13 driver permit issued as provided in ORS 807.280.

14 (18) A person may operate an electric personal assistive mobility device without any grant of
15 driving privileges if the person is 16 years of age or older.
