Senate Bill 255

Sponsored by Senator ROBLAN, Representatives SMITH DB, MCKEOWN; Senator HEARD, Representative GOMBERG (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Appropriates moneys from General Fund to Higher Education Coordinating Commission for Oregon Institute of Marine Biology at University of Oregon.

Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

2 Relating to Oregon Institute of Marine Biology funding; and declaring an emergency.

Whereas the University of Oregon has been teaching and conducting research in marine biology on the Southern Oregon coast since the 1920s; and

Whereas in 1929 the Army Corps of Engineers deeded a portion of the Coos Head Military Reservation to the University of Oregon to serve as the permanent home of the university's marine biology program; and

Whereas, aside from a brief interruption during World War II, the location and facilities have supported research from both the University of Oregon and Oregon State University for nearly 100 years; and

Whereas since the late 1960s the University of Oregon has operated the Oregon Institute of Marine Biology as a year-round research and teaching facility; and

Whereas the Oregon Institute of Marine Biology was instrumental in the establishment of the South Slough National Estuarine Research Reserve (SSNERR) and maintains a substantial collaboration with the organization concerning both research and public education; and

Whereas the research done by faculty and students at the Oregon Institute of Marine Biology complements the academic inquiry that occurs at Oregon State University's Hatfield Marine Science Center in Newport, Oregon; and

Whereas the Oregon Institute of Marine Biology and its Charleston Marine Life Center serve as cornerstone educational facilities for K-12, undergraduate, graduate and public education; and

Whereas the Oregon Institute of Marine Biology brings significant federal funding and numerous visitors to the Oregon Coast and is a cornerstone of the economy in the Charleston, Coos Bay and North Bend communities; and

Whereas the Oregon Institute of Marine Biology offers the only undergraduate marine biology major in this state; and

Whereas the undergraduate marine biology major offered by the Oregon Institute of Marine Biology is rapidly growing and highly ranked nationally; and

Whereas the teaching programs at the Oregon Institute of Marine Biology prepare Oregon students with the skills and knowledge to enter the workforce in natural resource fields and to work for state and federal public agencies; and

Whereas modern, safe research vessels are essential to ensuring that students and faculty have
access to important research and teaching sites in Oregon estuaries and the Oregon territorial sea;
and

Whereas the Oregon Legislative Assembly has demonstrated a commitment to marine infrastructure for public universities; now, therefore,

Be It Enacted by the People of the State of Oregon:

SECTION 1. There is appropriated to the Higher Education Coordinating Commission, for the biennium beginning July 1, 2019, out of the General Fund, the amount of \$500,000, for the Oregon Institute of Marine Biology at the University of Oregon for the purpose of leveraging private investment and replacing a research vessel at the institute.

<u>SECTION 2.</u> This 2019 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect on July 1, 2019.
