

Senate Bill 5527

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to State Parks and Recreation Department for biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from lottery moneys for certain purposes.

Limits biennial expenditures by department from federal funds for certain purposes.

Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

Relating to the financial administration of the State Parks and Recreation Department; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There is appropriated to the State Parks and Recreation Department, for the biennium beginning July 1, 2019, out of the General Fund, the amount of \$273,580 for the expenses of the director's office.

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2019, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the State Parks and Recreation Department, for the following purposes:

- (1) Director's office \$ 1,254,948
- (2) Central services \$ 17,872,163
- (3) Parks development..... \$ 17,548,816
- (4) Direct services..... \$ 67,743,280
- (5) Community support
and grants..... \$ 21,591,397

SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2019, as the maximum limits for payment of expenses from lottery moneys allocated from the Parks and Natural Resources Fund to the State Parks and Recreation Department, for the following purposes:

- (1) Director's office \$ 1,211,902
- (2) Central services \$ 17,639,590
- (3) Parks development..... \$ 23,993,420
- (4) Direct services..... \$ 53,640,498
- (5) Community support

2 **SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
3 \$2,374,100 is established for the biennium beginning July 1, 2019, as the maximum limit for
4 payment of expenses from lottery moneys allocated from the Administrative Services Eco-
5 nomic Development Fund to the State Parks and Recreation Department for the payment
6 of debt service.

7 **SECTION 5.** Notwithstanding any other law limiting expenditures, the following amounts
8 are established for the biennium beginning July 1, 2019, as the maximum limits for payment
9 of expenses from federal funds collected or received by the State Parks and Recreation De-
10 partment for the following purposes:

- 11 (1) Parks development..... \$ 1,810,132
- 12 (2) Direct services..... \$ 2,333,020
- 13 (3) Community support
- 14 and grants..... \$ 12,547,291

15 **SECTION 6.** This 2019 Act being necessary for the immediate preservation of the public
16 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect
17 July 1, 2019.
