Senate Bill 566

Sponsored by Senator KNOPP (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Modifies crimes of intimidation in the second degree and intimidation in the first degree. Adds status as peace officer or firefighter to list of characteristics of victim that, as perceived by defendant, constitute motive to commit crime.

ORS 166.155 is amended to read: 4 166.155. (1) A person commits the crime of intimidation in the second degree if the person: 5 (a) Tampers or interferes with property, having no right to do so nor reasonable ground to be-6 lieve that the person has such right, with the intent to cause substantial inconvenience to another 7 8 because of the person's perception of the other's race, color, religion, sexual orientation, disability, [or] national origin or status as a peace officer or firefighter; 9 (b) Intentionally subjects another to offensive physical contact because of the person's percep-10 tion of the other's race, color, religion, sexual orientation, disability, [or] national origin or status 11 12 as a peace officer or firefighter; or (c) Intentionally, because of the person's perception of race, color, religion, sexual orientation, 13disability, [or] national origin or status as a peace officer or firefighter of another or of a mem-14 ber of the other's family, subjects the other person to alarm by threatening: 15 16 (A) To inflict serious physical injury upon or to commit a felony affecting the other person, or 17a member of the person's family; or (B) To cause substantial damage to the property of the other person or of a member of the other 18 19 person's family. 20 (2) Intimidation in the second degree is a Class A misdemeanor. (3) For purposes of this section[,] and ORS 166.165: 2122(a) "Firefighter" has the meaning given that term in ORS 162.225. 23(b) "Peace officer" has the meaning given that term in ORS 133.005. (c) "Property" means any tangible personal property or real property. 24 25SECTION 2. ORS 166.165 is amended to read: 26 166.165. (1) Two or more persons acting together commit the crime of intimidation in the first degree, if the persons: 27 (a)(A) Intentionally, knowingly or recklessly cause physical injury to another person because of 28 the actors' perception of that person's race, color, religion, sexual orientation, disability, [or] na-29 tional origin or status as a peace officer or firefighter; or 30 (B) With criminal negligence cause physical injury to another person by means of a deadly 31 NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.
