

## SENATE AMENDMENTS TO SENATE BILL 755

By COMMITTEE ON JUDICIARY AND BALLOT MEASURE 110 IMPLEMENTATION

1 On page 1 of the printed bill, line 2, after the second semicolon delete the rest of the line and  
2 delete line 3 and insert “amending ORS 51.050, 135.242, 137.300, 153.012, 153.018, 153.019, 153.021,  
3 153.064, 153.992, 161.570, 221.339, 244.050, 419C.370, 423.478, 475.235, 475.752, 475.814, 475.824,  
4 475.834, 475.854, 475.874, 475.884, 475.894, 475.900, 475.925, 475B.759 and 670.280 and sections 1.”.

5 In line 4, delete the period and insert “; and declaring an emergency.”.

6 In line 18, before “health” insert “screening”.

7 In line 21, before “health” insert “screening”.

8 Delete lines 30 and 31.

9 Delete pages 2 through 4.

10 On page 5, delete lines 1 through 43 and insert:

11 “**SECTION 2.** Section 2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended  
12 to read:

13 “**Sec. 2.** [*Grants Program.* (1) *The Oversight and Accountability Council shall oversee and approve*  
14 *grants to implement Addiction Recovery Centers and increase access to community care, as set forth*  
15 *below.*]

16 “[*(2) Addiction Recovery Centers. The Oversight and Accountability Council shall provide grants*  
17 *to existing agencies or organizations, whether government or community-based, to create Addiction*  
18 *Recovery Centers for the purposes of immediately triaging the acute needs of people who use drugs and*  
19 *assessing and addressing any on-going needs thorough intensive case management and linkage to care*  
20 *and services.*]

21 “[*(a) Grants must be disbursed such that at least one center shall be established within each ex-*  
22 *isting coordinated care organization service area. Centers within each existing coordinated care or-*  
23 *ganization service area shall be established and operational by October 1, 2021.*]

24 “[*(b) Grantees must be able to provide or display an ability to provide the following services to any*  
25 *Oregon resident who requests it, in order to receive funding as an Addiction Recovery Center:*]

26 “[*(i) 24/7 triage: Centers shall assess a client’s need for immediate medical or other treatment*  
27 *shortly upon the client’s arrival to determine what acute care is needed and where it can be best pro-*  
28 *vided. Centers shall provide this service twenty-four hours a day, seven days a week, 365 days a*  
29 *year.*]

30 “[*(ii) Health assessment: Centers shall conduct a comprehensive behavioral health needs assessment*  
31 *for each client, including a substance use disorder screening by a certified alcohol and drug counselor*  
32 *or other credentialed addiction treatment professional. The assessment shall prioritize the self-identified*  
33 *needs of the client.*]

34 “[*(iii) Individual intervention plan, intensive case management and connection to services: If, after*  
35 *the completion of the assessment, the client indicates a desire to address some or all of the identified*

1 needs, a case manager shall work with the client to design an individual intervention plan. The plan  
2 must address the client's need for substance use disorder treatment, coexisting health problems, hous-  
3 ing, employment and training, childcare and other services. Intensive case management requires, in the  
4 least, that case managers have a sufficiently low staff-to-client ratio to provide daily support as needed  
5 to connect clients to services and care needed to fulfill the individual intervention plan and have the  
6 capacity to follow-up to ensure clients are accessing care and, if not, to reconnect clients to care as  
7 necessary and as desired by clients.]

8 “[iv] Peer support: Each center shall offer ongoing peer counseling and support from triage and  
9 assessment through implementation of individual intervention plans as well as provide peer outreach  
10 workers to engage directly with marginalized community members who could potentially benefit from  
11 the center's services.]

12 “[v] Outreach: Each center shall assess the need for, and provide, mobile or virtual outreach ser-  
13 vices to reach clients who are unable to access the center.]

14 “[A] Notwithstanding subsection (2)(a) of this section, only one center within each coordinated care  
15 organization service area is required to provide the triage assessments set forth in subsection (2)(b)(i)  
16 of this section.]

17 “[c] All services provided at the centers must be evidence-informed, trauma-informed, culturally  
18 responsive, patient-centered, non-judgmental, and centered on principles of harm reduction. The goal  
19 of the individual intervention plan and intensive case management shall be to address effectively the  
20 client's substance use disorder and any other factors driving problematic behaviors without employing  
21 coercion or shame or mandating abstinence.]

22 “[d] The centers shall be adequately staffed to address the needs of people with substance use  
23 disorder within their regions as determined by the Oversight and Accountability Council, but must in-  
24 clude, at a minimum, at least one person qualified in each of the following categories:]

25 “[Certified alcohol and drug counselor or other credentialed addiction treatment professional;]

26 “[Intensive case manager; and,]

27 “[C] Peer support specialist.]

28 “[e] Each center shall provide timely verification on behalf of any client who has completed a  
29 health assessment, as set forth in subsection (2)(b)(ii) of this section, if the client requests such verifi-  
30 cation to comply with section 22 or section 23 (2) of this Act.]

31 “[3] Increasing Community Access to Care. The Oversight and Accountability Council shall pro-  
32 vide grants to existing agencies or organizations, whether government or community based, to increase  
33 access to one or more of the following:]

34 “[a] Low barrier substance use disorder treatment that is evidence-informed, trauma-informed,  
35 culturally responsive, patient-centered, and non-judgmental;]

36 “[b] Peer support and recovery services;]

37 “[c] Transitional, supportive, and permanent housing for persons with substance use disorder;]

38 “[d] Harm reduction interventions including, but not limited to, overdose prevention education,  
39 access to naloxone hydrochloride and sterile syringes, and stimulant-specific drug education and out-  
40 reach.]

41 “[4] The council shall prioritize providing grants to community-based nonprofit organizations  
42 within each coordinated care organization service area. However, if within any such service area a  
43 community-based nonprofit organization does not apply for a grant or grants are not sought within that  
44 service area for which services are needed, then the council may request and fund grants to any com-  
45 munity care organization or county within that service area.]

1           “(5) *Services provided by grantees, including services provided by Addiction Recovery Centers,*  
2 *shall be free of charge to the persons receiving the services. To the extent consistent with applicable*  
3 *law, grantees and service providers may seek and obtain reimbursement for services provided to any*  
4 *person from any insurer or entity providing insurance to that person.*”]

5           “(1) **The Oversight and Accountability Council shall oversee and approve grants and**  
6 **funding to implement Behavioral Health Resource Networks and increase access to commu-**  
7 **nity care, as set forth below. A Behavioral Health Resource Network is an entity or col-**  
8 **lection of entities that individually or jointly provide some or all of the services described in**  
9 **subsection (2)(d) of this section.**

10           “(2)(a) **The Oversight and Accountability Council, in consultation with the Oregon Health**  
11 **Authority, shall provide grants and funding to agencies or organizations, whether govern-**  
12 **ment or community based, to establish Behavioral Health Resource Networks for the pur-**  
13 **poses of immediately screening the acute needs of people who use drugs and assessing and**  
14 **addressing any ongoing needs through ongoing case management, harm reduction, treat-**  
15 **ment, housing and linkage to other care and services. Recipients of grants or funding to**  
16 **provide substance use disorder treatment or services must be licensed, certified or creden-**  
17 **tialed by the state, including certification under ORS 743A.168 (7), or meet criteria prescribed**  
18 **by rule by the Oversight and Accountability Council under section 4, chapter 2, Oregon Laws**  
19 **2021 (Ballot Measure 110 (2020)).**

20           “(b) **Grants and funding must be disbursed such that at least one network shall be es-**  
21 **tablished and operational within each county by October 1, 2021.**

22           “(c) **Applicants for grants and funding may apply individually or jointly with other net-**  
23 **work participants.**

24           “(d) **A network must have the capacity to provide the following services and any other**  
25 **services specified by the council by rule:**

26           “(A) **Screening by certified addiction peer support or wellness specialists or other quali-**  
27 **fied persons designated by the council to determine a client’s need for immediate medical or**  
28 **other treatment to determine what acute care is needed and where it can be best provided,**  
29 **identify other needs and link the client to other appropriate local or statewide services, in-**  
30 **cluding treatment for substance abuse and coexisting health problems, housing, employment,**  
31 **training and child care. Networks shall provide this service 24 hours a day, seven days a**  
32 **week, every calendar day of the year. Notwithstanding paragraph (b) of this subsection, only**  
33 **one grantee in each network within each county is required to provide the screenings de-**  
34 **scribed in this subparagraph.**

35           “(B) **Comprehensive behavioral health needs assessment, including a substance use dis-**  
36 **order screening by a certified alcohol and drug counselor or other credentialed addiction**  
37 **treatment professional. The assessment shall prioritize the self-identified needs of a client.**

38           “(C) **Individual intervention planning, case management and connection to services. If,**  
39 **after the completion of a screening, a client indicates a desire to address some or all of the**  
40 **identified needs, a case manager shall work with the client to design an individual inter-**  
41 **vention plan. The plan must address the client’s need for substance use disorder treatment,**  
42 **coexisting health problems, housing, employment and training, child care and other services.**

43           “(D) **Ongoing peer counseling and support from screening and assessment through im-**  
44 **plementation of individual intervention plans as well as peer outreach workers to engage di-**  
45 **rectly with marginalized community members who could potentially benefit from the**

1 network's services.

2 “(E) Assessment of the need for, and provision of, mobile or virtual outreach services to:

3 “(i) Reach clients who are unable to access the network; and

4 “(ii) Increase public awareness of network services.

5 “(F) Harm reduction services and information and education about harm reduction ser-  
6 vices.

7 “(G) Low-barrier substance use disorder treatment.

8 “(H) Transitional and supportive housing for individuals with substance use disorders.

9 “(e) All services provided through the networks must be evidence-informed, trauma-  
10 informed, culturally specific, linguistically responsive, patient-centered and nonjudgmental.  
11 The goal shall be to address effectively the client's substance use and any other social de-  
12 terminants of health.

13 “(f) The networks must be adequately staffed to address the needs of people with sub-  
14 stance use disorders within their regions as prescribed by the council by rule, including, at  
15 a minimum, at least one person qualified by the Oregon Health Authority in each of the  
16 following categories:

17 “(A) Certified alcohol and drug counselor or other credentialed addiction treatment pro-  
18 fessional;

19 “(B) Case manager; and

20 “(C) Certified addiction peer support or wellness specialist.

21 “(g) Each network shall provide prompt verification on behalf of any client who has  
22 completed a screening, as set forth in subsection (2)(d)(B) of this section, if the client re-  
23 quests such verification to comply with section 22, chapter 2, Oregon Laws 2021 (Ballot  
24 Measure 110 (2020)), or section 45 of this 2021 Act to:

25 “(A) The client; and

26 “(B) The Oregon Health Authority, which shall forward the verification to the court in  
27 the manner prescribed by the Chief Justice of the Supreme Court.

28 “(3) In addition to grants and funding provided to networks, the council shall provide  
29 grants and funding to other agencies or organizations, whether government or community  
30 based, and to service providers that are affiliated with the nine federally recognized tribes  
31 in this state to increase access to one or more of the following:

32 “(a) Low-barrier substance use disorder treatment that is evidence-informed, trauma-  
33 informed, culturally specific, linguistically responsive, patient-centered and nonjudgmental;

34 “(b) Peer support and recovery services;

35 “(c) Transitional, supportive and permanent housing for persons with substance use dis-  
36 order; or

37 “(d) Harm reduction interventions including, but not limited to, overdose prevention ed-  
38 ucation, access to naloxone hydrochloride and sterile syringes and stimulant-specific drug  
39 education and outreach.

40 “(4) In awarding grants within each geographic area, the council shall prioritize  
41 community-based organizations serving communities most impacted by laws enacted in the  
42 war on drugs initiative.

43 “(5) The council shall require any government entity that applies for a grant to specify  
44 in the application details regarding subgrantees and how the government entity will fund  
45 culturally specific organizations and culturally specific services. A government entity re-

1 ceiving a grant must make an explicit commitment not to supplant or decrease any existing  
2 funding used to provide services funded by the grant.

3 “(6) In determining grants and funding to be awarded, the council may consult the com-  
4 prehensive addiction, prevention, treatment and recovery plan established by the Alcohol and  
5 Drug Commission under ORS 430.223 and the advice of any other group, agency, organization  
6 or individual that desires to provide advice to the council that is consistent with the terms  
7 of this section.

8 “(7) Services provided by grantees, including services provided by a Behavioral Health  
9 Resource Network, shall be free of charge to the clients receiving the services. Grantees in  
10 each network shall seek reimbursement from insurance issuers, the medical assistance pro-  
11 gram or any other third party responsible for the cost of services provided to a client and  
12 grants and funding provided by the council or the authority under subsection (2) of this  
13 section may be used for copayments, deductibles or other out-of-pocket costs incurred by the  
14 client for the services.

15 “(8) Subsection (7) of this section does not require the medical assistance program to  
16 reimburse the cost of services for which another third party is responsible in violation of 42  
17 U.S.C. 1396a(25).

18 “**SECTION 3.** Section 3, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended  
19 to read:

20 “**Sec. 3.** [*Oversight and Accountability Council.*] (1)(a) The Director of the Oregon Health Au-  
21 thority shall establish an Oversight and Accountability Council for the purpose of determining how  
22 funds will be distributed to grant applicants and to oversee the implementation of the [*Centers*]  
23 **Behavioral Health Resource Networks** pursuant to section 2, **chapter 2, Oregon Laws 2021**  
24 **(Ballot Measure 110 (2020))**. The council shall be formed on or before February 1, 2021.

25 “[*(a)*] (b) The council shall [*be comprised*] **consist** of qualified individuals with experience in  
26 substance use disorder treatment and other addiction services. The council shall consist of at least  
27 one member from each of the following categories only:

28 “[*(i)*] (A) A representative of the Oregon Health Authority, Health Systems Division Behavioral  
29 Health Services **as a nonvoting member**;

30 “[*(ii)*] (B) Three members of communities that have been disproportionately impacted by arrests,  
31 prosecution or sentencing for conduct that has been classified or reclassified as a Class E violation  
32 [*pursuant to section 11 to section 19.*];

33 “[*(iii)*] (C) A physician specializing in addiction medicine;

34 “[*(iv)*] (D) A licensed clinical social worker;

35 “[*(v)*] (E) An evidence-based substance use disorder provider;

36 “[*(vi)*] (F) A harm reduction services provider;

37 “[*(vii)*] (G) A person specializing in housing services for people with substance use disorder or  
38 a diagnosed mental health condition;

39 “[*(viii)*] (H) An academic researcher specializing in drug use or drug policy;

40 “[*(ix)*] (I) At least two people who suffered or suffer from substance use disorder;

41 “[*(x)*] (J) At least two recovery peers;

42 “[*(xi)*] (K) A mental or behavioral health provider;

43 “[*(xii)*] (L) A representative of a coordinated care organization; and[,]

44 “[*(xiii)*] (M) A person who works for a [*non-profit*] **nonprofit** organization that advocates for  
45 persons who experience or have experienced substance use disorder.

1 “(2) A quorum consists of [*nine*] **two-thirds of the members of the council, rounded up to the**  
2 **next odd number of members.**

3 “(3) The term of office for a member of the council [*shall be*] **is** four years. Vacancies shall be  
4 appointed for the unexpired term.

5 “(4)(a) To the extent permissible by law, a member of the council performing services for the  
6 council may receive compensation from [*his or her*] **the member’s** employer for time spent per-  
7 forming services as a council member.

8 “(b) If a member of the council is not compensated by [*their*] **the member’s** employer as set  
9 forth in [*subsection (4)(a) of this section*] **paragraph (a) of this subsection**, that member shall be  
10 entitled to compensation and expenses as provided in ORS 292.495.

11 “[*c*] *Nothing in this subsection (4) of this section excuses or exempts a member of the council from*  
12 *complying with any applicable provision of Oregon’s ethics laws and regulations, including the pro-*  
13 *visions of ORS chapter 244.*”

14 “(5) **Members of the council are subject to and must comply with ORS 244.045 (4), 244.047,**  
15 **244.120 and 244.130.**

16 “**SECTION 4.** Section 4, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended  
17 to read:

18 “**Sec. 4.** [*Administration.*] (1)(a) On or before June 30, 2021, the Oversight and Accountability  
19 Council shall adopt rules that establish general criteria and requirements for the [*Addiction Recov-*  
20 *ery Centers*] **Behavioral Health Resource Networks** and the grants **and funding** required by sec-  
21 tion 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, **including rules requiring**  
22 **recipients of grants and funding to collect and report information necessary for the Secre-**  
23 **tary of State to conduct the financial and performance audits required by section 24, chapter**  
24 **2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

25 “(b) The council shall from time to time adopt such rules, and amend and revise rules [*it*] **the**  
26 **council** has adopted, as [*it*] **the council** deems proper and necessary for the administration of [*this*  
27 *Act*] **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the performance of [*its*] **the**  
28 **council’s** work.

29 “(2) The council shall have and retain the authority to implement and oversee the [*Addiction*  
30 *Recovery Centers created by*] **Behavioral Health Resource Networks established under** section  
31 **2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020))**, and the grants [*program created and*  
32 *required by*] **and funding under** section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110**  
33 **(2020))**.

34 “(3) The Oregon Health Authority[, *Health Systems Division Behavioral Health Services*] shall  
35 administer and provide all necessary support to ensure the implementation of [*this Act*] **chapter 2,**  
36 **Oregon Laws 2021 (Ballot Measure 110 (2020))**.

37 “(4)(a) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services,*] **au-**  
38 **thority**, in consultation with the council, may enter into interagency agreements to ensure proper  
39 distribution of funds for the grants [*created and*] required by section 2, **chapter 2, Oregon Laws**  
40 **2021 (Ballot Measure 110 (2020))**.

41 “(b) The [*Oregon Health Authority, Health Systems Division Behavioral Health Services*] **au-**  
42 **thority** shall encourage and take all reasonable measures to ensure that grant recipients cooperate,  
43 coordinate and act jointly with one another to offer the services described in section 2, **chapter 2,**  
44 **Oregon Laws 2021 (Ballot Measure 110 (2020))**.

45 “(c) **The authority shall post to the authority’s website, at the time a grant or funding**

1 **is awarded:**

2 **“(A) The name of the recipient of the grant or funding;**

3 **“(B) The names of any subgrantees or subcontractors of the recipient of the grant or**  
4 **funding; and**

5 **“(C) The amount of the grant or funding awarded.**

6 **“(5) The [Oregon Health Authority, Health Systems Division Behavioral Health Services] au-**  
7 **thority shall provide requested technical, logistical and other support to the council to assist the**  
8 **council with [its] the council’s duties and obligations.**

9  
10 **“FUNDING**

11  
12 **“SECTION 5.** Section 5, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended  
13 to read:

14 **“Sec. 5.** (1) The Drug Treatment and Recovery Services Fund is established in the State  
15 Treasury, separate and distinct from the General Fund. Interest earned by the **Drug Treatment**  
16 **and Recovery Services** Fund shall be credited to the fund.

17 **“(2) The Drug Treatment and Recovery Services Fund shall consist of:**

18 **“(a) Moneys deposited into the fund pursuant to section 6, chapter 2, Oregon Laws 2021**  
19 **(Ballot Measure 110 (2020));**

20 **“(b) Moneys appropriated or otherwise transferred to the fund by the Legislative Assembly;**

21 **“(c) Moneys allocated from the Oregon Marijuana Account, pursuant to ORS 475B.759 (7);**  
22 **[and,]**

23 **“(d) Moneys allocated from the Criminal Fine Account pursuant to ORS 137.300 (4); and**

24 **“[(d)] (e) All other moneys deposited [in] into the fund from any source.**

25 **“(3) Moneys in the fund shall be continuously appropriated to the Oregon Health Authority for**  
26 **the purposes set forth in section 2, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

27 **“[(4) Unexpended moneys in the fund may not lapse and shall be carried forward and may be used**  
28 **without regard to fiscal year or biennium.]**

29 **“[(5)(a)] (4)(a)** Pursuant to subsection (2)(b) of this section, the Legislative Assembly shall ap-  
30 propriate or transfer to the fund an amount sufficient to fully fund the grants program required by  
31 section 2, **chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

32 **“(b) The total amount deposited and transferred into the fund shall not be less than \$57 million**  
33 **for the first year [this Act] chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is in effect.**

34 **“(c) In each subsequent year, [that] the minimum transfer amount set forth in paragraph (b)**  
35 **of this subsection [(5)(b) of this section] shall be increased by not less than the sum of:**

36 **“[(i)] (A) \$57 million multiplied by the percentage [(if any)], if any, by which the monthly av-**  
37 **eraged U.S. City Average Consumer Price Index for the 12 consecutive months ending [December]**  
38 **August 31 of the prior calendar year exceeds the monthly index for the fourth quarter of the cal-**  
39 **endar year 2020; and[.]**

40 **“[(ii)] (B) [An amount not less than the increase] The annual increase, if any, in moneys dis-**  
41 **tributed pursuant to ORS 475B.759 (7).”.**

42 **On page 6, delete lines 12 through 26 and insert:**

43 **“SECTION 7.** Section 7, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), is amended  
44 to read:

45 **“Sec. 7.** (1)(a) Within 180 days of *[the end of first biennium in which this Act becomes effective,*

1 and within 180 days of the end of each subsequent biennium] **June 30, 2020, and every June 30**  
2 **thereafter**, the [Office of Economic Analysis] **Oregon Department of Administrative Services**  
3 shall calculate the savings to the State of Oregon resulting from the [sentence reductions set forth  
4 in section 11 to section 20] **reductions to Class E violations for offenses described in ORS**  
5 **475.752, 475.814, 475.824, 475.834, 475.854, 475.874, 475.884 and 475.894**, including any savings re-  
6 sulting from reductions in arrests, incarceration and supervision.

7 “(b) The savings shall be calculated based on a comparison of the most recent biennium con-  
8 cluded at the time the calculation is made and the biennium [immediately preceding the biennium in  
9 which this Act became effective] **beginning July 1, 2019**.

10 “(2) In making the calculations set forth in this section, the [Office of Economic Analysis] **de-**  
11 **partment** shall use actual data. The [Office of Economic Analysis] **department** may use best avail-  
12 able estimates [where] **when** actual data is unavailable.”.

13 In line 34, delete “Addiction Recovery”.

14 In line 35, delete “Centers” and insert “Behavioral Health Resource Networks”.

15 In line 40, after “(1)” insert “(a)”.

16 After line 42, insert:

17 “(b) The amounts necessary for administration described in paragraph (a) of this subsection do  
18 not include expenditures to establish and maintain the telephone hotline described in section 23 (1),  
19 chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)).”.

20 On page 9, delete lines 12 through 14 and insert:

## 21 22 “VIOLATION PROCEDURES

23  
24 Delete lines 25 through 45 and delete pages 10 through 15.

25 On page 16, delete lines 1 through 17 and insert:

26 “**SECTION 12.** ORS 153.018, as amended by section 19, chapter 2, Oregon Laws 2021 (Ballot  
27 Measure 110 (2020)), is amended to read:

28 “153.018. (1) The penalty for committing a violation is a fine. The law creating a violation may  
29 impose other penalties in addition to a fine but may not impose a term of imprisonment.

30 “(2) Except as otherwise provided by law, the maximum fine for a violation committed by an  
31 individual is:

32 “(a) \$2,000 for a Class A violation.

33 “(b) \$1,000 for a Class B violation.

34 “(c) \$500 for a Class C violation.

35 “(d) \$250 for a Class D violation.

36 “(e) \$100[ or, in lieu of the fine, a completed health assessment as specified in section 2 (2)(b)(ii)  
37 or section 23 (2),] for a Class E violation.

38 “(f) \$2,000 for a specific fine violation, or the maximum amount otherwise established by law for

43 **“(I) Other areas identified by the division.**

44 **“(b) Financial review, which shall include an assessment of the following:**

45 **“(A) The functioning of the grants and funding systems between the council, the au-**

1 **thority and recipients of grants or funding, including by gathering information on who is**  
2 **receiving what grants and funding, the process of applying for the grants and funding and**  
3 **whether that process is conducive to obtaining qualified applicants and applicants from**  
4 **communities of color.**

5 **“(B) Whether grants and funding are going to organizations that are culturally respon-**  
6 **sive and linguistically specific, including an assessment of:**

7 **“(i) The barriers that exist for grant and funding applicants who are Black, Indigenous**  
8 **or People of Color.**

9 **“(ii) The applicants that were denied and why.**

10 **“(iii) Whether grants and other funding are being disbursed based on the priorities**

39 **with treatment.**

40 **“(b) The functioning of:**

41 **“(A) Law enforcement and the courts in relation to Class E violation citations;**

42 **“(B) The telephone hotline operated by the authority; and**

43 **“(C) Entities providing verification of screenings under section 2, chapter 2, Oregon Laws**  
44 **2021 (Ballot Measure 110 (2020)).**

45 **“(c) Disparities shown by demographic data and whether the citation data reveals a dis-**

1 proportionate use of citations in communities most impacted by the war on drugs.

2 “(d) Whether sections 2, 22 and 23, chapter 2, Oregon Laws 2021 (Ballot Measure 110  
3 (2020)), reduce the involvement in the criminal justice system of individuals with drug ad-  
4 diction.

5 “(e) Outcomes for individuals receiving treatment and other social services under section
