## Senate Bill 893

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires prioritizing financial assistance to local law enforcement agencies to partner with community-based organizations in order to address humanitarian crisis associated with unlawful marijuana cultivation or distribution operations in awarding grants through Illegal Marijuana Market Enforcement Grant Program.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

Relating to illegal cannabis; amending section 13, chapter 103, Oregon Laws 2018; and declaring an
emergency.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** Section 13, chapter 103, Oregon Laws 2018, is amended to read:

6 Sec. 13. (1) The Illegal Marijuana Market Enforcement Grant Program is established to assist

7 cities and counties with the costs incurred by local law enforcement agencies in addressing unlawful

8 marijuana cultivation or distribution operations.

9 (2) The Oregon Criminal Justice Commission shall administer the grant program described in 10 subsection (1) of this section and shall award the grants described in this section.

(3) The commission shall adopt rules to administer the grant program. Rules adopted under thissection must include:

13 (a) A methodology for reviewing and approving grant applications and awarding grants; and

(b) A process for evaluating the efficacy of local law enforcement programs and services fundedby the grant program.

(4) Moneys distributed to grant recipients under this section must be spent on costs associated
with addressing and prosecuting unlawful marijuana cultivation or distribution operations.

18 (5) The commission shall prioritize the following when awarding grants under this section:

(a) Providing financial assistance to local law enforcement agencies and district attorneys in
rural areas of this state to address unlawful marijuana cultivation or distribution operations;

(b) Supporting local law enforcement agencies and district attorneys in investigating and pros ecuting large-scale unlawful marijuana cultivation or distribution operations;

(c) Providing financial assistance to local law enforcement agencies and district attorneys in the
investigation and prosecution of organized crime involved in unlawful marijuana cultivation or dis tribution operations; [and]

(d) Providing financial assistance to local law enforcement agencies and district attorneys in the
investigation and prosecution of unlawful marijuana cultivation or distribution operations that di vert marijuana outside of this state[.]; and

(e) Providing financial assistance to local law enforcement agencies to partner with
community-based organizations in order to address the ongoing humanitarian crisis associ-

1ated with unlawful marijuana cultivation or distribution operations and to facilitate con-2nections to any necessary assistance and services for individuals impacted by the3humanitarian crisis, including but not limited to language translation services and housing4and legal assistance.5SECTION 2. This 2021 second special session Act being necessary for the immediate6preservation of the public peace, health and safety, an emergency is declared to exist, and

7 this 2021 second special session Act takes effect on its passage.
