# **A-Engrossed** Senate Bill 928

Ordered by the Senate April 15 Including Senate Amendments dated April 15

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Establishes Oregon Climate Authority[. Establishes] and creates Oregon Climate Board, effective on passage.

Transfers greenhouse gas reporting program from Department of Environmental Quality to Oregon Climate Authority, operative January 1, 2022.

Abolishes State Department of Energy. Transfers duties, functions and powers of State Depart-Abolishes State Department of Energy. Transfers duties, functions and powers of State Depart-ment of Energy related to issuance of loans for small scale local energy projects to Oregon Business Development Department. Transfers remaining duties, functions and powers of State Department of Energy to Oregon Climate Authority, **operative July 1, 2020**. Modifies permissible uses of energy supplier assessment **and reduces maximum amount of energy supplier assessment, operative July 1, 2021**.

Abolishes [Sustainability Board and] Oregon Global Warming Commission. Establishes Energy Program Review Task Force. [Becomes operative January 1, 2020.] Declares emergency, effective on passage.

Sections 2 to 6 and 8 of this 2019 Act are added to and made a part of ORS 19 469.010 to 469.155. 20SECTION 2. The Legislative Assembly finds and declares that: 21(1) Climate change resulting from greenhouse gas emissions is negatively impacting 22public health and Oregon's economic vitality, natural resources and environment. 23(2) It is the goal of Oregon to reduce greenhouse gas emissions, to sequester and store greenhouse gas emissions on natural and working lands and to help communities and indus-24 tries adapt to climate change. 25(3) It is the goal of Oregon to promote the efficient use of energy resources, to develop 2627low-carbon technologies, resources and services to enhance this state's economic competitiveness and to assist Oregon industries and households with the equitable transition 28to an affordable and reliable energy system and a mix of energy resources that can achieve 2930 the state's greenhouse gas emissions reduction goals. 31 (4) The need exists for comprehensive state leadership on climate change, greenhouse gas mitigation and the transition to low-carbon, clean energy resources. It is therefore the policy 32of Oregon: 33 34 (a) That through example and policy, state government will promote greenhouse gas 35emissions reductions, energy conservation, energy efficiency and the adoption of low-carbon, clean energy resources and technologies. 36 37 (b) That Oregon's energy policy and programs should be consistent and aligned with the 38 state's greenhouse gas emissions reduction goals and climate change policies. (c) That the state promote the development of a resilient, safe and affordable system of 39 diverse energy resources and related infrastructure. 40 (d) That state government assist every citizen and industry in adjusting to changes in 41 the energy system and mix of energy resources to achieve the state's greenhouse gas emis-42 43 sions reduction goals. (e) That the state encourage low-carbon and energy-efficient modes of transportation for 44 people and for freight. 45

1	(f) That the state pursue opportunities to conserve energy, to increase energy efficiency,
<b>2</b>	to enhance resilience to the impacts of climate change and to reduce emissions associated
3	with the built environment.
4	(g) That the state identify and pursue opportunities to sequester and store carbon on
5	natural and working landscapes.
6	(h) That the state's climate change policies, goals and strategies will be informed by the
7	best available science and economics.
8	(i) That, to the greatest degree possible, the Oregon Climate Authority will pursue poli-
9	cies and programs that promote innovation and harness market incentives.
10	(j) That state agency decision-making relating to climate policy, energy sources, facilities
11	or conservation shall consider cost-effectiveness, alongside climate and environmental policy
12	objectives.
13	(k) That the authority shall be transparent and accountable to regulated entities and
14	stakeholders.
15	(L) That state government shall provide a source of impartial and objective information
16	in order that this energy and climate policy may be enhanced.

20	SECTION 3. (1) The Oregon Climate Authority is established.
21	(2) The Oregon Climate Authority shall:
22	(a) Be the central repository within the state government for the collection and analysis

24	mitigation and adaptation, energy resources and energy markets.
25	(b) Coordinate state agency actions toward achieving reductions in greenhouse gas
26	emissions in accordance with ORS 468A.205 and other statutes, rules and policies that govern
27	state agency actions to reduce greenhouse gas emissions.
28	(c) Coordinate state agency actions toward achieving state goals related to energy, en-
29	ergy conservation, energy efficiency and energy safety.
30 21	(d) Advise, consult and cooperate as requested with other state agencies, political subdi-
31 32	visions, other states or the federal government in respect to matters pertaining to the re- duction of greenhouse gas emissions levels in Oregon and the pursuit of goals related to
	climate change and clean energy.
33 34	(e) Advise the Governor and the Legislative Assembly on climate change and energy-
34 35	related matters.
36	(f) Endeavor to utilize all public and private sources to inform and educate the public
37	about climate change and energy challenges and solutions, and about the ways in which the
38	public can conserve energy resources, mitigate greenhouse gas emissions and adapt to cli-
39	mate change.
40	(g) Engage in research but, whenever possible, contract with appropriate public or pri-
41	vate agencies and dispense funds for research projects and other services related to climate
42	change and energy, except that the Oregon Climate Authority shall endeavor to avoid dupli-
43	cation of research whether completed or in progress.
44	(h) Qualify for, accept and disburse or utilize any private or federal moneys or services

15	(o) Upon request of the governing body of any affected jurisdiction, coordinate a public
16	review of a proposed transmission line according to the provisions of ORS 469.442.

20	SECTION 4. (1) The Oregon Climate Authority shall be under the supervision of the Di-
21	rector of the Oregon Climate Authority, who shall:
22	(a) Supervise the day-to-day functions of the Oregon Climate Authority;
23	(b) Supervise and facilitate the work and research on energy facility siting applications
24	at the direction of the Energy Facility Siting Council;
25	(c) Hire, assign, reassign and coordinate personnel of the Oregon Climate Authority,

28	(d) Adopt rules and issue orders to carry out the duties of the director and the authority

43	(a) The Director of the Oregon Climate Authority;
44	(b) One member jointly appointed by the President of the Senate and the Speaker of the
45	House of Representatives who is a member of either the Senate or the House of Represen-

tatives and who is also a member of the Republican Party and serves as a member of a 1 committee of the Legislative Assembly related to climate; 2 (c) One member jointly appointed by the President of the Senate and the Speaker of the 3 House of Representatives who is a member of either the Senate or the House of Represen-4 tatives and who is also a member of the Democratic Party and serves as a member of a 5 committee of the Legislative Assembly related to climate; 6 (d) One member who is a member of the office of the Governor and who serves as a 7 policy advisor to the Governor on issues related to climate; 8 9 (e) One member who represents the Oregon Climate Change Research Institute; (f) The chairperson of the Environmental Justice Task Force; 10 (g) The Director of Agriculture or the designee of the director; 11 12 (h) The Director of the Department of Environmental Quality or the director's designee; (i) A member of the Public Utility Commission or the designee of the chairperson of the 13 commission; 14 (j) The Director of Transportation or the director's designee; 15 (k) The Director of the Housing and Community Services Department or the director's 16 designee; 17 18 (L) The Water Resources Director or the director's designee; and (m) The Director of the Oregon Health Authority or the director's designee. 19 (3) The Governor shall appoint nine members to the board, subject to confirmation by the 20Senate as provided in ORS 171.562 and 171.565. Members of the board appointed under this 21 22subsection must be residents of this state well informed in energy and climate issues and 23shall include the following: (a) One member who is a tribal representative; 94 (b) Two members who are representatives of the energy sector; 25(c) One member who represents environmental interests; 2627(d) One member who is an economist or who has experience and expertise in state fi-28nance; (e) One member who represents industrial energy users; 2930 (f) One member with expertise in transportation issues; and 31 (g) Two at-large members. SECTION 6. (1) The term of office of each member appointed to the Oregon Climate 32Board is four years, but the members of the board may be removed by the Governor. Before 33 34 the expiration of the term of a member, the Governor shall appoint a successor to assume 35the duties of the member on July 1 of the next following year. (2) A member is eligible for reappointment, but no member may serve more than two 36 37 consecutive terms. In case of a vacancy for any cause, the Governor shall make an appointment to become immediately effective for the unexpired term. 38 (3) The Governor shall select one of the voting members as chairperson and another as 39 vice chairperson, for terms and with duties and powers necessary for the performance of the 40 functions of the offices as the board determines. 41 (4) A majority of the voting members of the board constitutes a quorum for the trans-42 action of business. 43

The board may hold additional meetings at times and places deter-1 mined by the chairperson or the Director of the Oregon Climate Authority, or as requested 2 by a majority of the voting members. 3 (6) A member of the board is not entitled to compensation but may be reimbursed from 4 funds available to the board for actual and necessary travel and other expenses incurred by 5 the member in the performance of the member's official duties in the manner and amount 6 provided in ORS 292.495. 7 SECTION 7. Notwithstanding the term of office specified by section 6 of this 2019 Act, 8 9 of the members first appointed by the Governor to the Oregon Climate Board: (1) Two shall serve for terms ending July 1, 2020. 10 (2) Two shall serve for terms ending July 1, 2021. 11 12(3) Two shall serve for terms ending July 1, 2022. (4) Three shall serve for terms ending July 1, 2023. 13 SECTION 8. (1) The Oregon Climate Board shall advise the Director of the Oregon Cli-14 15 mate Authority regarding: (a) The implementation, administration and enforcement of the programs and activities 16 of the Oregon Climate Authority; 17 18 (b) The development of the rules and policies of the authority in accordance with the policy stated in section 2 of this 2019 Act and state climate, energy and environmental poli-19 cies; and 20(c) The preparation for submission to the Governor of budget forms under ORS 291.208 2122for purposes related to the compilation and preparation of the Governor's budget under ORS 23291.216. (2) By arrangement with the chairperson of the Oregon Climate Board, the Director of 94 the Oregon Climate Authority shall review with the board the activities of the authority and, 25subject to policy direction by the board, outline the methods, policies and program of work 2627for the authority. (3) The board shall receive regular reports from the Energy Facility Siting Council and 28the Oregon Hanford Cleanup Board. 2930 (4) The Oregon Climate Board shall provide a biennial report to the Legislative Assembly 31 in the manner provided in ORS 192.245 on the progress of the state in meeting the state's climate and clean energy and energy conservation goals. 32(5) The board shall hold public hearings and provide an opportunity for public comment 33 34 in carrying out the board's activities under this section. 35SECTION 8a. (1) No later than September 15 of each year, the Oregon Climate Board shall submit a report, in the manner provided in ORS 192.245, to the Legislative Assembly 36 37 on activities related to implementing the establishment of the Oregon Climate Authority. (2) The report shall include, but need not be limited to, information on: 38 (a) The transfer of programs between the authority and other state agencies as provided 39 for by law; and 40 (b) The development of capacity by the authority to implement, administer and enforce 41 the programs and activities of the authority. 42 (3) The report may include recommendations for legislation. 43 SECTION 8b. Section 8a of this 2019 Act is repealed on January 2, 2023. 44

(o) For energy facilities that emit carbon dioxide, the impacts of those emissions on climate
change. For fossil-fueled power plants, as defined in ORS 469.503, the council shall apply a standard
as provided for by ORS 469.503 (2).

(2) The council may adopt exemptions from any need standard adopted under subsection (1)(L)
of this section if the exemption is consistent with the state's energy policy set forth in [ORS 469.010
and 469.310] section 2 of this 2019 Act and ORS 469.310.

(3)(a) The council may issue a site certificate for a facility that does not meet one or more of the applicable standards adopted under subsection (1) of this section if the council determines that the overall public benefits of the facility outweigh any adverse effects on a resource or interest protected by the applicable standards the facility does not meet.

(b) The council by rule shall specify the criteria by which the council makes the determinationdescribed in paragraph (a) of this subsection.

(4) Notwithstanding subsection (1) of this section, the council may not impose any standard developed under subsection (1)(b), (f), (j) or (k) of this section to approve or deny an application for an energy facility producing power from wind, solar or geothermal energy. However, the council may, to the extent it determines appropriate, apply any standards adopted under subsection (1)(b),
(f), (j) or (k) of this section to impose conditions on any site certificate issued for any energy facility.
SECTION 113. ORS 469.503 is amended to read:

44 469.503. In order to issue a site certificate, the Energy Facility Siting Council shall determine 45 that the preponderance of the evidence on the record supports the following conclusions:

1 (1) The facility complies with the applicable standards adopted by the council pursuant to ORS 2 469.501 or the overall public benefits of the facility outweigh any adverse effects on a resource or 3 interest protected by the applicable standards the facility does not meet.

4 (2) If the energy facility is a fossil-fueled power plant, the energy facility complies with any 5 applicable carbon dioxide emissions standard adopted by the council or enacted by statute. Base 6 load gas plants shall comply with the standard set forth in subsection (2)(a) of this section. Other 7 fossil-fueled power plants shall comply with any applicable standard adopted by the council by rule 8 pursuant to subsection (2)(b) of this section. (a) The net carbon dioxide emissions rate of the proposed base load gas plant shall not exceed 10 0.70 pounds of carbon dioxide emissions per kilowatt hour of net electric power output, with carbon 11 12 dioxide emissions and net electric power output measured on a new and clean basis. 13 Notwithstanding the foregoing, the council may by rule modify the carbon dioxide emissions standard for base load gas plants if the council finds that the most efficient stand-alone combined cycle, 14 15 combustion turbine, natural gas-fired energy facility that is commercially demonstrated and operat-16 ing in the United States has a net heat rate of less than 7,200 Btu per kilowatt hour higher heating value adjusted to ISO conditions. In modifying the carbon dioxide emission standard, the council 17 18 shall determine the rate of carbon dioxide emissions per kilowatt hour of net electric output of such 19 energy facility, adjusted to ISO conditions, and reset the carbon dioxide emissions standard at 17 20percent below this rate.

(b) The council shall adopt carbon dioxide emissions standards for other types of fossil-fueled power plants. Such carbon dioxide emissions standards shall be promulgated by rule. 37 (K) Promote prompt implementation of offset projects;

38 (L) Provide for monitoring and evaluation of the performance of offsets; and

39 (M) Promote reliability of the regional electric system.

(c) The council shall determine whether the applicable carbon dioxide emissions standard is met by first determining the gross carbon dioxide emissions that are reasonably likely to result from the operation of the proposed energy facility. Such determination shall be based on the proposed design of the energy facility. The council shall adopt site certificate conditions to ensure that the predicted carbon dioxide emissions are not exceeded on a new and clean basis. For any remaining emissions reduction necessary to meet the applicable standard, the applicant may elect to use any of subpar-

agraphs (A) to (D) of this paragraph, or any combination thereof. The council shall determine the 1 amount of carbon dioxide or other greenhouse gas emissions reduction that is reasonably likely to 2 result from the applicant's offsets and whether the resulting net carbon dioxide emissions meet the 3 applicable carbon dioxide emissions standard. For purposes of determining the net carbon dioxide 4 emissions, the council shall by rule establish the global warming potential of each greenhouse gas  $\mathbf{5}$ based on a generally accepted scientific method, and convert any greenhouse gas emissions to a 6 carbon dioxide equivalent. Unless otherwise provided by the council by rule, the global warming 7 potential of methane is 23 times that of carbon dioxide, and the global warming potential of nitrous 8 9 oxide is 296 times that of carbon dioxide. Unless modified by the council as provided below, the payment of 57 cents shall be deemed to result in a reduction of one ton of carbon dioxide emissions. 

 public purposes on which the revenue was expended.

(4) A consumer-owned utility may comply with the public purpose requirements of this section
 by participating in collaborative efforts with other consumer-owned utilities located in this state.

(5) Funds assessed and paid by, and credits or other financial assistance issued or extended to, 35retail electric consumers for purposes of this section may, in the discretion of the governing body 36 37 of the consumer-owned utility, be expended to fund programs for energy conservation, renewable 38 resources or low-income energy services otherwise required by the laws of this state, adopted by the governing body pursuant to the National Energy Conservation Policy Act (Public Law 95-619, as 39 amended November 10, 1981), or conducted by the utility pursuant to agreement with the Bonneville 40 Power Administration under the Pacific Northwest Electric Power Planning and Conservation Act 41 (Public Law 96-501). All such funds expended, credits issued and incremental costs incurred in con-42 nection with the performance of a consumer-owned utility's obligations under this section shall be 43 credited toward the utility's public purpose funding obligation under this section. 44

45 (6) A consumer-owned utility also may credit toward its funding obligations under this section

any incremental costs incurred by the utility for capital expenditures made to reduce its distribution system energy losses, existing biomass gas and waste to energy systems, existing hydroelectric generation projects using fish attraction water, for new energy conservation and renewable resource funding costs included in its wholesale power supplier's charges and for electric power generated by renewable or cogeneration resources pursuant to requirements of the Public Utilities Regulatory Policy Act of 1978 (Public Law 95-617), to the extent that such costs exceed the average cost of the utility's other electric power resources.

8 (7) A consumer-owned utility also may credit toward its public purpose funding obligations under
9 this section any costs incurred in complying with ORS 469.649 to 469.659.

10 (8) Beginning on March 1, 2002, a consumer-owned utility whose territory abuts the greatest 11 percentage of the site of an aluminum plant that averages more than 100 megawatts of electricity 12 use per year shall collect from the aluminum company a public purpose charge equal to one percent 13 of the total revenue from the sale of electricity services to the aluminum plant from any source.

(9)(a) A retail electricity consumer that uses more than one average megawatt of electricity at any site in the prior year shall receive a credit against public purpose charges billed by a consumer-owned utility for that site. The amount of the credit shall be equal to the total amount of qualifying expenditures for new energy conservation, not to exceed 68 percent of the annual public purpose charges, and the above-market costs of purchases of new renewable energy resources incurred by the retail electricity consumer, less administration costs incurred under this subsection. The credit shall not exceed, on an annual basis, the lesser of:

(A) The amount of the retail electricity consumer's qualifying expenditures; or

(B) The portion of the public purpose charge billed to the retail electricity consumer that is
dedicated to new energy conservation, new market transformation or the above-market costs of new
renewable resources.

25(b) To obtain a credit under this subsection, a retail electricity consumer shall file with the [department] Oregon Climate Authority a description of the proposed conservation project, new 2627market transformation or new renewable energy resource and a declaration that the retail electricity consumer plans to incur the qualifying expenditure. The [department] authority shall issue 28a notice of precertification within 30 days of receipt of the filing, if such filing is consistent with 2930 this subsection. Notice shall be issued to the retail electricity consumer and the appropriate 31 consumer-owned utility. The credit may be taken after a retail electricity consumer provides a letter from a certified public accountant to the [department] authority verifying that the precertified 32qualifying expenditure has been made. 33

(c) Credits earned by a retail electricity consumer as a result of qualifying expenditures that
 are not used in one year may be carried forward for use in subsequent years.

(d)(A) A retail electricity consumer that uses more than one average megawatt of electricity at 36 37 any site in the prior year may request that the [department] authority hire an independent auditor 38 to assess the potential for conservation measures at the site. If the independent auditor determines there is no available conservation measure at the site that would have a simple payback of one to 39 10 years, the retail electricity consumer shall be relieved of 54 percent of its payment obligation for 40 public purpose charges related to the site. If the auditor determines that there are potential con-41 servation measures available at the site, the retail electricity consumer shall be entitled to a credit 42 against public purpose charges related to the site equal to 54 percent of the public purpose charges 43 less the estimated cost of available conservation measures. 44

45 (B) A retail electricity consumer shall be entitled each year to the credit described in this par-

1 agraph unless a subsequent audit determines that new conservation investment opportunities are 2 available. The [department] **authority** may require that a new audit be performed on the site to 3 determine whether new conservation measures are available, provided that the audits occur no more 4 than once every two years.

5 (C) The retail electricity consumer shall pay the cost of the audits described in this subsection. 6 (10) A retail electricity consumer with a load greater than one average megawatt shall not be 7 required to pay a public purpose charge in excess of three percent of the consumer's total cost of 8 electricity services unless the charge is established in an agreement between the consumer and the 9 consumer-owned utility.

(11) Beginning on March 1, 2002, a consumer-owned utility shall have in operation a bill assistance program for households that qualify for federal low-income energy assistance in the consumer-owned utility's service area. A consumer-owned utility shall report annually to the Housing and Community Services Department detailing the utility's program and program expenditures.

(12) A consumer-owned utility may require an electricity service supplier to provide information necessary to ensure compliance with this section. The consumer-owned utility shall ensure the privacy and protection of any proprietary information provided.
