

# Senate Joint Resolution 203

Sponsored by Senator PROZANSKI; Representatives BARNHART, HOLVEY, HOYLE, NATHANSON (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Rescinds Senate Joint Resolution 34 (2013).

Proposes amendment to Oregon Constitution to allow person serving as judge to be employed by Oregon National Guard for purpose of performing military service or by public university for purpose of teaching.

Refers proposed amendment to people for their approval or rejection at next regular general election.

## JOINT RESOLUTION

2 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

3 **PARAGRAPH 1. Senate Joint Resolution 34, Seventy-seventh Legislative Assembly, 2013**  
4 **Regular Session, is rescinded. The Secretary of State may not refer Senate Joint Resolution**  
5 **34, Seventy-seventh Legislative Assembly, 2013 Regular Session, to the people for their ap-**  
6 **proval or rejection at the next regular general election held throughout this state.**

7 **PARAGRAPH 2.** The Constitution of the State of Oregon is amended by creating a new section  
8 8a to be added to and made a part of Article XV, and by amending section 8, Article XV, such  
9 sections to read:

10 **Sec. 8.** Notwithstanding the provisions of section 1, [*article*] **Article** III and section 10, [*article*]  
11 **Article** II of [*the*] **this** Constitution [*of the State of Oregon,*]:

12 (1) [a] **A** person employed by [*the State Board of Higher Education,*] **any board or commission**  
13 **established by law to supervise and coordinate the activities of Oregon's institutions of**  
14 **post-secondary education, a person employed by a public university as defined by law or a**  
15 **member or employee** of any school board [*or employee thereof, shall be*] **is** eligible to [*a seat in*]  
16 **serve as a member of** the Legislative Assembly, and [*such*] membership in the Legislative Assembly  
17 [*shall*] **does** not prevent [*such*] **the** person from being employed by [*the State Board of Higher Edu-*  
18 *cation*] **any board or commission established by law to supervise and coordinate the activities**  
19 **of Oregon's post-secondary institutions of education or by a public university as defined by**  
20 **law, or from being a member or employee of a school board.**

21 (2) **A person serving as a judge of any court of this state may be employed by the Oregon**  
22 **National Guard for the purpose of performing military service or may be employed by any**  
23 **public university as defined by law for the purpose of teaching, and the employment does not**  
24 **prevent the person from serving as a judge.**

25 **SECTION 8a.** Notwithstanding any other provision of this Constitution, if the amendment  
26 to section 8 of this Article proposed by Senate Joint Resolution 34 (2013) is approved by the  
27 people at the general election held on November 4, 2014, the amendment to section 8 of this  
28 Article by Senate Joint Resolution 34 (2013) shall not be effective and the amendment to

1 **section 8 of this Article proposed by Senate Joint Resolution 203 (2014) (LC 153) shall be ef-**

5 **people for their approval or rejection at the next regular general election held throughout**  
6 **this state.**
