#### AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in educational gratuity program, establishing the Medal of Honor and Purple Heart Recipient Tuition Waiver Program; and making editorial changes. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 Section 1. - 29 (3) was honorably discharged from the military or naval
- 30 forces of the United States and certified by the United

- 1 States Veterans' Administration as a 100% disabled veteran as
- 2 a result of service during a period of war or armed conflict
- 3 or as a result of hostile fire or terrorist attack (as
- 4 determined by the Department of Military Affairs) during

- 26 (a) General rule. -- The commission shall make educational
- 27 gratuity payments not exceeding \$500 per term or semester per
- 28 qualified child to each approved educational institution upon
- 29 submission by that approved educational institution of proof
- 30 that bills have been incurred or contracted covering

- 1 matriculation fees and other necessary fees, tuition, board,
- 2 room rent, books and supplies for a qualified child in a
- 3 definite amount for the school year.
- 4 (b) Records. -- The commission shall attach the proof
- 5 submitted under subsection (a) to the requisition prepared for
- 6 payment out of appropriations made by the General Assembly for
- 7 purposes of the educational gratuity payments.
- 8 (c) Duration of payments. -- Whenever a qualified child is
- 9 completing an educational or training course and becomes 23
- 10 years of age before completing the course, the educational
- 11 gratuity payment may be paid until the course is completed. No
- 12 educational gratuity payments may be made for any qualified
- 13 child for a period longer than four scholastic years, provided,
- 14 however, that the department may adjust the payments per term or
- 15 semester per child so that the total payments do not exceed the
- 16 amount of the appropriation.

- 18 (a) Eligibility standards. -- The following requirements shall
- 19 be used to determine the eligibility of applicants for
- 20 educational gratuity payments. The applicant shall be:
- 21 (1) Not less than 16 years of age nor more than 23 years
- of age.

- 26 <u>"Medal of Honor recipient." A qualified resident who is a</u>

- 28 of the individual's service in the United States Armed Forces.
- 29 "Public institution of higher education." One of the

- 10 "Purple Heart recipient." A qualified resident who is a
- 11 <u>veteran and who has earned or has been awarded the Purple Heart</u>
- 12 as a result of the individual's service in the United States
- 13 <u>Armed Forces.</u>
- 14 "Qualified resident." An individual who has been a bona fide
- 15 <u>resident of this Commonwealth prior to the time an application</u>
- 16 <u>for a tuition waiver is made.</u>
- 17 "Tuition." The rate charged to a resident of this
- 18 Commonwealth by a public institution of higher education.
- 19 "Veteran." An individual who has served in the United States
- 20 Armed Forces including a reserve component or National Guard and
- 21 who has been discharged or released from the service under
- 22 conditions other than dishonorable.
- 23 § 8722. Establishment.
- There is established the Medal of Honor and Purple Heart
- 25 Recipient Tuition Waiver Program.
- 26 § 8723. Requirements.
- 27 (a) Waiver.--Beginning in the 2016-2017 academic year, a
- 28 public institution of higher education shall waive the tuition
- 29 for each qualified resident who is a recipient of the Medal of
- 30 <u>Honor or Purple Heart who:</u>

- 1 (1) Is admitted as a full-time or part-time student in a
- 2 program of study leading to a degree or certificate.
- 3 (2) Submits verification as provided under paragraph (3)
- 4 <u>that the veteran is a Medal of Honor or Purple Heart</u>
- 5 <u>recipient.</u>
- 6 (3) Provides documentation as required by the department
- 7 that provides verification that the applicant meets the
- 8 <u>requirements under this subchapter.</u>
- 9 (b) Determination. -- The agency shall make the final decision
- 10 as to whether an applicant is a qualified resident.
- 11 § 8724. Regulations.
- 12 The Adjutant General and the agency may promulgate
- 13 regulations to carry out the provisions of this chapter.
- 14 Section 7. This act shall take effect in 60 days.
