6	Section 1. Section 3354(f) of Title 75 of the Pennsylvania
7	Consolidated Statutes is amended and the section is amended by
8	adding a subsection to read:
9	§ 3354. Additional parking regulations.

11	(e.2) Electric vehicle charging station parkingNo person
12	shall stop, stand or park a vehicle within a parking space
13	specifically designated for parking and charging an electric
14	vehicle in accordance with departmental regulations unless the
15	vehicle is an electric vehicle and connected to the charging
16	equipment. The department shall promulgate regulations requiring
17	that conspicuous signage or markings properly identifying the
18	parking space as specifically designated for parking and

charging an electric vehicle and identify charging restrictions. 1 A vehicle that is unlawfully parked under this subsection may be 2 towed and may be reclaimed by the vehicle owner upon payment of 3 the towing costs. A vehicle may only be towed under this 4 subsection if the parking space is posted with a sign indicating 5 that vehicles in violation of this section may be towed. 6 7 (f) Penalty.--A person violating subsection (a), (b) or (d) 8 (1) is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of not more than \$15. A person 9 10 violating subsection (d)(2) or (3) [or], (e) or (e.2) is guilty of a summary offense and shall, upon conviction, be sentenced to 11 12 pay a fine of not less than \$50 nor more than \$200. If a person 13 is convicted under subsection (d) (2) or (3) or (e.2) in the 14 absence of a sign stating the penalty amount, the fine imposed may not exceed \$50. A person violating subsection (d.1) is 15 quilty of a summary offense and shall, upon conviction, be 16 sentenced to pay a fine of not less than \$100 nor more than 17 18 \$300.
