AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, further providing for display of registration plate.

The General Assembly of the Commonwealth of Pennsylvania
hereby enacts as follows:
Section 1. Section 1332 of Title 75 of the Pennsylvania
Consolidated Statutes is amended by adding a subsection to read:
§ 1332. Display of registration plate.

(a.1) Motorcycle registration plate.--
(1) A registration plate issued for a motorcycle may be
mounted on the motorcycle in a vertical manner, provided that $<-=$
the mounting complies with all othex provisions of this section.

            (I) THE IDENTIFYING CHARACTERS ON THE PLATE ARE
    DISPLAYED IN A VERTICAL ALIGNMENT; AND
(II) THE MOUNTING COMPLIES WITH ALL OTHER PROVISIONS
OF THIS SECTION.
(2) A REGISTRATION PLATE THAT HAS ITS IDENTIFYING
CHARACTERS DISPLAYED HORIZONTALLY SHALL NOT BE DISPLAYED AND
MOUNTED VERTICALLY.
(3) THE DEPARTMENT SHALL produce a registration plate
for motorcycles which displays the identifying characters on
the plate in a vertical alignment and shall issue the plate <--
upon payment of a fee of $\$ 20$. THE DEPARTMENT SHALL ISSUE <--
SUCH A PLATE UPON REQUEST AND UPON PAYMENT OF A FEE OF $\$ 20$,
which shall be in addition to the annual registration fee.

Section 2. This act shall take effect in 90 days. <--
