AN ACT

1 Making appropriations from the State Lottery Fund for the fiscal
2 year beginning July 1, 2019, and for the payment of bills
3 incurred and remaining unpaid at the close of the fiscal year
4 ending June 30, 2020.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

8 PRELIMINARY PROVISIONS

9 Section 101. Short title.

10 This act shall be known and may be cited as the Appropriation
11 Act of 2019 - State Lottery Fund.

13 STATE LOTTERY FUND APPROPRIATIONS

14 FOR 2019-2020

15 Section 301. Appropriations from State Lottery Fund.

16 The following amounts, or as much thereof as may be
17 necessary, are hereby appropriated from the State Lottery Fund
18 to the departments and for the purposes specified in this part
19 for the fiscal year beginning July 1, 2019, and for the payment

1 of bills incurred and remaining unpaid at the close of the
2 fiscal year ending June 30, 2020.
3 Section 302. Department of Aging.

4 The following amounts are
5 appropriated to the Department of

6 Aging: Federal State

7 For general government
8 operations of the Department of
9 Aging.

11 For PENNCARE for older
12 Pennsylvanians for the purpose of
