## AN ACT

1 2 3 4	Amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in protection from abuse, further providing for relief and providing for shared wireless telephone plans.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Section 6108 of Title 23 of the Pennsylvania
8	Consolidated Statutes is amended by adding a subsection to read:
9	§ 6108. Relief.
10	* * *
11	(i) Shared telephone plans
12	(1) If a plaintiff is a party to a telephone plan
13	contract held by and in the name of the defendant, or a
14	relative of the defendant, in any protection order or consent
15	agreement approved by the court in accordance with subsection
16	(a), the court shall:
17	(i) order the defendant to remove the plaintiff as a

Τ	party to such a telephone plan contract within three
2	<pre>calendar days; and</pre>
3	(ii) order the defendant to pay any surcharge, early
4	termination fee or any other penalty that may incur as a
5	result of removing the plaintiff as a party to the
6	telephone plan contract.
7	(2) Failure to remove the plaintiff from the shared
8	telephone plan shall be subject to the penalties as
9	prescribed in sections 6113 (relating to arrest for violation
10	of order) and 6114 (relating to contempt for violation of
11	order or agreement).
12	(3) As used in this subsection, the following words and
13	phrases shall have the meanings given to them in this
14	paragraph unless the context clearly indicates otherwise:
15	"Shared telephone plan." A package of services offered
16	to subscribers at a set monthly access fee or rate by a
17	telecommunications service provider, including, but not
18	limited to, voice, messaging, data, Internet access and
19	television content under a telephone plan contract.
20	"Telecommunications service provider." A company,
21	including a provider of cable television, that supplies
22	customers with telecommunications services, including land
23	line and wireless telephone services, Internet access, data
24	and the delivery of television content.
25	"Telephone plan contract." A shared telephone plan that
26	allows a customer to share minutes and other services with
27	another individual under one account or contract with a
28	telecommunications service provider, regardless of whether
29	the plan is a shared-minute or family plan contract.
30	Section 2. Title 23 is amended by adding a section to read:

- 1 § 6108.6. Shared telephone plans.
- 2 <u>(a) General rule.--</u>
- 3 (1) A telecommunications service provider shall allow a
- 4 person who is under a telephone plan contract with the
- 5 <u>provider and who is a victim of domestic violence involving</u>
- 6 <u>another person under the same telephone plan contract to opt</u>
- 7 out of the contract without charge. A request to opt out of a
- 8 <u>telephone plan contract shall be in writing and shall include</u>
- 9 any of the following documents, which shall relate to the
- 10 domestic violence:
- 11 <u>(i) A valid police report.</u>
- 12 <u>(ii) A valid protection from abuse order.</u>
- 13 <u>(iii) A signed affidavit from a licensed medical or</u>
- 14 <u>mental health care provider, an employee of a court</u>
- acting within the scope of employment, a social worker, a
- 16 <u>rape crisis counselor, a domestic violence counselor or</u>
- 17 <u>an advocate acting on behalf of an agency that assists</u>
- domestic violence victims.
- 19 (2) A request to opt out of a telephone plan contract
- shall be made in good faith, and the telecommunications
- 21 service provider shall waive the otherwise applicable fees or
- 22 charges for the person requesting to opt out of the contract.
- 23 (3) A person seeking accommodation under this section
- 24 may request, and if requested shall be provided at no
- 25 <u>additional cost to that person, a new telephone number within</u>
- 26 24 hours from the time the request is made.
- 27 (b) Deadline for providing documents.--Any document provided
- 28 to a telecommunications service provider by a person seeking to
- 29 opt out of a telephone plan contract in accordance with
- 30 subsection (a) must be:

- 1 (1) provided to the telecommunications service provider
- 2 at the time the request to opt out is made;
- 3 (2) issued no more than six months before the opt-out
- 4 <u>request.</u>
- 5 (c) Retention and confidentiality of documents. -- A
- 6 <u>telecommunications service provider that receives a written</u>
- 7 request accompanied by the necessary documentation to opt out of
- 8 <u>a telephone plan contract in accordance with this section may</u>
- 9 retain the documentation or return it to the person seeking to
- 10 opt out. Any documentation provided to a telecommunications
- 11 service provider by a victim of domestic violence shall be
- 12 considered confidential communications and, if retained by a
- 13 <u>telecommunications service provider</u>, shall be subject to the
- 14 <u>confidentiality requirements under Federal or State law.</u>
- 15 (d) Applicability. -- This section shall apply to telephone
- 16 plan contracts entered into on or after the effective date of
- 17 this section.
- 18 (e) Definitions.--For the purposes of this section, the
- 19 terms "telecommunications service provider" and "telephone plan
- 20 contract" shall have the meanings given to them in section
- 21 6108(i)(3) (relating to relief).
- 22 Section 3. This act shall take effect as follows:
- 23 (1) The addition of 23 Pa.C.S. § 6108(i) shall take
- 24 effect immediately.
- 25 (2) This section shall take effect immediately.
- 26 (3) The remainder of this act shall take effect in 60
- 27 days.
