## AN ACT

7	Section 1. Section 2710 heading, (a) and (c) of Title 18 of
8	the Pennsylvania Consolidated Statutes are amended to read:
9	§ 2710. [Ethnic] <u>Hate-based</u> intimidation.
10	(a) Offense definedA person commits the offense of
11	[ethnic] <u>hate-based</u> intimidation if, with malicious intention
12	toward the race, color, religion [or], national origin <u>or</u>
13	intellectual or physical disability of another individual or
14	group of individuals, he commits an offense under any other
15	provision of this article or under Chapter 33 (relating to
16	arson, criminal mischief and other property destruction)
17	exclusive of section 3307 (relating to institutional vandalism)
18	or under section 3503 (relating to criminal trespass) with

respect to such individual or his or her property or with
 respect to one or more members of such group or to their
 property.

5 (c) Definition.--As used in this section "malicious 6 intention" means the intention to commit any act, the commission of which is a necessary element of any offense referred to in 7 8 subsection (a) motivated by hatred toward the race, color, religion [or], national origin or intellectual or physical 9 10 disability of another individual or group of individuals. Section 2. Section 8309(a) of Title 42 is amended to read: 11 12 § 8309. Civil rights violations.

13 (a) Redress for personal injury.--A person who incurs injury 14 to his person or damage or loss to his property as a result of 15 conduct described in 18 Pa.C.S. § 2710 (relating to [ethnic] 16 hate-based intimidation) or 3307 (relating to institutional vandalism) shall have a right of action against the actor for 17 18 injunction, damages or other appropriate civil or equitable 19 relief. In the action, the issue of whether the defendant 20 engaged in the conduct alleged shall be determined according to 21 the burden of proof used in other civil actions for similar relief. The plaintiff may seek recovery for any of the 22 23 following:

(1) General and special damages, including damages for
emotional distress. Damages under this paragraph shall be
actual damages or \$500, whichever is greater.

(2) Punitive damages.

28 (3) Reasonable attorney fees and costs.
