INTRODUCED BY MARKOSEK, MAY 11, 2015

AS REPORTED FROM COMMITTEE ON APPROPRIATIONS, HOUSE OF REPRESENTATIVES, AS AMENDED, JUNE 23, 2015

AN ACT

1 Making appropriations from the Professional Licensure
2 Augmentation Account and from restricted revenue accounts
3 within the General Fund to the Department of State for use by
4 the Bureau of Professional and Occupational Affairs in
5 support of the professional licensure boards assigned
6 thereto.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. The sum of ~~\$41,861,000~~, \$43,946,000, or as much <--
10 thereof as may be necessary, is hereby appropriated from the
11 Professional Licensure Augmentation Account within the General
12 Fund to the Department of State for the operation of the Bureau
13 of Professional and Occupational Affairs, including the State
14 Board of Auctioneer Examiners, for the fiscal year July 1, 2015,
15 to June 30, 2016.

16 Section 2. (a) The sum of ~~\$7,975,000~~, \$8,184,000, or as <--
17 much thereof as may be necessary, is hereby appropriated from
18 the restricted receipts account of the State Board of Medicine
19 for the operation of the board for the fiscal year July 1, 2015,
20 to June 30, 2016.

1       (b) The sum of ~~\$1,323,000~~, \$1,523,000, or as much thereof as <--  
2 may be necessary, is hereby appropriated from the restricted  
3 receipts account of the State Board of Osteopathic Medicine for  
4 the operation of the board for the fiscal year July 1, 2015, to  
5 June 30, 2016.

6       (c) The sum of ~~\$238,000~~, \$245,000, or as much thereof as may <--  
7 be necessary, is hereby appropriated from the restricted  
8 receipts account of the State Board of Podiatry for the  
9 operation of said board for the fiscal year July 1, 2015, to  
10 June 30, 2016.

11       (d) The sum of \$560,000, or as much thereof as may be  
12 necessary, is hereby appropriated from the Athletic Commission  
13 Augmentation Account for the State Athletic Commission, as  
14 authorized by 5 Pa.C.S. § 1512 (relating to Athletic Commission  
15 Augmentation Account), for the support and operation of the  
16 commission for the fiscal year July 1, 2015, to June 30, 2016.

17       (e) Each appropriation listed in subsections (a), (b), (c)  
18 and (d) shall not be treated as an augmentation to the  
19 Department of State, general government appropriation or any  
20 other appropriation, but shall be treated and accounted for as  
21 separate appropriations respectively.

22       Section 3. This act shall take effect July 1, 2015, or  
23 immediately, whichever is later.
