AN ACT

1 Designating a bridge that carries State Route 153 over the
2 Bennett Branch in Huston Township, Clearfield County, as the
3 Huston Township Veterans Memorial Bridge; ~~and~~ designating <--
4 U.S. Route 219 in Johnsonburg Borough, Elk County, from the
5 intersection of State Route 1009, Center Street, starting at
6 roadway segment 0502 offset 0000 to the intersection of State
7 Route 1009, Center Street, ending at roadway segment 0522
8 offset 1159, as the Veterans of Johnsonburg Bypass-; <--
9 DESIGNATING A PORTION OF PENNSYLVANIA ROUTE 1001 BETWEEN
10 RHAWN STREET, 0100/0000 AND KENDRICK STREET, 0100/2784 IN THE
11 CITY OF PHILADELPHIA, PHILADELPHIA COUNTY, AS THE FIREFIGHTER
12 DANIEL SWEENEY MEMORIAL HIGHWAY; DESIGNATING A PORTION OF
13 PENNSYLVANIA ROUTE 611 BETWEEN MAPLE AVENUE AND MEETINGHOUSE
14 ROAD, IN MONTGOMERY COUNTY, AS THE LIEUTENANT JOSEPH C. PARK
15 II MEMORIAL HIGHWAY; DESIGNATING A PORTION OF STATE ROUTE 272
16 IN LANCASTER COUNTY, SOUTH OF STATE ROUTE 372 AND BEFORE
17 OSCEOLA ROAD, AS THE STAFF SERGEANT KEITH A. BENNETT MEMORIAL <--
18 HIGHWAY; ~~AND~~ DESIGNATING A PORTION OF U.S. ROUTE 1, CITY <--
19 AVENUE IN PHILADELPHIA AND MONTGOMERY COUNTIES FROM ITS
20 INTERSECTION WITH PRESIDENTIAL BOULEVARD TO ITS INTERSECTION
21 WITH MONUMENT ROAD AS ED BRADLEY WAY-; PROVIDING FOR THE <--
22 REDESIGNATION OF THE EASTON-PHILLIPSBURG TOLL BRIDGE OPERATED
23 BY THE DELAWARE RIVER JOINT TOLL BRIDGE COMMISSION AS THE
24 SERGEANT WILLIAM JOHN CAHIR MEMORIAL BRIDGE; DESIGNATING A
25 PORTION OF PA ROUTE 191 IN WASHINGTON TOWNSHIP, NORTHAMPTON
26 COUNTY, AS THE "WORLD WAR II HOMEFRONT HEROES HIGHWAY";
27 RENAMING THE HOKENDAUQUA BRIDGE IN LEHIGH COUNTY AS THE
28 LIEUTENANT COLONEL THOMAS J. LYNCH MEMORIAL BRIDGE; RENAMING

1 THE MAIN STREET BRIDGE IN BROCKWAY BOROUGH, JEFFERSON COUNTY,
2 AS THE ENSIGN USN CONNIE RITA ESPOSITO MEMORIAL BRIDGE;
3 DESIGNATING A BRIDGE CARRYING STATE ROUTE 1008 KNOWN AS
4 POMPEY HILL ROAD, OVER THE STONYCREEK RIVER IN QUEMAHONING
5 AND STONYCREEK TOWNSHIPS, SOMERSET COUNTY, AS THE PRIVATE
6 JOHN W. MOSTOLLER BRIDGE; ~~AND~~ DESIGNATING A BRIDGE ON THAT <--
7 PORTION OF STATE ROUTE 271 OVER THE SOUTH BRANCH BLACKLICK
8 CREEK, NANTY GLO BOROUGH, CAMBRIA COUNTY, AS THE PLATOON
9 SERGEANT ALFRED MCCULLOUGH MEMORIAL BRIDGE-; ~~AND~~ DESIGNATING <--
10 A BRIDGE ON THAT PORTION OF STATE ROUTE 181 OVER THE CONEWAGO
11 CREEK, BETWEEN NEWBERRY TOWNSHIP AND EAST MANCHESTER
12 TOWNSHIP, YORK COUNTY, AS THE SP4 RANDY STEPHEN SCHELL
13 MEMORIAL BRIDGE-; AND DESIGNATING A PORTION OF PENNSYLVANIA <--
14 ROUTE 144 IN CENTRE COUNTY AS THE PFC DONALD RAY LUCAS
15 MEMORIAL HIGHWAY.

16 The General Assembly of the Commonwealth of Pennsylvania
17 hereby enacts as follows:

18 Section 1. Huston Township Veterans Memorial Bridge.

19 (a) Findings.--

20 (1) Huston Township, Clearfield County, has been home to
21 many valiant military veterans who have given their lives in
22 defense of the United States.

23 (2) The elected Board of Supervisors of Huston Township
24 has endorsed designating this bridge in honor of those
25 township residents who have made the ultimate sacrifice for
26 our nation over the years.

27 (b) Designation.--The bridge that carries State Route 153
28 over the Bennett Branch in Huston Township, Clearfield County,
29 is hereby designated as the Huston Township Veterans Memorial
30 Bridge.

31 (c) Signs.--The Department of Transportation shall erect and
32 maintain appropriate signs displaying the name of the bridge to
33 traffic in both directions on the bridge.

34 Section 2. Veterans of Johnsonburg Bypass.

35 (a) Findings.--The General Assembly finds and declares that
36 the Borough of Johnsonburg has been home through the years to
37 veterans, both living and deceased, who have served our nation

1 valiantly.

2 (b) Designation.--U.S. Route 219 in Johnsonburg Borough, Elk
3 County, from the intersection of State Route 1009, Center
4 Street, starting at roadway segment 0502 offset 0000 to the
5 intersection of State Route 1009, Center Street, ending at
6 roadway segment 0522 offset 1159, is hereby designated as the
7 Veterans of Johnsonburg Bypass.

8 (c) Signs.--The Department of Transportation shall erect and
9 maintain appropriate signs displaying the name of the highway to
10 traffic in both directions.

11 SECTION 3. FIREFIGHTER DANIEL SWEENEY MEMORIAL HIGHWAY. <--

12 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AS FOLLOWS:

13 (1) FIREFIGHTER DANIEL SWEENEY WAS A MEMBER OF LADDER 10
14 FIRE COMPANY AND RESIDED AT TABOR AND FULLER IN THE HEART OF
15 FOX CHASE IN THE NEIGHBORHOOD WHERE HIS PARENTS RESIDE.

16 (2) MR. SWEENEY MADE THE ULTIMATE SACRIFICE ON MONDAY,
17 APRIL 9, 2012, WHILE FIGHTING A FIVE-ALARM FIRE IN
18 KENSINGTON. IN THE FIRE, HE LOST HIS LIFE AS A RESULT OF A
19 COLLAPSING WALL AND ROOF. HE DEMONSTRATED TRUE COURAGE AND
20 HEROISM WHILE IN THE LINE OF DUTY.

21 (3) MR. SWEENEY IS SURVIVED BY HIS FATHER, DAVID, WHO IS
22 A RETIRED FIRE CAPTAIN, HIS MOTHER, MARIAN, HIS THREE
23 SISTERS, SUZANNE SWEDLIGE, SARAH SWEENEY AND DEBORAH SWEENEY,
24 HIS BROTHER-IN-LAW, DAVID SWEDLIGE AND HIS NIECE AND
25 GODCHILD, STACEY SWEDLIGE.

26 (B) DESIGNATION.--THE SECTION OF PENNSYLVANIA ROUTE 1001
27 BETWEEN RHAWN STREET, 0100/0000 AND KENDRICK STREET, 0100/2784
28 IN THE CITY OF PHILADELPHIA, PHILADELPHIA COUNTY, IS HEREBY
29 DESIGNATED THE FIREFIGHTER DANIEL SWEENEY MEMORIAL HIGHWAY.

30 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

1 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO
2 TRAFFIC IN BOTH DIRECTIONS ON THE HIGHWAY.

3 SECTION 4. LIEUTENANT JOSEPH C. PARK II MEMORIAL HIGHWAY.

4 (A) FINDINGS.--

5 (1) LT. PARK WAS BORN AUGUST 31, 1946, AND LIVED IN
6 HORSHAM, PENNSYLVANIA.

7 (2) LT. PARK ATTENDED HATBORO-HORSHAM HIGH SCHOOL AND
8 VALLEY FORGE MILITARY ACADEMY BEFORE BRIEFLY ATTENDING THE
9 PENNSYLVANIA STATE UNIVERSITY.

10 (3) LT. PARK WAS A MEMBER OF THE POLO TEAM AT THE VALLEY
11 FORGE MILITARY ACADEMY AND ATTAINED THE RANK OF EAGLE SCOUT.

12 (4) LT. PARK PROUDLY AND COURAGEOUSLY SERVED IN THE
13 UNITED STATES ARMY DURING THE VIETNAM WAR.

14 (5) LT. PARK WAS KILLED IN VIETNAM ON MARCH 28, 1968,
15 FROM A HOSTILE GUNSHOT WOUND.

16 (6) LT. PARK WAS AWARDED THE PURPLE HEART, NATIONAL
17 DEFENSE MEDAL, AND REPUBLIC OF VIETNAM SERVICE MEDAL FOR HIS
18 MILITARY SERVICE.

19 (B) DESIGNATION.--THE PORTION OF PENNSYLVANIA ROUTE 611 IN
20 MONTGOMERY COUNTY, BETWEEN MAPLE AVENUE AND MEETINGHOUSE ROAD,
21 IS HEREBY DESIGNATED AS THE LIEUTENANT JOSEPH C. PARK II
22 MEMORIAL HIGHWAY.

23 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
24 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO
25 TRAFFIC IN BOTH DIRECTIONS ON THE HIGHWAY.

26 SECTION 5. STAFF SERGEANT KEITH A. BENNETT MEMORIAL HIGHWAY. <--

27 (A) FINDINGS AND DECLARATIONS.--THE GENERAL ASSEMBLY FINDS
28 AND DECLARES:

29 (1) STAFF SERGEANT KEITH A. BENNETT WAS A PROUD 1991
30 GRADUATE OF SOLANCO HIGH SCHOOL.

1 (2) AS A MEMBER OF THE PENNSYLVANIA NATIONAL GUARD,
2 STAFF SERGEANT BENNETT WAS KILLED IN ACTION IN IRAQ ON
3 DECEMBER 11, 2005.

4 (B) DESIGNATION.--THE SECTION OF STATE ROUTE 272 IN
5 LANCASTER COUNTY, SOUTH OF STATE ROUTE 372 AND BEFORE OSCEOLA
6 ROAD, IS HEREBY DESIGNATED THE STAFF SERGEANT KEITH A. BENNETT
7 MEMORIAL HIGHWAY. <--

8 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
9 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO
10 TRAFFIC IN BOTH DIRECTIONS ON THE HIGHWAY.
11 SECTION 6. ED BRADLEY WAY.

12 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
13 FOLLOWS:

14 (1) MR. ED BRADLEY WAS BORN IN PHILADELPHIA AND
15 GRADUATED FROM SAINT THOMAS MORE CATHOLIC BOYS HIGH SCHOOL IN
16 WEST PHILADELPHIA IN 1959.

17 (2) MR. BRADLEY GRADUATED FROM CHEYNEY STATE COLLEGE,
18 NOW CHEYNEY UNIVERSITY, IN 1964 WITH A DEGREE IN EDUCATION
19 AND HIS FIRST JOB WAS TEACHING SIXTH GRADE AT WILLIAM B. MANN
20 ELEMENTARY SCHOOL IN PHILADELPHIA.

21 (3) MR. BRADLEY STARTED REPORTING THE NEWS AT WDAS-FM
22 AND, IN 1971, THIS LED HIM TO A FULL-TIME JOB AT WCBS IN NEW
23 YORK.

24 (4) IN 1972, MR. BRADLEY VOLUNTEERED TO BE TRANSFERRED
25 TO SAIGON TO COVER THE VIETNAM WAR IN VIETNAM AND CAMBODIA,
26 WHERE HE WAS INJURED BY A MORTAR ROUND.

27 (5) IN 1976, MR. BRADLEY BECAME THE FIRST AFRICAN-
28 AMERICAN WHITE HOUSE TELEVISION CORRESPONDENT FOR CBS NEWS.

29 (6) IN 1981, MR. BRADLEY JOINED THE TELEVISION PROGRAM
30 60 MINUTES, WHERE, OVER THE COURSE OF HIS 26 YEARS ON THE

1 PROGRAM, HE DID OVER 500 STORIES.

2 (7) MR. BRADLEY ALSO HOSTED THE PEABODY AWARD-WINNING
3 PROGRAM "JAZZ AT LINCOLN CENTER" ON NATIONAL PUBLIC RADIO FOR
4 MORE THAN TEN YEARS, UNTIL HIS DEATH IN 2006.

5 (B) DESIGNATION.--THE PORTION OF U.S. ROUTE 1, CITY AVENUE
6 IN PHILADELPHIA AND MONTGOMERY COUNTIES FROM ITS INTERSECTION
7 WITH PRESIDENTIAL BOULEVARD TO ITS INTERSECTION WITH MONUMENT
8 ROAD IS HEREBY DESIGNATED AS ED BRADLEY WAY.

9 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
10 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO
11 TRAFFIC IN BOTH DIRECTIONS.

12 SECTION 7. SERGEANT WILLIAM JOHN CAHIR MEMORIAL BRIDGE. <--

13 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES THAT:

14 (1) WILLIAM JOHN CAHIR, A GRADUATE OF THE PENNSYLVANIA
15 STATE UNIVERSITY, WORKED AS A NEWSPAPER CORRESPONDENT FOR THE
16 EXPRESS-TIMES, PROVIDING NEWS COVERAGE TO WARREN AND
17 HUNTERDON COUNTIES IN NEW JERSEY AND LEHIGH AND NORTHAMPTON
18 COUNTIES IN PENNSYLVANIA, AND FOR NEWHOUSE NEWS SERVICE,
19 DURING WHICH TIME HIS WORK REGULARLY APPEARED IN NUMEROUS NEW
20 JERSEY-BASED NEWSPAPERS; AND

21 (2) THROUGHOUT HIS LIFE, WILLIAM CAHIR WAS COMMITTED TO
22 PUBLIC SERVICE, WORKING FOR UNITED STATES SENATOR EDWARD
23 KENNEDY AND UNITED STATES SENATOR HARRIS WOFFORD, AND RUNNING
24 FOR THE CONGRESS OF THE UNITED STATES IN PENNSYLVANIA'S 5TH
25 CONGRESSIONAL DISTRICT IN 2008; AND

26 (3) AFTER THE TERRORIST ATTACKS AGAINST THE UNITED
27 STATES ON SEPTEMBER 11, 2001, WILLIAM CAHIR ENLISTED IN THE
28 UNITED STATES MARINE CORPS RESERVE AT THE AGE OF 34, WHERE HE
29 WENT TO GREAT LENGTHS TO OBTAIN AN AGE WAIVER AND EVENTUALLY
30 ROSE TO THE RANK OF SERGEANT; AND

1 (4) SERGEANT CAHIR WAS ASSIGNED TO THE 4TH CIVIL AFFAIRS
2 GROUP, MARINE FORCES RESERVE BASED IN WASHINGTON, D.C.,
3 COMPLETED TWO TOURS IN IRAQ AND, IN 2009, WAS DEPLOYED FOR A
4 TOUR IN AFGHANISTAN TO SUPPORT OPERATION ENDURING FREEDOM;
5 AND

6 (5) ON AUGUST 13, 2009, WHILE COMPLETING HIS THIRD TOUR,
7 SERGEANT CAHIR WAS TRAGICALLY SHOT AND KILLED BY ENEMY FIRE
8 WHILE ON A DISMOUNTED PATROL DURING EASTERN RESOLVE II, A
9 PREDAWN OFFENSIVE OPERATION IN HELMAND PROVINCE, AFGHANISTAN,
10 THAT WAS INTENDED TO CUT TALIBAN TRADE AND SUPPLY LINES IN
11 ORDER TO ALLOW LOCAL RESIDENTS TO VOTE IN THE AFGHAN
12 PRESIDENTIAL ELECTION; AND

13 (6) FOR HIS HEROISM, SERGEANT CAHIR RECEIVED THE BRONZE
14 STAR, THE PURPLE HEART AND OTHER DECORATIONS; AND

15 (7) SERGEANT CAHIR IS SURVIVED BY HIS WIFE, RENE, WHO AT
16 THE TIME OF HIS DEATH WAS PREGNANT WITH THEIR TWIN DAUGHTERS,
17 CAROLINE AND ELIZABETH; AND

18 (8) THE EASTON-PHILLIPSBURG TOLL BRIDGE, OPERATED BY THE
19 DELAWARE RIVER JOINT TOLL BRIDGE COMMISSION, CONNECTS THE
20 COUNTIES IN NEW JERSEY AND PENNSYLVANIA THAT WERE SERVED BY
21 THE NEWSPAPER FOR WHICH SERGEANT CAHIR REPORTED; AND

22 (9) IT IS ALTOGETHER FITTING AND PROPER FOR THE
23 COMMONWEALTH OF PENNSYLVANIA TO HONOR THE LIFE AND SACRIFICE
24 OF SERGEANT WILLIAM JOHN CAHIR BY DESIGNATING THE U.S. ROUTE
25 22 BRIDGE OVER THE DELAWARE RIVER BETWEEN EASTON,
26 PENNSYLVANIA, AND PHILLIPSBURG, NEW JERSEY, KNOWN AS THE
27 EASTON-PHILLIPSBURG TOLL BRIDGE, AS THE "SERGEANT WILLIAM
28 JOHN CAHIR MEMORIAL BRIDGE."

29 (B) REDESIGNATION.--THE EXECUTIVE DIRECTOR OF THE DELAWARE
30 RIVER JOINT TOLL BRIDGE COMMISSION SHALL DESIGNATE THE U.S.

1 ROUTE 22 BRIDGE CROSSING THE DELAWARE RIVER BETWEEN EASTON,
2 PENNSYLVANIA, AND PHILLIPSBURG, NEW JERSEY, KNOWN AS THE EASTON-
3 PHILLIPSBURG TOLL BRIDGE, AS THE "SERGEANT WILLIAM JOHN CAHIR
4 MEMORIAL BRIDGE" AND ERECT APPROPRIATE SIGNS BEARING THIS NAME.

5 (C) PROHIBITION.--NO STATE OR OTHER PUBLIC FUNDS SHALL BE
6 USED FOR PRODUCING, PURCHASING OR ERECTING SIGNS BEARING THE
7 DESIGNATION ESTABLISHED PURSUANT TO SUBSECTION (B).

8 SECTION 8. PUBLICATION.

9 THE SECRETARY OF THE COMMONWEALTH SHALL PUBLISH A NOTICE IN
10 THE PENNSYLVANIA BULLETIN WHEN THE GENERAL ASSEMBLY OF THE STATE
11 OF NEW JERSEY ENACTS A LAW DESIGNATING THE BRIDGE DESCRIBED IN
12 SECTION 7 AS THE "SERGEANT WILLIAM JOHN CAHIR MEMORIAL BRIDGE."

13 SECTION 9. WORLD WAR II HOMEFRONT HEROES HIGHWAY.

14 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
15 FOLLOWS:

16 (1) THE DEDICATION OF THE AMERICAN PEOPLE DURING WORLD
17 WAR II WAS CRUCIAL IN SUPPLYING AND AIDING BOTH AMERICAN AND
18 ALLIED FORCES ENGAGED IN BATTLE ON TWO GLOBAL THEATERS.

19 (2) THE AMERICAN CITIZENS AT HOME SACRIFICED BY
20 RATIONING MATERIALS, RECYCLING GOODS, PURCHASING WAR BONDS,
21 AND TIRELESSLY WORKING LONGER HOURS IN FACTORIES, MINES,
22 MILLS, FARMS AND MANY OTHER INDUSTRIES TO KEEP THE WAR EFFORT
23 MOVING FORWARD.

24 (3) WITH MANY YOUNG MEN SERVING IN THE ARMED FORCES,
25 AMERICAN WOMEN WERE QUICK TO STEP UP AND TAKE JOBS IN
26 INDUSTRIES THAT WERE CONSIDERED RESERVED FOR MEN ONLY, AND
27 SUBSEQUENTLY MADE "ROSIE THE RIVETER" A POPULAR, AND NOW
28 CLASSIC, AMERICAN ICON.

29 (4) CIVILIAN SUPPORT FOR THE ARMED FORCES AND DEFENSE OF
30 THE NATION SPURRED THE ESTABLISHMENT OF NUMEROUS GROUPS AND

1 ORGANIZATIONS SUCH AS THE CIVIL AIR PATROL, COAST GUARD
2 AUXILIARY AND UNITED SERVICE ORGANIZATIONS (USO), WHICH EXIST
3 TO THIS DAY.

4 (5) THROUGH THEIR STEADFAST DEDICATION AND SUPPORT,
5 UNITED STATES CITIZENS AT HOME WERE ABLE TO KEEP AMERICAN AND
6 ALLIED FORCES SUPPLIED WITH MATERIALS AND MORALE, WHICH WAS
7 INSTRUMENTAL IN ACHIEVING VICTORY AND ENDING ONE OF THE
8 DEADLIEST WARS IN THE HISTORY OF HUMAN EXISTENCE.

9 (B) DESIGNATION.--THAT PORTION OF PA ROUTE 191 IN WASHINGTON
10 TOWNSHIP, NORTHAMPTON COUNTY, FROM THE BANGOR BOROUGH LINE TO
11 THE PLAINFIELD TOWNSHIP LINE IS HEREBY DESIGNATED AS THE "WORLD
12 WAR II HOMEFRONT HEROES HIGHWAY."

13 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
14 MAINTAIN SIGNS TO TRAFFIC IN BOTH DIRECTIONS TO INDICATE THE
15 DESIGNATION UNDER SUBSECTION (B).

16 SECTION 10. LIEUTENANT COLONEL THOMAS J. LYNCH MEMORIAL BRIDGE.

17 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES THAT:

18 (1) LIEUTENANT COLONEL (LT. COL.) THOMAS J. LYNCH WAS
19 BORN IN CATASAUQUA, PENNSYLVANIA, ON DECEMBER 9, 1916.

20 (2) LT. COL. THOMAS J. LYNCH SERVED OUR COUNTRY IN THE
21 UNITED STATES ARMY AIR CORPS DURING WORLD WAR II.

22 (3) LT. COL. THOMAS J. LYNCH SHOT DOWN 20 JAPANESE
23 PLANES DURING HIS SERVICE OVER THE PACIFIC OCEAN AND WAS ONE
24 OF THE TOP THREE FIGHTER ACES IN WORLD WAR II BEFORE HE WAS
25 SHOT DOWN WHILE ATTACKING A NUMBER OF ENEMY BARGES

14 ESPOSITO WAS KILLED WHEN THE MILITARY TRANSPORT PLANE SHE WAS
15 ON CRASHED INTO THE PACIFIC OCEAN WHILE ENROUTE TO THE UNITED
16 STATES NAVAL HOSPITAL IN YOKOSUKA, JAPAN. THE AIRCRAFT
17 CRASHED AND EXPLODED SHORTLY AFTER TAKING OFF FROM KWAJALEIN
18 ISLAND. ALL 26 NAVAL PERSONNEL ON BOARD LOST THEIR LIVES IN

5 (2) PRIVATE MOSTOLLER SERVED IN THE UNION ARMY FROM 1861
6 TO 1864, BY REASON OF MUSTER OUT OF COMPANY WHILE HOLDING THE
7 GRADE OF PRIVATE, IN COMPANY B, FIFTY-FOURTH REGIMENT OF
8 PENNSYLVANIA INFANTRY VOLUNTEERS.

9 (3) PRIVATE MOSTOLLER RECEIVED A MEDAL OF HONOR ON
10 NOVEMBER 27, 1894, FOR MOST DISTINGUISHED GALLANTRY AT THE
11 BATTLE OF LYNCHBURG, VIRGINIA.

12 (4) WHEN THE OFFICERS OF HIS COMPANY WERE ABSENT OR
13 DISABLED, PRIVATE MOSTOLLER VOLUNTARILY LED A CHARGE UPON A
14 CONFEDERATE BATTERY.

15 (5) HIS NAME WAS ENTERED AND RECORDED ON THE ARMY AND
16 NAVY MEDAL OF HONOR ROLL ON JUNE 10, 1916.

17 (6) PRIVATE MOSTOLLER WAS A GUEST OF THE WAR DEPARTMENT
18 AT THE ENTOMBMENT OF THE UNKNOWN SOLDIER IN ARLINGTON
19 NATIONAL CEMETERY, WHEN HE PARTICIPATED ALONG WITH A NUMBER
20 OF OTHER VETERANS OF THE CIVIL WAR FROM OTHER STATES.

21 (7) THE CONGRESSIONAL MEDAL OF HONOR AWARDED TO PRIVATE
22 MOSTOLLER DURING THE CIVIL WAR WAS PRESENTED TO SOMERSET
23 COUNTY AND IS DISPLAYED INSIDE THE UNION STREET ENTRANCE TO
24 THE SOMERSET COUNTY COURTHOUSE. IT IS THE ONLY CONGRESSIONAL
25 MEDAL OF HONOR WON BY A SOMERSET COUNTY SOLDIER IN THE CIVIL
26 WAR.

27 (8) PRIVATE MOSTOLLER, BELOVED SON OF JOSEPH AND SARAH
28 (MOWRY) MOSTOLLER COURAGEOUSLY SERVED HIS COUNTRY AND HAS
29 BEEN EXTOLLED BY MANY FOR HIS BRAVERY AND SERVICE.

30 (B) DESIGNATION.--STATE ROUTE 1008, KNOWN AS POMPEY HILL

1 ROAD OVER THE STONYCREEK RIVER IN QUEMAHONING AND STONYCREEK
2 TOWNSHIPS, SOMERSET COUNTY, IS HEREBY DESIGNATED AS THE PRIVATE
3 JOHN W. MOSTOLLER MEMORIAL BRIDGE.

4 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
5 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION UNDER

7 SECTION 13. PLATOON SERGEANT ALFRED MCCULLOUGH MEMORIAL BRIDGE.

9 (1) PLATOON SERGEANT ALFRED MCCULLOUGH WAS BORN IN NANTY
10 GLO, PENNSYLVANIA, ON APRIL 2, 1935, AND GRADUATED FROM NANTY
11 GLO HIGH SCHOOL, NOW BLACKLICK VALLEY HIGH SCHOOL, IN 1954.

12 (2) SERGEANT MCCULLOUGH SERVED OUR COUNTRY IN THE UNITED
13 STATES ARMY AND WAS KILLED IN ACTION IN VIETNAM ON JUNE 6,
14 1968.

15 (3) SERGEANT MCCULLOUGH RECEIVED THE SILVER STAR
16 POSTHUMOUSLY FOR HIS ACTIONS ON MAY 13, 1968, AS ACTING
17 PLATOON LEADER DURING A RECONNAISSANCE MISSION IN WHICH HIS
18 SQUADRON CAME UNDER AUTOMATIC WEAPON AND ANTITANK ROCKET FIRE
19 FROM A HEAVILY FORTIFIED ENEMY POSITION. SERGEANT MCCULLOUGH
20 MOVED HIS PLATOON INTO AN ASSAULT POSITION AND LAUNCHED AN
21 EFFECTIVE COUNTERSTRIKE, OVERRUNNING THE ENEMY'S POSITIONS
22 AND LEADING AN ASSAULT ON THE REMAINING ENEMY ROCKET FIRE

12 (3) ON JUNE 18, 1968, IN A DISPLAY OF SELFLESS COURAGE
13 DURING AN ATTACK BY THE VIET CONG, SP4 SCHELL MOVED INTO AN
14 AREA UNDER ENEMY ASSAULT AND ADMINISTERED FIRST AID TO
15 SEVERAL WOUNDED COMRADES. AFTER DRAGGING HIS FELLOW SOLDIERS
16 TO SAFETY, SP4 SCHELL DISREGARDED THE GREAT PERSONAL RISK AND
17 RETURNED TO SEARCH FOR INJURED SOLDIERS WHEN HE WAS MORTALLY

11 (4) ON JANUARY 12, 1969, PFC LUCAS MADE THE ULTIMATE
