- 1 Amending Title 62 (Procurement) of the Pennsylvania Consolidated
- Statutes, in general provisions, further providing for
- definitions and providing for charging Internet convenience
- 4 fee.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 103 of Title 62 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a definition to read:
- 9 § 103. Definitions.
- 10 Subject to additional definitions contained in subsequent
- 11 provisions of this part which are applicable to specific
- 12 provisions of this part, the following words and phrases when
- 13 used in this part shall have the meanings given to them in this
- 14 section unless the context clearly indicates otherwise:
- 15 * * *
- 16 <u>"Internet convenience fee." An additional fee for an online</u>
- 17 transaction of an executive agency, including, but not limited

- 1 to, a fee for ordering an online search or an online filing of
- 2 any application, license, permit, registration or form, if the
- 3 fee is separate from and in addition to the fee for the same
- 4 search, application, license, permit, registration or form when
- 5 the transaction is made in person or by mail. The term shall
- 6 <u>also include any additional online fee for a person to use a</u>
- 7 <u>credit card, debit card or electronic transfer from a checking</u>
- 8 account in paying for an online search or an online filing of
- 9 any application, license, permit, registration or form.

- 11 Section 2. Title 62 is amended by adding a section to read:
- 12 § 109. Internet convenience fee.
- No contract pursuant to this title shall authorize and no
- 14 <u>executive agency is permitted to establish any Internet</u>
- 15 convenience fee without specific authorization from the General
- 16 Assembly. This limitation shall not preclude any type of credit
- 17 card or debit card processing fee for the payment of any type of
- 18 tax or fee to the Department of Revenue or the Pennsylvania
- 19 Public Utility Commission or for the payment of any fine or
- 20 penalty to an executive agency.
- 21 Section 3. This act shall take effect in 60 days.
