## AN ACT

1 Authorizing the Commonwealth of Pennsylvania to join the

Agreement Among the States to Elect the President by National

Popular Vote; and providing for the form of the agreement.

- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Agreement
- 8 Among the States to Elect the President by National Popular Vote
- 9 Act.

- 10 Section 2. Text of agreement.
- 11 The Agreement Among the States to Elect the President by
- 12 National Popular Vote is enacted into law and entered into with
- 13 all other signatory jurisdictions in substantially the following
- 14 form:
- 15 ARTICLE I
- 16 MEMBERSHIP
- 17 Any state of the United States and the District of Columbia

- 1 may become a member of this agreement by enacting this
- 2 agreement.
- 3 ARTICLE II
- 4 RIGHT OF THE PEOPLE IN MEMBER STATES TO VOTE
- 5 FOR PRESIDENT AND VICE PRESIDENT
- 6 Each member state shall conduct a statewide popular election
- 7 for President and Vice President of the United States.
- 8 ARTICLE III
- 9 MANNER OF APPOINTING PRESIDENTIAL ELECTORS IN MEMBER STATES
- 10 Prior to the time set by law for the meeting and voting by
- 11 the presidential electors, the chief election official of each
- 12 member state shall determine the number of votes for each
- 13 presidential slate in each state of the United States and in the
- 14 District of Columbia in which votes have been cast in a
- 15 statewide popular election and shall add such votes together to
- 16 produce a "national popular vote total" for each presidential
- 17 slate.
- 18 The chief election official of each member state shall
- 19 designate the presidential slate with the largest national
- 20 popular vote total as the "national popular vote winner."
- 21 The presidential elector certifying official of each member
- 22 state shall certify the appointment in that official's own state
- 23 of the elector slate nominated in that state in association with
- 24 the national popular vote winner.
- 25 At least six days before the day fixed by law for the meeting
- 26 and voting by the presidential electors, each member state shall
- 27 make a final determination of the number of popular votes cast
- 28 in the state for each presidential slate and shall communicate
- 29 an official statement of such determination within 24 hours to
- 30 the chief election official of each other member state.

- 1 The chief election official of each member state shall treat
- 2 as conclusive an official statement containing the number of
- 3 popular votes in a state for each presidential slate made by the
- 4 day established by Federal law for making a state's final
- 5 determination as to the counting of electoral votes by Congress.
- In event of a tie for the national popular vote winner, the
- 7 presidential elector certifying official of each member state
- 8 shall certify the appointment of the elector slate nominated in
- 9 association with the presidential slate receiving the largest
- 10 number of popular votes within that official's own state.
- 11 If, for any reason, the number of presidential electors
- 12 nominated in a member state in association with the national
- 13 popular vote winner is less than or greater than that state's
- 14 number of electoral votes, the presidential candidate on the
- 15 presidential slate that has been designated as the national
- 16 popular vote winner shall have the power to nominate the
- 17 presidential electors for that state and that state's
- 18 presidential elector certifying official shall certify the
- 19 appointment of such nominees.
- The chief election official of each member state shall
- 21 immediately release to the public all vote counts or statements
- 22 of votes as they are determined or obtained.
- 23 This article shall govern the appointment of presidential
- 24 electors in each member state in any year in which this
- 25 agreement is, on July 20, in effect in states cumulatively
- 26 possessing a majority of the electoral votes.
- 27 ARTICLE IV
- 28 OTHER PROVISIONS
- 29 This agreement shall take effect when states cumulatively
- 30 possessing a majority of the electoral votes have enacted this

- 1 agreement in substantially the same form and the enactments by
- 2 such states have taken effect in each state.
- 3 Any member state may withdraw from this agreement, except
- 4 that a withdrawal occurring six months or less before the end of
- 5 a President's term shall not become effective until a President
- 6 or Vice President shall have been qualified to serve the next
- 7 term.
- 8 The chief executive of each member state shall promptly
- 9 notify the chief executive of all other states of when this
- 10 agreement has been enacted and has taken effect in that
- 11 official's state, when the state has withdrawn from this
- 12 agreement and when this agreement takes effect generally.
- 13 This agreement shall terminate if the electoral college is
- 14 abolished.
- 15 If any provision of this agreement is held invalid, the
- 16 remaining provisions shall not be affected.
- 17 ARTICLE V
- 18 DEFINITIONS
- 19 For purposes of this agreement,
- 20 "Chief election official" shall mean the state official or
- 21 body that is authorized to certify the total number of popular
- 22 votes for each presidential slate;
- 23 "Chief executive" shall mean the Governor of a state of the
- 24 United States or the Mayor of the District of Columbia;
- 25 "Elector slate" shall mean a slate of candidates who have
- 26 been nominated in a state for the position of presidential
- 27 elector in association with a presidential slate;
- 28 "Presidential elector" shall mean an elector for President
- 29 and Vice President of the United States;
- 30 "Presidential elector certifying official" shall mean the

- 1 state official or body that is authorized to certify the
- 2 appointment of the state's presidential electors;
- 3 "Presidential slate" shall mean a slate of two persons, the
- 4 first of whom has been nominated as a candidate for President of
- 5 the United States and the second of whom has been nominated as a
- 6 candidate for Vice President of the United States, or any legal
- 7 successors to such person, regardless of whether both names
- 8 appear on the ballot presented to the voter in a particular
- 9 state;
- 10 "State" shall mean a state of the United States and the
- 11 District of Columbia; and
- "Statewide popular election" shall mean a general election in
- 13 which votes are cast for presidential slates by individual
- 14 voters and counted on a statewide basis.
- 15 Section 3. Publication in Pennsylvania Bulletin.
- In the event that the Agreement Among the States to Elect the
- 17 President by National Popular Vote takes effect according to
- 18 Article III thereof, the Secretary of the Commonwealth shall
- 19 forward the agreement to the Legislative Reference Bureau for
- 20 publication as a notice in the Pennsylvania Bulletin. The notice
- 21 shall include the date on which the agreement became effective
- 22 between the Commonwealth and any other states.
- 23 Section 4. Effective date.
- 24 This act shall take effect immediately.
