- 11 "RECREATIONAL VEHICLE PARK TRAILER." A VEHICLE THAT IS BUILT
- 12 ON A SINGLE CHASSIS MOUNTED ON WHEELS, HAS A GROSS TRAILER AREA
- 13 NOT EXCEEDING 400 SQUARE FEET IN THE SET-UP MODE AND IS
- 14 CERTIFIED BY THE MANUFACTURER AS COMPLYING WITH ANSI A119.5.

- 21 trailer, eight years in the case of a truck tractor or trailer
- 22 weighing in excess of 10,000 pounds and six years in all other
- 23 cases, in each case dating from the time of perfection as-
- 24 provided for in this subchapter and subject to renewal as-
- 25 provided in subsection (b).

- 3 OR EMERGENCY VEHICLE, 20 YEARS FOR A MOTOR HOME OR RECREATIONAL
- 4 TRAILER, EIGHT YEARS IN THE CASE OF A TRUCK TRACTOR OR TRAILER
- 5 WEIGHING IN EXCESS OF 10,000 POUNDS AND SIX YEARS IN ALL OTHER
