## AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in assault, further providing for the 2 offense of aggravated assault. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 Section 1. Section 2702(d) of Title 18 of the Pennsylvania Consolidated Statutes is amended and subsection (c) is amended 8 by adding a paragraph to read: § 2702. Aggravated assault. 10 (c) Officers, employees, etc., enumerated. -- The officers, 11 12 agents, employees and other persons referred to in subsection 13 (a) shall be as follows: \* \* \* 14 15 (39) A health care practitioner in a health care facility. 16

(d) Definitions. -- As used in this section, the following

- 1 words and phrases shall have the meanings given to them in this
- 2 subsection:
- 3 "Electric or electronic incapacitation device." A portable
- 4 device which is designed or intended by the manufacturer to be
- 5 used, offensively or defensively, to temporarily immobilize or
- 6 incapacitate persons by means of electric pulse or current,
- 7 including devices operated by means of carbon dioxide
- 8 propellant. The term does not include cattle prods, electric
- 9 fences or other electric devices when used in agricultural,
- 10 animal husbandry or food production activities.
- "Emergency medical services personnel." The term includes,
- 12 but is not limited to, doctors, residents, interns, registered
- 13 nurses, licensed practical nurses, nurse aides, ambulance
- 14 attendants and operators, paramedics, emergency medical
- 15 technicians and members of a hospital security force while
- 16 working within the scope of their employment.
- 17 <u>"Health care facility." Any of the following:</u>
- 18 <u>(1) A physician's office.</u>
- 19 (2) A general, tuberculosis, mental, chronic disease or
- 20 other type of hospital.
- 21 (3) An ambulatory clinic or center.
- 22 (4) A health maintenance organization, institution and
- 23 <u>corporation medical department and center.</u>
- 24 (5) A student health center.
- 25 (6) A physical rehabilitation facility.
- 26 (7) A skilled or intermediate care nursing facility.
- 27 (8) A radiology laboratory.
- 28 (9) A renal dialysis center.
- 29 <u>(10) A diagnostic center.</u>
- 30 (11) A home health care agency.

- 1 (12) A clinical laboratory.
- 2 (13) A program affiliated with a medical care facility
- 3 which renders treatment or care for drug or alcohol abuse or
- 4 <u>dependence</u>.
- 5 (14) A setting where medical care and services are
- 6 <u>rendered.</u>
- 7 <u>"Health care practitioner." An individual who is authorized</u>
- 8 to practice some component of the healing arts by a license,
- 9 permit, certificate or registration issued by a Commonwealth
- 10 <u>licensing agency or board.</u>
- 11 Section 2. This act shall take effect in 60 days.
