1 2 3	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in assault, further providing for the offense of aggravated assault.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 2702(d) of Title 18 of the Pennsylvania
7	Consolidated Statutes is amended and subsection (c) is amended
8	by adding a paragraph to read:
9	§ 2702. Aggravated assault.

11	(c) Officers, employees, etc., enumeratedThe officers,
12	agents, employees and other persons referred to in subsection
13	(a) shall be as follows:

15	(39) A health care practitioner in a health care <

(d) Definitions.--As used in this section, the following
words and phrases shall have the meanings given to them in this
subsection:

"Electric or electronic incapacitation device." A portable 4 device which is designed or intended by the manufacturer to be 5 used, offensively or defensively, to temporarily immobilize or 6 7 incapacitate persons by means of electric pulse or current, 8 including devices operated by means of carbon dioxide 9 propellant. The term does not include cattle prods, electric fences or other electric devices when used in agricultural, 10 11 animal husbandry or food production activities.

12 "Emergency medical services personnel." The term includes, 13 but is not limited to, doctors, residents, interns, registered 14 nurses, licensed practical nurses, nurse aides, ambulance 15 attendants and operators, paramedics, emergency medical 16 technicians and members of a hospital security force while 17 working within the scope of their employment.

18 "Health care facility." Any of the following: <---19 (1) A physician's office. 20 (2) A general, tuberculosis, mental, chronic diseas other type of hospital. 21 22 (3) An ambulatory clinic or center. 23 (4) A health maintenance organization, institution 24 corporation medical department and center. 25 (5) A student health center. 26 (6) A physical rehabilitation facility. (7) <u>A skilled or intermediate care nursing facility.</u> 27

28 <u>(8) A radiology laboratory.</u>

8	"Health care practitioner." An individual who is authorized
9	to practice some component of the healing arts by a license,
10	permit, certificate or registration issued by a Commonwealth
11	licensing agency or board.

13	ACT OF JULY 19, 1979 (P.L.130, NO.48), KNOWN AS THE HEALTH CARE
14	FACILITIES ACT.
15	Section 2. This act shall take effect in 60 days.
