## AN ACT

- Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, providing for the installation of United States Veterans Affairs grave markers and medallions in cemeteries; imposing powers and duties upon the Department of Military and Veterans Affairs and the State Real Estate Commission; and imposing sanctions. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. Title 51 of the Pennsylvania Consolidated 10 Statutes is amended by adding a chapter to read: 11 CHAPTER 98 12 UNITED STATES VETERANS AFFAIRS GRAVE MARKERS 13 Sec.
- 14 9801. Definitions.
- 15 9802. Federal veterans markers and cemeteries.
- 9803. Fee restrictions for VA grave marker installation. 16
- 17 9804. Complaints.
- 18 <u>9805</u>. <u>Sanctions</u>.

- 1 § 9801. Definitions.
- 2 The following words and phrases when used in this chapter
- 3 shall have the meanings given to them in this section unless the
- 4 <u>context clearly indicates otherwise:</u>
- 5 <u>"Cemetery." A place for the disposal or burial of deceased</u>
- 6 <u>human beings, by cremation or in a grave, mausoleum, vault,</u>
- 7 columbarium or other receptacle. The term does not include a
- 8 private family cemetery.
- 9 "Commission." The State Real Estate Commission.
- 10 "VA marker." A grave marker offered by the United States
- 11 Department of Veterans Affairs free of charge for placement on
- 12 the graves of eligible deceased veterans to signify the
- 13 <u>decedent's status as a veteran. The term includes the VA upright</u>
- 14 <u>headstone in marble or granite, the VA flat marker in bronze,</u>
- 15 marble or granite and the VA medallion.
- 16 § 9802. Federal veterans markers and cemeteries.
- 17 (a) General authorization. -- The installment of a VA marker
- 18 on the grave of a deceased veteran may not be prohibited by any
- 19 cemetery.
- 20 (b) Specific requirements.--
- 21 (1) In cemeteries where the grave of a deceased veteran
- is marked by a headstone, whether upright or flat, a
- 23 <u>secondary VA flat marker may not be prohibited.</u>
- 24 (2) In cemeteries where an upright headstone is allowed
- 25 <u>to mark a grave, the VA upright headstone may not be</u>
- 26 prohibited.
- 27 <u>(3) In cemeteries where the grave of a deceased veteran</u>
- is marked with a headstone, whether upright or flat, the next
- of kin of the deceased veteran shall be permitted to replace
- 30 the existing headstone with a VA marker.

- 1 (4) In cemeteries where the grave of a deceased veteran
- is marked with a headstone, whether upright or flat, the
- 3 installment of a VA medallion onto the headstone may not be
- 4 <u>prohibited</u>.
- 5 (c) Construction of chapter. -- This chapter shall not be
- 6 construed to require a cemetery to change its existing rules
- 7 requiring uniform upright headstones and markers or uniform flat
- 8 <u>headstones and markers.</u>
- 9 (d) Application. -- This chapter is only applicable to bona
- 10 fide requests by an eliqible applicant for a VA marker.
- 11 § 9803. Fee restrictions for VA grave marker installation.
- 12 <u>(a) Fees.--The following fee restrictions shall apply to the</u>
- 13 <u>installation and care of any VA grave marker:</u>
- 14 (1) If concrete is used as a base for a VA marker, the
- installation fee shall not exceed \$250.
- 16 (2) If granite is used as a base for a VA marker, the
- installation fee shall not exceed \$400.
- 18 (3) If a VA upright headstone is installed, the
- installation fee shall not exceed \$300.
- 20 (4) If a VA medallion is installed on a headstone, the
- installation fee shall not exceed \$75.
- 22 (b) Scope. -- All fees in this section shall be inclusive of
- 23 material, installation and perpetual care costs related to the
- 24 VA marker.
- 25 <u>(c) Expiration.--This section shall expire June 30, 2019.</u>
- 26 § 9804. Complaints.
- 27 <u>A family or custodian of a deceased veteran with a valid and</u>
- 28 reasonable grievance regarding the burial arrangements or
- 29 placement of a VA marker that cannot resolve the grievance with
- 30 the cemetery may contact the Adjutant General. The Adjutant

- 1 General shall notify the commission for the purpose of
- 2 investigating the grievance under section 9805 (relating to
- 3 sanctions).
- 4 § 9805. Sanctions.
- 5 The commission may investigate a cemetery engaged in a
- 6 <u>business relating to cemetery lots, plots or mausoleum spaces,</u>
- 7 openings or foundations. If the commission determines that the
- 8 <u>cemetery has violated this chapter, the commission may impose a</u>
- 9 sanction on the cemetery under section 604 of the act of
- 10 February 19, 1980 (P.L.15, No.9), known as the Real Estate
- 11 Licensing and Registration Act.
- 12 Section 2. This act shall take effect in 60 days.
