1 2 3 4 5 6 7 8 9	Amending the act of December 19, 1988 (P.L.1262, No.156), entitled "An act providing for the licensing of eligible organizations to conduct games of chance, for the licensing of persons to distribute games of chance, for the registration of manufacturers of games of chance, and for suspensions and revocations of licenses and permits; requiring records; providing for local referendum by electorate; and prescribing penalties," providing for social card games and tournaments.
10	The General Assembly of the Commonwealth of Pennsylvania
11	hereby enacts as follows:
12	Section 1. The act of December 19, 1988 (P.L.1262, No.156),
13	known as the Local Option Small Games of Chance Act, is amended
14	by adding a chapter to read:
15	CHAPTER 8
16	SOCIAL CARD GAMES AND TOURNAMENTS
17	Section 801. Definitions.
18	The following words and phrases when used in this chapter
19	shall have the meanings given to them in this section unless the
20	<pre>context clearly indicates otherwise:</pre>
21	"Nonbanking card game " A card game where players play

- 1 against one another rather than against the house. Nonbanking
- 2 card games may include any of the following:
- 3 (1) Poker games.
- 4 <u>(2) Hearts.</u>
- 5 (3) Rummy.
- 6 (4) Pinochle.
- 7 (5) Bid Whist.
- 8 "Nonbanking card game tournament" or "tournament." A series
- 9 of card games held by a licensed eligible organization during a
- 10 consecutive period of time of not more than 24 hours and not
- 11 <u>held as part of any other games of chance.</u>
- 12 "Pyramid" or "build-up." A card game in which a prize must
- 13 <u>be returned in order to play another game or to be eliqible for</u>
- 14 <u>another bigger prize</u>, or a game in which the prize must be
- 15 <u>forfeited if a later game is lost.</u>
- 16 "Social card game" or "card game." A nonbanking card game
- 17 that is played by members at the licensed premises of an
- 18 <u>eliqible organization</u>.
- 19 Section 802. Authorization to conduct social card games.
- 20 <u>(a) General rule.--Notwithstanding any provision of 18</u>
- 21 Pa.C.S. (relating to crimes and offenses) or of this act or any
- 22 other law or regulation to the contrary, social card games may
- 23 be played at the licensed premises of an eligible organization
- 24 in accordance with the requirements of this chapter.
- 25 (b) Conditions.--
- 26 (1) Card games may only be played by and between members
- 27 <u>of the eliqible organization.</u>
- 28 (2) No eligible organization or other person may have an
- 29 interest, financial or otherwise, in the outcome of a card
- 30 <u>game.</u>

1	(3) Only nonbanking card games may be played with
2	members playing against each other.
3	(4) Wagering shall be entirely at the discretion of each
4	player.
5	(5) The maximum prize or payout for a card game shall be
6	limited to \$100.
7	(6) No eligible organization may charge a fee for play.
8	(7) Not more than 10 members may play at a table in a
9	card game.
10	(8) Card games may only be played in a room set aside
11	for those activities at the licensed premises of the eligible
12	organization.
13	(9) Not more than five gaming tables may be made
14	available for the play of card games by the eligible
15	organization.
16	(10) No card games may be played between the hours of 1
17	a.m. and 1 p.m.
18	(11) No eligible organization or other person may
19	collect, obtain or charge a percentage of or shall collect or
20	obtain a portion of a wager or winnings of a player in a card
21	game, except a player may collect the player's own winnings.
22	(12) No eligible organization or other person may
23	collect or obtain any money from, or charge or impose a fee
24	upon, a person that either enables the person to play or
25	results in or from the person playing a card game. Nothing in
26	this paragraph shall be construed to preclude the collection
27	of a membership fee by the eligible organization that is
28	unrelated to participation in the play of a card game
29	authorized under this chapter.
3.0	(13) An eligible organization that allows the use of its

1	premises for the play of card games by its members in
2	accordance with this chapter shall submit a schedule of the
3	proposed dates of the card games and any card game
4	tournaments to the licensing authority.
5	(c) Required postings An eligible organization that
6	permits the play of card games at its licensed premises shall
7	prominently post the following in close proximity of card game
8	tables in the room designated to play card games:
9	(1) The wagering limits for each type of card game.
_0	(2) The rules of play.
1	(3) Information on where a person can obtain help for
_2	problem gambling, including the telephone number for the
.3	Pennsylvania Compulsive Gambling Hotline.
4	(d) Prohibitions
.5	(1) It shall be unlawful for an eligible organization
. 6	to:
_7	(i) Obtain or collect any money or thing of value
8_8	from the conduct of card games at its licensed premises.
_9	(ii) Knowingly permit a card game to be played in
20	violation of this chapter.
21	(iii) Fail to comply with the posting requirement in
22	accordance with subsection (c).
23	(iv) Engage in any act, practice or course of
24	conduct that would constitute fraud or deceit upon a
25	player in a card game.
26	(v) Allow a person under 21 years of age to play a
27	card game at the eligible organization's licensed
28	premises.
29	(vi) Knowingly allow a person to employ or attempt
30	to employ a device, scheme or artifice to cheat or

- 2 (vii) Advertise a card game in violation of section
- 3 704.
- 4 (2) A licensed organization that violates paragraph (1)
- 5 <u>shall be subject to the penalties imposed under section</u>
- 6 <u>702 (d)</u>.
- 7 (e) Applicability. -- The requirements of sections 502 and 503
- 8 shall not apply to social card games authorized under this
- 9 chapter.
- 10 Section 803. Authorization to conduct tournaments.
- 11 (a) General rule. -- Notwithstanding any other provision of
- 12 <u>law or regulation to the contrary, an eligible organization may</u>
- 13 <u>conduct nonbanking card game tournaments. A tournament conducted</u>
- 14 by an eligible organization shall comply with all of the
- 15 following:
- (1) Only nonbanking card games shall be played in the
- 17 tournament.
- 18 (2) Each card game shall be conducted in a fair and
- 19 <u>honest manner and shall not be operated on a build-up or</u>
- 20 <u>pyramid basis.</u>
- 21 (3) Each player in the tournament shall be given the
- 22 <u>same chance of winning the tournament. Second-chance entries</u>
- or multiple entries shall be prohibited.
- 24 (4) The eligible organization shall conduct the
- 25 tournament and shall not contract with or permit another
- 26 <u>person to conduct the tournament or a card game during the</u>
- 27 <u>tournament</u>.
- 28 (5) Only the eligible organization may receive or have a
- 29 fixed or contingent right to receive, directly or indirectly,
- any profit, remuneration or compensation from or related to a

1	card game in the tournament, except an amount that a person
2	may win as a player on the same basis as the other players.
3	(6) No eligible organization may hold more than five
4	tournaments annually.
5	(7) The tournament may not be conducted within seven
6	calendar days of another tournament conducted by the eligible
7	organization.
8	(8) The eligible organization may hold only one
9	tournament during a period of 24 consecutive hours, starting
L 0	from the time the tournament begins.
1	(9) At the conclusion of the tournament, the eligible
_2	organization shall announce the name of the winning player
13	and the amount of winnings.
4	(10) The eligible organization shall limit the number of
15	tables used in the tournament to not more than five with not
. 6	more than 10 players at each table.
_7	(11) The tournament shall only be held in a room at the
8	licensed premises designated by the eligible organization for
_9	the conduct of card games.
20	(12) Players in the tournament shall be limited to the
21	members of the eligible organization.
22	(13) Players shall be at least 21 years of age.
23	(14) The tournament may not provide a direct financial
24	benefit to the eligible organization or other person, except
25	winning players in the tournament.
26	(15) The value of all prizes awarded for the tournament,
27	except for a Texas Hold'em tournament, may not exceed \$200.
28	(16) If the tournament involves Texas Hold'em, all of
29	the following shall apply:
30	(i) The payment of an entry fee or other

- 1 <u>consideration for participating is prohibited.</u>
- 2 (ii) The value of all prizes awarded to an
- 3 individual winner of the tournament or contest at a
- 4 <u>single table may not exceed \$200 each day.</u>
- 5 (17) The eligible organization shall ensure that
- 6 <u>reasonable accommodations are made for players with</u>
- 7 <u>disabilities.</u>
- 8 (b) Required postings. -- Notwithstanding subsection (a), the
- 9 <u>eligible organization shall prominently post the tournament</u>
- 10 rules on a sign in the tournament playing room at least 24 hours
- 11 before the tournament begins. The sign shall be at least 30
- 12 <u>inches by 30 inches, and the rules shall be easily readable. The</u>
- 13 <u>sign shall include all of the following:</u>
- 14 (1) In permanent letters three inches high, the words
- 15 "Tournament Rules."
- 16 (2) Card game or games to be played in the tournament
- and the rules of each card game.
- 18 (3) The prize for each card game and tournament.
- 19 (4) How winners will be determined.
- 20 <u>(5) Any other tournament rules.</u>
- 21 (c) Prizes.--Cash or merchandise prizes may be awarded for a
- 22 tournament subject to the following:
- 23 (1) The eligible organization shall distribute the
- 24 prizes awarded on the day the prizes are won.
- 25 (2) Donated or merchandise prizes shall not be
- 26 <u>repurchased by the eligible organization.</u>
- 27 (3) Only prizes that can be won shall be displayed in
- the room where the tournament is held.
- 29 Section 2. This act shall take effect immediately.
