## AN ACT

Amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873, 1 No.1), entitled "An act providing for taxation by school districts, for the State funds formula, for tax relief in first class cities, for school district choice and voter participation, for other school district options and for a 5 task force on school cost reduction; making an appropriation; 6 prohibiting prior authorized taxation; providing for 7 installment payment of taxes; restricting the power of certain school districts to levy, assess and collect taxes; 9 and making related repeals," in senior citizens property tax and rent rebate assistance, further providing for property 10 11 tax and rent rebate. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1.
