- 11 of the Budget, the Secretary of Revenue or the Pennsylvania
- 12 Gaming Control Board to transfer any money within or between the
- 13 appropriations in Parts III, V and VII.
- 14 Section 902. Effective date.
- This act shall take effect July 1, 2025, or immediately,
- 16 whichever is later.
