AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, further providing for physical education; and, in charter 5 6 schools, further providing for provisions applicable to 7 charter schools and cyber charter schools. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 1512.1 of the act of March 10, 1949 12 (P.L.30, No.14), known as the Public School Code of 1949, added July 11, 2006 (P.L.1092, No.114), is amended to read: 13 14 Section 1512.1. Physical Education .-- (a) The board of 15 school directors in every school district shall establish a 16 curriculum aligned with Pennsylvania academic standards on 17 health, safety and physical education that pursuant to 22 Pa.

18 Code § 4.27 (relating to physical education and athletics),

19 requires pupils enrolled in the district to participate in

20 physical education.
