AN ACT

- 1 Providing for temporary emergency budget funds.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Temporary
- 6 Emergency Budget Fund Act.
- 7 Section 2. Temporary Emergency Budget Fund.
- 8 (a) Establishment. -- The Temporary Emergency Budget Fund is
- 9 established as a separate fund in the State Treasury. The money
- 10 in the fund is appropriated on a continuing basis to carry out
- 11 the provisions of this section.
- 12 (b) Transfers.--If legislation providing for appropriations
- 13 from the General Fund for the ordinary programs of the
- 14 Commonwealth is not enacted by July 1, 2015, the State Treasurer
- 15 shall periodically transfer unappropriated, unrestricted General
- 16 Fund money, to the extent that the funds are available, to the
- 17 Temporary Emergency Budget Fund. The transfers shall be at the

- 1 times as necessary to meet the required payments of the
- 2 Commonwealth, but shall not exceed the total amount appropriated
- 3 under the General Appropriations Act of the previous fiscal
- 4 year.
- 5 (c) Certification of transfers.--If the Governor fails to
- 6 certify revenue estimates under section 618 of the act of April
- 7 9, 1929 (P.L.177, No.175), known as The Administrative Code of
- 8 1929, for the current fiscal year the Secretary of Revenue shall
- 9 certify to the State Treasurer each time a transfer is needed
- 10 under subsection (a) that there is adequate unappropriated,
- 11 unrestricted General Fund money to make the transfer.
- 12 Section 3. Payments from the fund.
- 13 The Secretary of the Budget shall draw a warrant on the State
- 14 Treasurer for amounts to be paid from the fund, which shall not
- 15 exceed the total amount as provided in the General
- 16 Appropriations Act of the previous fiscal year.
- 17 Section 4. Limitation.
- 18 Transfers and payments under this act shall only be in effect
- 19 during the time in which no General Appropriations Act has been
- 20 enacted.
- 21 Section 5. Applicability.
- 22 This act shall apply to fiscal years beginning after June 30,
- 23 2015.
- 24 Section 6. Effective date.
- 25 This act shall take effect immediately.
